### 1. DESCRIPTION OF THE PLAN

The following description of the Cummins Behavioral Health Systems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a prototype defined contribution plan and trust custodial account adopted by Cummins Behavioral Health Systems, Inc. (the Plan Sponsor). The Plan is a safe harbor 401(k) plan, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees who meet certain eligibility service requirements will be enrolled in the Plan.

#### Contributions and Participant Accounts

The Plan Sponsor makes a safe-harbor match of 100% of participant contributions into the Plan up to 6% of a participant's eligible compensation. Each year the employer may also make a discretionary profit sharing contribution to the plan. Participants are generally eligible to receive employer safe harbor contributions if they are at least 21 years of age and have obtained one year of service. During plan years 2024 and 2023, there were no profit sharing contribution made into the plan.

Upon entry into the Plan or on any pay period, participants may also defer a dollar amount or a percentage of their compensation, to a maximum as determined and adjusted by the IRS. In addition, participants who have or will have attained age 50 by the end of the calendar year are allowed to defer an additional amount as "catch-up contributions" to a maximum as determined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Individual accounts are maintained for each plan participant. The participants are able to direct their balance to be invested into various investment options offered by the Plan.

#### Vesting and Forfeiture

The Plan provides that employee salary deferrals, rollover contributions, and employer safe harbor contributions are always 100% vested in the Plan. Amounts relating to discretionary profit sharing contributions become 100% vested once an eligible employee attains three years of service, upon attainment of normal retirement age, upon retirement due to disability, upon death or upon termination of the Plan. Upon termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce the Plan Sponsor's contributions or administrative expenses of the Plan. Forfeitures totaled approximately \$3,700 and \$18,500 for the Plan years ended December 31, 2024 and 2023, respectively. Forfeiture amounts used to reduce employer contributions in 2024 were approximately \$5,500. If the participant is reemployed before incurring five consecutive one-year breaks in service, the employee will be entitled to have his prior account balance restored.

#### Participant Loans

The Plan does not permit participant loans.

#### Payment of Benefits

On termination of employment, in general, a participant may elect to leave the vested balance invested in the Plan or receive either a lump-sum amount equal to the value of the account or annual installments. Participants may also elect to receive distributions prior to termination granted they have attained age 59 ½. Distributions can only be made from accounts which are 100% vested.

#### Plan Termination

Although the Company has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by the Plan Sponsor's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the Plan text and regulations.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Valuation of Investments

The Plan values its investments at fair market value for financial reporting purposes. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net assets value of shares held by the Plan at year-end. Changes in appreciation or depreciation of the fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur. Money market mutual funds are valued at their daily net asset value calculated using the amortized cost of the securities held in the fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

In general, on termination of service, a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover, an annuity or leave the account in the Plan, subject to a certain limitations and conditions as defined by the Plan. Withdrawals other than for termination are permitted under provisions provided by the Plan.

#### Expenses of the Plan

The Plan Sponsor pays the majority of the expenses of the Plan, including administrative and accounting fees. Participants pay expenses associated with equity trades and the administrative fees related to money managers retained at the option of the participant.

#### Subsequent Events

The Plan evaluates events or transactions occurring subsequent to the statement of net asset available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued which is October 10, 2025.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and investment related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There were no level 3 assets as of December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Money market mutual funds*: Generally transact subscription and redemption activity at a \$1 stable NAV however, on a daily basis the funds are valued at their daily NAV calculated using the amortized cost of the securities held in the fund.
- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 5. INCOME TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by Ascensus LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **6. PARTIES-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others.

Certain investments are shares of mutual funds managed by American Funds Investments. American Funds Investments is a subsidiary of Capital Bank and Trust Company, the custodian of the plan assets and, therefore, any transactions with American Funds Investments or Capital Bank and Trust Company qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

During 2024, the Plan changed third-party service providers to Capital Group Retirement Plan Services. Prior to the change, Ascensus LLC served as the third-party service provider of the Plan. Administrative expenses amounted to approximately \$19,600 for 2024 and are included in administrative and other fees in the statement of changes in net assets available for benefits. Blue & Co., LLC is the independent auditor for the Plan and receives payment for its services. Certain expenses of the Plan are paid by the Plan Sponsor. The Plan Sponsor provides certain administrative services at no cost to the Plan including accounting fees.

#### **7. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
