#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Masonicare Corporation 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## 1. Description of the Plan

The following description of the Masonicare Corporation 401(k) Retirement Savings Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

### ***General***

The Plan is a defined contribution plan covering all employees of Masonicare Corporation and its affiliates and locations (collectively, the “Company” or the “Employer”), who have reached the age of 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

### ***Contributions***

Each year, participants may contribute up to 60% of eligible compensation as defined in the Plan. Employees are automatically enrolled at a 6% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The pre-tax default deferral rate for participants who are automatically enrolled will increase by 1% each year up to a maximum deferral rate of 12%, unless otherwise elected by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company makes matching contributions to the account of each eligible employee equal to 25% of the first 4% of eligible compensation that a participant contributes to the Plan. The Company shall also make a non-elective employer contribution in the amount of 3% of eligible compensation, who have met applicable service requirements for participation, regardless of whether such employee has elected to make salary reduction contributions under the Plan. The non-elective contribution is intended to meet Safe Harbor requirements. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions, (b) Plan earnings, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

### ***Retirement, Death and Disability***

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

### 1. Description of the Plan (*continued*)

#### ***Vesting***

Participants are immediately vested in their contributions, safe harbor non-elective contributions and rollovers plus actual earnings or losses thereon. Vesting in the remainder of their accounts, plus earnings or losses thereon, is based on years of continuous service. A participant is 100% vested after three years of credited service.

#### ***Payment of Benefits***

Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

#### ***Forfeited Accounts***

Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. The forfeited non-vested accounts total \$301,742 and \$231,505 as of December 31, 2024 and 2023, respectively. During 2024 and 2023, forfeitures of \$43,939 and \$44,722 were used to offset the employer contributions, respectively.

#### ***Administrative and Investment Management Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Investment Valuation and Income Recognition***

The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions as further discussed in Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

### 3. Investments Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), a qualified institution.

### 4. Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Self-Directed Brokerage Accounts:* Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

*Common Collective Trusts:* The fair values of participant units held in a collective trust are based on the net assets values per unit as reported by the fund managers. The collective trust provides for daily redemptions by the Plan at reported net asset values per share with no advance notice requirement.

\* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

### 5. Traditional Guaranteed Investment Contract

The Plan holds a fully benefit-responsive traditional investment contract with Empower Annuity Insurance Company (“Empower”) that is reported at contract value. Amounts deposited under this traditional group annuity contract are held within the Guaranteed Long Term Account (the “GLTA”). As described in Note 2, because the GLTA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company (“EAIC”), represents the accumulation of contributions, plus interest, less funds used to pay benefits and expenses. The contract value as of December 31, 2024 and 2023 was \$10,141,691 and \$10,713,265, respectively.

Participants could withdraw their balances at contract value without restriction or charge on account of any of the following events: death, disability, retirement, terminations of employment, hardship, loans, attainment of age 65, or the purchase of an annuity from EAIC. Benefit responsive withdrawals from this contract during any twelve-month period that are made on account of employer-initiated events and in aggregate in excess of 10% of the contract balance at the beginning of such twelve-month period shall be subject to a withdrawal adjustment. EAIC will pay participant-elected withdrawals of all or a portion of the participant account that do not constitute benefit responsive withdrawals, to the extent permitted by the Plan and authorized by the contract holder, but such payments will be subject to a withdrawal adjustment with respect to the requested withdrawal amount.

The contract contained a minimum guaranteed interest rate, which will not be less than 1.5%. At the beginning of each calendar year, Empower determines the declared interest rate, which will be credited to all monies invested in the guaranteed separate account during such calendar year. In no event will the declared rate of interest be less than the contract’s minimum guaranteed interest rates.

### 5. Traditional Guaranteed Investment Contract (*continued*)

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options; (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

### 6. Related Party Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds investments from Fidelity. Fidelity is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to them qualify as party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 7. Plan Termination

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 8. Tax Status

The Company has adopted an approved volume submitter plan which received an IRS advisory opinion letter dated June 30, 2020 which indicated the form of the Plan satisfied the qualification requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and tax-exempt as of the financial statement date.

### 9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
