## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SDAC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1. Description of the Plan**

The following brief description of SDAC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all full-time employees of South Dade Air Conditioning & Refrigeration, Inc. (the "Sponsor"), SDAC Facility Services, LLC, SDAC Rail Services, LLC, SDAC OZ Holdings, Timberline Payroll Services, LLC, CADS, LLC and SDAC USVI, LLC, except residents of Puerto Rico and nonresident aliens with no earned income from a U.S. source, certain union employees, and leased employees. Prior to January 1, 2023, to be eligible to participate in the Plan, an employee must have reached age 21 and completed six months of service. Effective January 1, 2023, to be eligible to participate in the Plan, an employee must have reached age 18 with no service requirements. Participants may enter the Plan upon employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan allows for participants to make pretax or after-tax contributions to the Plan subject to regulatory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover).

The Plan provides a safe harbor contribution equal to 3 percent of eligible compensation.

The Sponsor may also contribute to the Plan supplemental discretionary contributions in such amounts as the Sponsor may determine. The Sponsor did not make any discretionary contributions for the 2024 plan year.

Eligible participants who are performing services under a public contract subject to provisions or regulations under the Davis-Bacon Act or any state or municipal "prevailing wage" law or ordinance are eligible to receive the prevailing wage as a non-elective contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, and allocations of (a) the Plan's safe harbor and discretionary contributions and (b) Plan earnings and losses and is charged with an allocation of administrative expenses, where applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and prevailing wage contributions plus actual earnings and losses thereon. Participants are also immediately vested in any safe harbor matching contributions plus actual earnings and losses thereon, made on behalf of the Sponsor. Participants' interests in any Sponsor contributions other than safe harbor matching contributions, and allocated earnings or losses thereon, vest according to the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years	100%

Participants must complete 1,000 hours of service to complete one year of vesting. Regardless of the years of service, the participant's employer contribution account becomes fully vested in the event of death, disability or the attainment of normal retirement age (age 65).

Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in participant's account and bear interest at 2 percent over the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid through payroll deductions.

Payment of Benefits

Benefits are generally payable upon termination, retirement, death or disability. Benefits may be paid by lump-sum payment or in equal installments, as defined by the Plan. Hardship distributions are also available from participants' elective deferral accounts, excluding earnings on such deferrals, subject to regulatory requirements.

Forfeited Accounts

Forfeitures, which generally result from participants withdrawing from the Plan prior to fully vesting in Sponsor contributions plus earnings or losses thereon, may be used to pay administrative expenses or reduce future employer contributions. As of December 31, 2024 and 2023, there were \$1,007 and \$196, respectively, of unallocated forfeitures.

**Note 2. Summary of Accounting Policies**

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation of investments in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements.

**Note 3. Information Certified and Provided by Great-West Trust Company, LLC**

All information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, net appreciation of investments, and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC ("Empower").

### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board ("FASB") ASC Topic 820, *Fair Value Measurement* ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standard Codification Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Common Collective Trust:* Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. ASC Topic 820 allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. The Plan administrator has determined the common collective trust held by the Plan meets the requirements for the NAV practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Empower. Empower is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for such services totaled \$41,441 for the year ended December 31, 2024. The remaining administrative expenses of \$10,689 included in the statement of changes in net assets available for benefits relate to charges incurred in connection with compliance and consulting services provided to the Plan. These transactions qualify as exempt party-in-interest transactions.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants would become fully vested and the assets of the Plan, after payment of expenses, would be distributed to the participants.

**Note 7. Income Tax Status**

The Sponsor has adopted a pre-approved plan whose sponsor obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In 2021, the Plan sponsor became aware of a potential operational matter with respect to the Plan that, if not corrected, could be treated by the IRS as a qualification failure and may result in additional contributions from the Plan sponsor to the Plan. The Plan sponsor is in the process of evaluating this matter, with the assistance of legal counsel, and will work directly with the Internal Revenue Service and other regulatory bodies to resolve the matter to the extent necessary. Management does not believe these matters will impact the Plan's income tax status going forward.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
