NOTE 1 - DESCRIPTION OF PLAN

The following description of the Tosoh America, Inc. (Company) Savings and Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan is a multi-employer defined contribution plan covering substantially all employees of the Company and its wholly owned subsidiaries: Tosoh SMD, Inc.; Tosoh USA, Inc.; Tosoh Bioscience, Inc.; Tosoh Quartz, Inc.; Tosoh Bioscience LLC; Tosoh America, Inc.; Tosoh Specialty Chemicals USA, Inc.; and Organo USA, Inc. (collectively, the Sponsors). Employees are eligible to participate in the Plan after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Sponsors of the Plan as of December 31, 2024, and their effective dates of sponsorship, are as follows:

Tosoh SMD, Inc.	July 15, 1998
Tosoh USA, Inc.	January 1, 1990
Tosoh Bioscience, Inc.	January 1, 1990
Tosoh America, Inc.	July 1, 1991
Tosoh Quartz, Inc.	January 1, 1994

Tosoh Specialty Chemicals USA, Inc.	February 1, 2008
Organo USA, Inc.	January 1, 2022

The Company's board of directors has designated seven members as the Plan's Policy Committee. The Plan's Policy Committee designated six employees of the Sponsors to form the Plan's Administrative Committee.

Contributions - Each year, participants may voluntarily contribute a portion of their annual compensation between 1% and 100%, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limits. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions. The Plan is a safe harbor plan and matches 100% of the first 4% of participant deferrals per payroll period.

The Plan allows for automatic enrollment at a deferral rate of 4% of the employee's eligible compensation upon meeting the participation eligibility requirements. Eligible employees are automatically enrolled unless the employee elects to not participate. If participants do not make an investment selection at enrollment, or elect to not participate, contributions are directed to a Target Date Fund based on their age and years away from normal retirement age. The deferral rate increases automatically at a rate of 1% annually until the deferral rate reaches 10%.

Each Sponsor may elect to make a discretionary profit-sharing contribution to eligible participants at the Sponsor's location. There were no discretionary profit-sharing contributions in the current year.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution, (b) net investment income (loss) and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The net investment income (loss) is allocated to each participant's account on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Investment Options - Each participant may direct their contributions and any related earnings in any of the investment options available under the Plan. In addition, a participant may elect to invest in a self-directed brokerage account option also available under the Plan. Participants may change their investment elections daily.

Vesting - Participants are immediately vested in all contributions and earnings thereon.

Payment of Benefits - On termination of service, total and permanent disability, retirement or death, or other reasons, a participant will receive a lump sum amount equal to the value of their account.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to 15 years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and must bear interest at a rate commensurate with local prevailing rates, as determined by the Administrative Committee. Principal and interest are paid ratably through biweekly payroll deductions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by Plan management in preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements follows:

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures; actual results might differ from these estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and Plan administrators deem the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Fees not paid by the Company are paid from Plan assets. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through October 15, 2025, the date that the financial statements were issued and determined that there have been no events that have occurred that would require adjustments to the disclosures in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENT

The Financial Accounting Standards Board accounting standard for Fair Value Measurement establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account: The following investment types of the Self-Directed Brokerage Account are valued as follows:

Common Stock - Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual Funds - Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Units in Trust - Valued at daily closing price as reported by the fund. Units in Trust held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily NAV to transact at that price. Units in Trust held by the Plan are deemed to be actively traded.

Common Collective Trust - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value, and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

NOTE 5 - CERTIFICATION (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 6 - TAX STATUS

The Plan adopted a prototype plan sponsored by Charles Schwab Trust Company. The prototype plan received an opinion letter dated September 21, 2020 from the IRS, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Charles Schwab Trust Bank, the trustee of the Plan, and certain administrative functions are performed by officers or employees of the Company at no cost to the Plan; therefore these transactions qualify as party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.
