## NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024

### 1. DESCRIPTION OF PLAN

The following description of the Meritum Energy GP, LLC (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established in July 2019 with an initial effective date of July 28, 2019. Employees of the Company who have completed 60 days of service and are age 21 or older can participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

#### **Employee Contributions**

Pursuant to Section 401(k) of the Internal Revenue Code (the "IRC"), participants may contribute up to the lesser of 100% of their compensation or \$23,000 for 2024. Employees who are age 50 or older may also make catch-up contributions of up to \$7,500 for 2024. All participants' contributions are fully vested at all times.

#### **Employer Contributions**

The Plan is a qualified automatic contribution arrangement ("QACA") safe harbor 401(k) plan. Each year the Company will contribute a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 6% of the compensation.

Each year the Company's Board of Directors may elect to contribute to the Plan a discretionary matching contribution. During 2024, there was no discretionary matching contribution. The discretionary matching contribution is to be allocated regardless of the amount of service completed during the Plan year and will not exceed 4% of participant compensation.

Each year the Company's Board of Directors may elect to contribute to the Plan a discretionary profit-sharing contribution. Participants must be employed on the last day of the year and have completed at least 1,000 hours of service during the Plan year to share in the discretionary profit-sharing contribution. During 2024 there was no profit-sharing contribution.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe harbor matching contribution (b) the discretionary matching contribution (c) the discretionary profit-sharing contribution, and (d) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in accounts attributable to the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon is determined according to the following schedule and is based on years of service. A participant will always be 100% vested upon normal retirement age, death or disability.

## **Payment of Benefits**

Upon termination of service due to death, disability or retirement on or after normal retirement age, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or installments over a period of not more than the participant's assumed life expectancy if the vested account balance exceeds \$5,000. If a participant's vested account balance does not exceed \$5,000, participants will receive a lump-sum distribution. For termination of service for other reasons or before normal retirement age, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as soon as administratively feasible, however, if the vested account balance exceeds \$5,000, participants may elect to postpone distribution until the required beginning date.

## **Notes Receivable from Participants**

Participants may borrow from their accounts a maximum amount equal to the lesser of (a) \$50,000 or (b) 50% of the value of their vested interest in the Plan. Loan transactions are treated as a transfer to (from) an investment fund from (to) the Participant Notes Receivable Fund. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the Plan administrator. The loans are repaid ratably through payroll deductions over a period not to exceed 5 years for general loans. However, if the loan is for the purchase of a principal residence, the plan administrator may permit a longer repayment term. The maximum number of Plan loans a participant may have outstanding at any time is one.

## **Forfeitures**

A forfeiture is the non-vested portion of a terminated participant's account balance. The forfeited amount remains in the Plan and is first used to pay any administrative expenses, and any remaining amounts are used to reduce any subsequent discretionary employer contributions. As of December 31, 2024, and 2023, there was \$8,519 and \$989, respectively, in unallocated forfeitures remaining in the plan to reduce administrative expenses and employer contributions. Also, in 2024, \$929 and \$9,435 in forfeitures were used to reduce administrative expenses and employer contributions respectively.

## **Investment Options**

The assets of the Plan are allocated to the various funds at the direction of the participant.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the Schedule H of the 5500. Under GAAP, the defaulted loan will remain a note receivable from participant until a distributable event occurs. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Administrative Expenses**

The daily operation expenses of maintaining the Plan are paid by the Plan and are reflected in the financial statements as administrative expenses. Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Certain administrative expenses are paid directly by the Company, such as recordkeeping, trustee, legal and accounting fees. Investment related expenses are included in net appreciation of fair value of investments.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

### 3. ASSET INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

At December 31, 2024 and 2023, the Plan's investments were held by Transamerica Retirement Solutions, LLC and John Hancock Life Insurance Company (U.S.A.) (the "Trustees") respectively. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustees as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

During 2024, the Plan's investments (including gains and losses on investments bought, sold, as well as held during the year), appreciated in value by \$866,118.

### 4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are inputs other than quoted prices included with Level 1 that are observable for similar assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair values using Level 1 inputs because they generally provide the most reliable evidence of fair value.

#### Investments measured at net asset value

Pooled Separate Accounts: valued at the net asset value of units of the underlying investments at the insurance company. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant's transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the accounts, no notification is required.

**5. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500**

## **6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Transamerica Retirement Solutions, LLC, the trustee of the Plan. These transactions qualify as exempt party in interest transactions. There were \$68,237 in fees paid directly by the Plan for the year ended December 31, 2024.

## **7. TAX STATUS**

The Plan operates under a Volume Submitter Profit Sharing Plan agreement sponsored by Loren D Stark Company. This Volume Submitter Profit Sharing Plan document has been filed with the appropriate agency and has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the IRC. The plan administration and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified, and the related trust is tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations three years after filing.

## **8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **9. RISK AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

## **10. SUBSEQUENT EVENTS**

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through October 14, 2025, the date of financial statement issuance. No events requiring disclosure were noted.
