NOTE 1 - DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan For Employees of AIDS Center of Queens County (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of AIDS Center of Queens County, Inc. (the "Organization" or "Sponsor"). The Plan is designed to receive both employee contributions and discretionary employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In February 2015, the Organization's Board of Directors passed a resolution to form an affiliation with AIDS Healthcare Foundation (a nonprofit organization) ("AHF"). On that date, the Organization board was dissolved and AHF became the sole voting member of the Organization. AHF is a California nonprofit public benefit corporation, qualifying as a 501(c)(3) organization under the federal tax law, formed for the purpose of providing healthcare and related services to individuals living with HIV and AIDS.

B. Eligibility and Service Rules for Participation

Employees are eligible upon hire to participate in the plan. There is no minimum age or service requirement for salary reduction contributions. However, for the employer based contribution employees, must be at least 21 years of age, complete one year of service(in which the employee worked 1,000 hours) to receive employer-based discretionary contributions under the plan.

C. Contributions

Employee

Each year, participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. Contributions are subject to certain limits.

Employer

Each plan year, the Organization may declare a discretionary contribution that is made for all eligible participants who are actively employed with the Organization on the last day of the plan year and meet certain eligibility requirements. Contributions are allocated to the accounts of eligible participants on the basis of the ratio that each eligible participant's compensation bears to the total compensation of all participants for the plan year. The Organization declared a 3% contribution in 2024 totaling \$183,124. For the year ended December 31, 2024, participant contributions, including rollovers totaled \$150,780 and employer-based contributions totaled \$183,124.

D. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

A participant is 100% vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service and there is no partial vesting. Participants become fully vested upon reaching age 65, death, or total and permanent disability.

F. Forfeitures

At December 31, 2024 and 2023, forfeitures non-vested accounts totaled \$0 and \$3,066, respectively. Forfeitures are used to reduce future employer contributions. During 2024, Employer contributions were not reduced by forfeitures.

G. Participant Loans

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Only one loan may be made in any twelve-consecutive month period. Defaults in loans are treated as a distribution at the time of default against the participant's account.

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from Mutual of America Life Insurance Company. The Participant's account is not reduced by the loan amount but serves as security for the loan. The loan amount is moved into a fixed-income collateral account within the borrower's account. The loan must be repaid directly to Mutual of America Life Insurance Company within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default.

At December 31, 2024, and 2023, total principal balances due amounted to \$17,247 and \$36,580, respectively. The loans are collateralized by the participant accounts. As of December 31, 2024, and 2023, defaulted loans totaled \$0 and \$6,871, respectively. The interest rates on these loans range from the highest rate of 5.85% to the lowest rate of 4.21% with maturities through 2028.

H. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

I. Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and excluded from these financial statements. Fees related to the administration of participants' loans are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

B. Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value, except for the mutual interest accumulation account, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. The mutual funds are open-ended and registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The funds valued at contract value represent contributions made under the contract, plus interest credited, less withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes Plan's gains and losses on investments bought and sold as well as held during the year.

C. Payment of Benefits

Payment of benefits is recorded when paid.

D. Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and recognition in the financial statement through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 – INVESTMENTS INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE

Certain information related to investments disclosed in the accompanying financial statements and ERISA required Schedule H, part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2024, and 2023, and net appreciation in the value of investments, interest on investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, qualified institution.

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information contained in the supplemental schedule was certified as complete and accurate by Mutual, as Plan's custodian and was not subject to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

Mutual of America, the Plan's custodian, certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP guidance on Fair Value Measurements, which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets, which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are observable and are used to the extent that observable inputs do not exist.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual of America Interest Accumulation Account

The Mutual of America Interest Accumulation Account is credited with interest at a rate determined by Mutual of America. Mutual of America reserves the right to change the interest rate applicable to amounts held in the interest accumulation account at its discretion. If funds are transferred to another funding vehicle or investment, they may be subject to market value adjustments. The interest Accumulation account is carried at contract value.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. We evaluated the significance of transfers between levels based on the nature of the financial instrument and the size of the transfer relative to total net assets available for benefits. There were no transfers for the years ended December 31, 2024, and 2023.

Mutual funds carried at fair value as December 31, 2024 and 2023 were classified as Level 1 and amounted to \$3,119,672 and 2,740,892, respectively.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Mutual of America. Mutual of America is the Custodian defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The sponsor paid certain fees relating to administrative expenses outside of the Plan.

Participants who are active employees may borrow from their accounts, and such loans qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Employer who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

Fees incurred by the Plan for the investment management services are reflected as administrative fees in the accompanying financial statements and amounted to approximately \$2,057 for the year ended December 31, 2024.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan has adopted an approved prototype plan document which received Internal Revenue Service ("IRS") approval. The Employer believes that the Plan is designed and operating according to applicable sections of the Internal Revenue code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to multiple risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statement of net assets available for benefits.

The global and domestic economic uncertainty may result in significant volatility in the financial markets. This volatility may affect the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024, are not reflected in these financial statements, and future effects on the Plan's net assets available for benefits cannot be predicted.
