We have performed audits of the accompanying financial statements of Desert AIDS Project 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Desert AIDS Project 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **NOTES TO FINANCIAL STATEMENTS**

#### **DECEMBER 31, 2024 AND 2023**

#### **1. DESCRIPTION OF PLAN**

The following brief description of Desert AIDS Project 401(K) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The plan assets are held by Fidelity Management Trust Company, as trustee of the Plan.

##### General

The Plan is a defined contribution plan and allows eligible employees the opportunity to participate in a salary deferral (“401(K)”) Plan. Eligible employees may participate if they have completed two (2) consecutive months of service and are a minimum of 18 years of age or older. Temporary employees are not immediately eligible. Temporary employees can become eligible if they reach age 21 and complete 1,000 hours of service during a computation period. The plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

##### Contributions

The Plan allows participants to elect to have a portion of their compensation deferred on their behalf in lieu of receiving such amounts as compensation, as defined by the Plan. Participants who have reached age 50 or older are eligible to make catch-up contributions. Participants may elect to make Pre-Tax 401(K) contributions or Roth Contributions to the Plan. For the 2024 calendar year, the maximum amount of compensation deferred may not exceed \$23,000 (\$30,500 for age 50 or older). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, common stocks, bonds, government securities and an insurance investment contract as investment options for participants.

##### Safe Harbor Matching

Desert AIDS Project will make Safe Harbor matching contributions up to 4% and may make discretionary matching contributions up to 7%. Desert AIDS Project approved an employer contribution of 4% for the plan years ending December 31, 2024 and 2023. Effective in March 2021, the employer authorized a discretionary matching contribution of 3%.

##### Participant Accounts

Each participant account is credited with the participant’s contribution and allocations of the Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant’s vested account.

##### Vesting

Participants are immediately vested in their contributions, employer Safe Harbor Matching Contributions, plus actual earnings thereon. Vesting in the discretionary Employer’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Regardless of the vesting schedule, Participants shall become fully vested upon death or total and permanent disability.

**1. DESCRIPTION OF PLAN (Continued)**

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prevailing interest rate at the time of borrowing. Loan payments must be made over a maximum period of five years through payroll deductions.

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Distributions under the Plan may be made in lump-sum amounts. Upon termination of employment, distributions may be made as soon as administratively feasible. Participant consent is required for distributions over \$5,000. Distributions upon the death of a Participant shall be made pursuant to the election of the Participant or Beneficiary. Hardship distributions are permitted from all Participant accounts.

If the Participant withdraws all or a portion of their vested account before age 59 1/2, he or she will be subject to a 10% penalty tax on the amount withdrawn per the Internal Revenue Code and 2 1/2 % penalty on the amount withdrawn per the California Revenue and Taxation Code, and must report the amount withdrawn as income subject to their regular tax rates on their income tax returns.

Benefits are recorded when paid. For the years ended December 31, 2024 and 2023, benefits paid to participants amounted to \$2,722,270 and \$800,008, respectively.

Forfeitures

Forfeitures will occur as of the earlier of the last day of the Plan Year in which the former Participant incurs five (5) consecutive 1-year breaks in service, or the distribution of the entire Vested portion of the Participant's Account. Forfeitures will be used to pay administrative expenses of the Plan and to reduce Employer matching contributions.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Estimates

The preparation of the financial statement in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Basis of Accounting

The Plan maintains its accounts on the accrual basis of accounting.

### Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Shares or registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at the end of the year. Participant loans receivable are valued at cost, which approximates fair value. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### Expenses

Certain employees of the Organization function as trustees, subject to guidelines established by the Plan document. The trustees have been granted discretionary authority to carry out the provisions of the Plan documents. Administration fees, investment advisory and management fees and other professional fees are paid by the Plan.

### Payment of Benefits

Benefits are recorded when paid.

## **3. FAIR VALUE MEASUREMENTS**

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

**3. FAIR VALUE MEASUREMENTS (Continued)**

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence for fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair value of common stocks, corporate bonds, and U.S. government securities are based on closing price reported on the active market where the individual securities are traded.

*Level 2 Fair Value Measurements*

The fair value of mutual funds is generally based on available indirect information, such as quoted prices for similar assets or liabilities in active markets, or quoted prices for identical or similar assets of liabilities in markets that are not active.

**4. UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The December 31, 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023 and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Fidelity Management Trust Company. The information certified includes total investments of \$22,029,947 and \$14,946,078 at December 31, 2024 and 2023, respectively, and related gains of \$1,735,532 and \$1,587,490 respectively for the years ending December 31, 2024 and 2023.

##### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the plan to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

##### **6. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Fidelity Investments Institutional which is the trustee as defined by the Plan as of December 31, 2024 and 2023, respectively, and fees paid by the Plan for investment advisory and management services amounted to \$55,365 and \$28,868, respectively. The plan also maintains a relationship with Global Retirement Partners LLC as investment advisors amounting to \$58,584 and \$34,279 for the years ending December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions. The plan also maintains a relationship with Coachella Valley Accounting and Auditing and paid fees in the amount of \$12,000 for the year ended December 31, 2024.

##### **7. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Organization that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

##### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### **9. SUBSEQUENT EVENTS**

The management of the Plan evaluated all potential subsequent events as of October 12, 2025, when the financial statements were authorized and available to be issued. No subsequent events or transactions were identified after December 31, 2024, or as of October 12, 2025 require disclosure to the financial statements.
