NOTE 1 - PLAN DESCRIPTION

General

The United Union of Roofers, Waterproofers and Allied Workers Local No. 12 Vacation Fund (Plan) was formed on January 1, 2003, under an agreement between the United Union of Roofers, Waterproofers, And Allied Workers Local No. 12 (Union) and the Roofing Contractors Association of Fairfield, Litchfield, and New Haven Counties (Employer). The current collective bargaining agreement provides for employers who have either signed or agreed to a collective bargaining agreement with the Union to contribute to the Plan based on employee hours worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to collect contributions on behalf of participants which are deposited into a participant account and distributed annually in accordance with the Trust agreement.

Benefits

The Plan is a multi-employer plan which provides for accumulating vacation benefits for Union members. The operation and administration of the Plan is the joint responsibility of the Board of Trustees, which is comprised of Union trustees and Employer trustees.

Vesting

All participants are 100% vested upon entering the Plan.

Funding

Employers are required under the current collective bargaining agreement to contribute \$7.00 an hour for each hour worked by a member.

Priorities Upon Termination

If the Plan is terminated, assets will be allocated to provide benefits to Plan members in the order of priority as specified in the Plan, or as otherwise required by law.

Tax Status

The Plan was issued a favorable determination letter, dated November 8, 2006, for continued qualification under section 401(a) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving the determination letter, however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Employer Contributions

The Plan's revenue is derived from third-party employer contributions, as negotiated under a collective bargaining agreement, and interest income. Employer contributions are based on reports of hours worked as submitted by employers at rates contractually agreed upon. Contributions are recognized when earned. The Trustees believe that contributions receivable are fully collectible and therefore, a provision for uncollectible contributions has not been provided.

Income Taxes

The Trustees evaluate all significant tax positions as required by accounting principles generally accepted in the United States of America. As of December 31, 2024, the Trustees do not believe that they have taken any positions that would require the recording of any additional tax liability, nor do they believe that there are any unrealized tax benefits that would either increase or decrease within the next year.

Payment of Benefits

Vacation benefits are collected and retained in participant accounts until December of each year and are paid during the month of December. In the event a participant dies, the balance of a participant account is paid to their designated beneficiary.

Vacation Benefits Payable

The Plan's benefits are recognized when earned. Based on the timing of distributions, the Plan may recognize an amount for benefits earned by the Participants and not yet paid.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued and determined no subsequent events requiring disclosure exist.

NOTE 3 - FIDELITY BOND

The Plan is insured by a fidelity bond against losses through fraud or dishonesty, up to a maximum of \$20,000.

NOTE 4 - RISKS AND UNCERTAINTIES

During the years ended December 31, 2024 and 2023, the Fund received approximately 75% and 70%, respectively, of its contribution income from one employer. As of December 31, 2024 and 2023, approximately 87% and 94%, respectively, of the Fund's contributions receivable were owed by the same employer. Should this employer cease operations, there could be a significant negative impact on the Fund's contribution income. Since the local union has collective bargaining agreements with other employers who make up the Plan's contribution base, the Trustees believe that if this employer were to cease operations, the affected employees and related projects would be assumed by one or more of the other contributing employers to the Plan.

NOTE 5 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, and certain others. The Plan has arrangements with service providers providing legal, and audit services. These transactions are exempt party-in-interest transactions under ERISA. The Plan has an administrator's service agreement with Zenith American Solutions, Inc. Zenith American Solutions, Inc. is responsible for the daily administration of the Plan, processing of all benefit payments, and participant data.
