Opinion

We have audited the financial statements of The Baton Rouge Clinic (A Medical Corporation) Medical Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE A – DESCRIPTION OF THE PLAN

The following description of The Baton Rouge Clinic (A Medical Corporation) Medical Plan Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

[1] General

The Plan provides health and other benefits covering eligible employees of The Baton Rouge Clinic (the “Clinic”) and their dependents. Plan assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All Plan benefits are self-insured. The Plan entered into an administrative services agreement with Blue Cross Blue Shield of Louisiana, as the third-party administrator. The claims for self-insured benefits are processed by the Plan’s third-party administrator under an administrative services only (“ASO”) arrangement. The third-party administrator pays claims directly to or on behalf of participants and is then reimbursed by the Plan’s VEBA trust. Despite the Plan’s utilization of a third-party administrator, ultimate responsibility for payments to benefit providers and participants is retained by the Plan.

[2] Benefits

The Plan provides medical benefits (hospital, surgical, major medical, and prescription drugs), life insurance coverage, and accidental death and dismemberment coverage for employees who either actively work at least 20 hours a week, are classified as non-temporary employees, or are classified as eligible retired employees. A participant becomes eligible for coverage on the first day of the month following the date of hire. Eligible retired employees are entitled to similar health benefits provided they have attained at least 15 years of service with the Clinic, have agreed to make required contributions, retire on or after the age of fifty-nine and one half, and are not eligible for Medicare.

The Plan provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”). Medical benefits under COBRA are funded entirely by the former employees.

The Plan also permits participants to elect to use flexible spending accounts (“FSA”) to set aside a portion of their earnings on a pre-tax basis to pay for qualified expenses. Amounts in the accounts at the end of the Plan year, if any, cannot be carried forward to the next year and are forfeited back to the Clinic. Substantially all of the contributions into the FSAs are used to pay participant premiums in the Plan and are included in participant contributions in the statement of changes in net assets available for benefits.

The Clinic provides a high deductible health plan (“HDHP”) option as a component of the Plan. Under a HDHP option, participants pay the out-of-pocket healthcare expenses not fully covered by insurance, such as copays, coinsurance, and deductibles, subject to the applicable limits of the Plan. Additionally, health savings accounts (“HSA”) are an optional component of the Plan. The associated activity is excluded from the Plan’s financial statements because the Plan is not obligated to pay the benefits; the participants own the accounts and are responsible for substantiating distributions from his or her HSA account.

[3] Contributions

The Plan agreement provides that the Clinic make contributions to the Plan on the employee's behalf after they have completed three consecutive months of employment; a covered employee pays the entire cost of coverage for their eligible dependents. An employee may contribute specified amounts to extend coverage for themselves during the first three calendar months following the employee's date of hire and for eligible dependents during the same time period. The total contribution rates for the contract periods from January 1, 2024 through December 31, 2024, and January 1, 2023 through December 31, 2023, were \$1,029.45 and \$912.94, respectively, per month for single coverage and \$2,287.68 and \$2,028.76, respectively, per month for family coverage. Total contribution rates for the HDHP for 2024 and 2023 were \$926.51 and \$821.65, respectively, per month for single coverage and \$2,058.91 and \$1,825.88, respectively, per month for family coverage. Any deficiency of the Plan's net assets over benefit obligations is funded by the Clinic.

[4] Stop loss insurance

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). A contingent liability exists with respect to such stop loss insurance should the insurance company be unable to meet the obligations assumed under the stop loss insurance agreement. For the contract periods below, the Plan has obtained stop loss insurance on health claims with the following limits:

Under these stop loss insurance contracts, \$61,488 and \$97,199 was due to the Plan at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan collected \$122,622 of stop loss insurance recoveries. Stop loss insurance recoveries are recorded as a reduction of claims incurred and paid by the Plan. During the year ended December 31, 2024, the Plan incurred stop loss insurance premiums of \$508,073.

[5] Administrative expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party administrator, who processes the Plan's benefit claims, and professional fees paid to other service providers. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid directly by the Clinic are excluded from these financial statements.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

[2] Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

[3] Cash

The Plan maintains its non-interest-bearing cash balances in an account with a bank. The balance in this account may at times exceed the insurance coverage provided by the Federal Deposit Insurance Corporation. Plan management periodically evaluates the financial condition of the bank holding its assets and believes such assets do not pose a financial risk to the Plan.

[4] Employer contribution receivable

The Plan records amounts due from the Clinic on an annual basis at year-end based on the Plan's net cash and other receivables less direct liabilities and benefit obligations (claims payable and claims incurred but not reported) as of year-end. At December 31, 2024 and 2023, the Plan had an employer contribution receivable recorded of \$38,868 and \$-0-, respectively.

[5] Benefit obligations

Plan benefit obligations include claims payable and an estimate of claims incurred but not reported (“IBNR”). Plan obligations for health claims incurred but not yet reported are estimated by the Plan based on historical claim payment patterns and claims paid subsequent to year end which relate to prior years. The Plan believes these claims will be paid during the following fiscal year. Thus, the cost of such claims would be approximately equal to the present value; and, therefore, these claims are not discounted.

Based on the low historical participation rates of retired employees and other factors, the Plan administrator does not believe that the benefit obligation associated with post-retirement benefit obligations is material to the financial statements. Furthermore, the Plan estimates that a one-percentage point increase in health care cost trend rates would not have a significant effect on Plan benefit obligations.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[6] Benefits paid

Claim payments are recorded when paid by the third-party claims administrator. Amounts due to the third-party claims administrator that have yet to be reimbursed by the Plan, if any, are recorded as a payable to the third-party claims administrator in the accompanying statements of net assets available for benefits. Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

The third-party claims administrator provides pharmacy benefit management services, which may provide rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. These prescription rebates are provided as a credit against health claims expense. During the year ended December 31, 2024, the Plan earned \$907,420 in prescription rebates. Prescription rebates receivable at December 31, 2024 and 2023, was \$374,005 and \$243,349, respectively.

[7] Allowance for credit losses

Contributions receivable, stop loss insurance recoveries receivable, and prescription rebates receivable, where applicable, include amounts currently due which the Plan has the unconditional right to receive. Amounts due are stated at their estimated net realizable value. An allowance for credit losses is derived from a review of the Plan's historical losses, adjusted for management's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on this assessment, management determined that an allowance for credit losses at December 31, 2024 and 2023, was not necessary.

[8] Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – INCOME TAX STATUS

The VEBA trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the VEBA trust's net income is exempt from income taxes. The Plan has obtained a favorable tax determination letter dated August 22, 1991, from the Internal Revenue Service. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the VEBA trust continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code, and the trust is tax-exempt.

NOTE C - INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE D – PLAN TERMINATION

Although it has not expressed any intent to do so, the Clinic has the right under the Plan to modify the benefits provided to, and the contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the remaining assets will be applied in a uniform and nondiscriminatory manner towards the provision of benefits for or on account of the participants until all benefit obligations of the Plan have been satisfied.

NOTE E – RISKS AND UNCERTAINTIES

The Plan's benefit obligations are reported based on certain assumptions pertaining to health claim payment patterns and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE F – RELATED PARTY TRANSACTIONS

As described in Note A, the Plan has a contractual arrangement with the third-party administrator. These transactions are considered party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA. The Clinic pays certain expenses of the Plan; therefore, these transactions qualify as party-in-interest transactions under ERISA. Certain administrative functions are performed by employees of the Clinic at no cost to the Plan. These transactions are not considered prohibited transactions under Section 408(b) of ERISA regulations.


