Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Weller Auto Parts 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Note 1 - Description of the Plan

The following description of Weller Auto Parts 401(k) Plan (the Plan) provides only general information. Participants should refer to the restated Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Weller Auto Parts, Inc. (the Company) who have met the service requirements defined below and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of the Company are eligible to participate in the Plan on the first of the month following completion of 90 days of service for the Company, as defined by the Plan, and attaining age 21.

Contributions

Participants may contribute up to 80% of their pay each plan year, up to the maximums established by Internal Revenue Service (IRS) regulations. The Plan contains an automatic enrollment arrangement. In the absence of a salary-deferral agreement, participants are automatically enrolled into the Plan to defer 8% of compensation. Eligible employees may elect not to defer or to defer another percentage. Participants contributing to the Plan under the automatic enrollment election shall have an annual 1% increase in their deferral rate that is not to exceed 15% of their gross pay, absent a subsequent election by the participant. If an employee chooses to enroll, or if employee is automatically enrolled, and does not provide direction as to how contributions made should be directed, then contributions will be directed to the Plan's default investment option: a designated Principal lifetime fund. Participants may also contribute amounts representing distributions from other qualified plans.

The Company contributes a discretionary matching contribution up to 10% of participant's eligible compensation. In 2024 and 2023, the matching contribution was 50% of the participant's contribution, up to 10% of eligible compensation for each year. The Company may make a discretionary profit-sharing contribution on an annual basis. No discretionary profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts and Forfeitures

Each participant's account is credited with the participant's 401(k) contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on account balances, as defined by the Plan Agreement. Forfeitures will be used first to pay Plan administrative expenses. If forfeitures are not sufficient, then the Company will pay any remaining expenses. Forfeiture activity is as follows:

Vesting

Participants are immediately 100% vested in their elective contributions, plus earnings thereon. Participants are vested in the Company's contributions based on a six-year grading schedule. Participants may also be 100% vested regardless of years of service if they were working for the Company: on or after the date they reach retirement age; on or after the date they reach early retirement age; on the date they become totally disabled, as defined in the Plan; or on the date they die.

Benefit Payments

Upon normal retirement age (65), early retirement age (55 and six years of vesting service), termination of employment, death, or disability, participants or their beneficiaries may elect to receive the value of vested interest in his or her account in the form of a lump-sum distribution, or in an alternative manner, as mutually agreed upon with the Plan Administrator. Withdrawals may also be made upon attainment of age 59½, as defined in the Plan.

Administrative Expenses

Certain administrative expenses are paid by the Company. Administrative expenses not paid directly by the Company may be paid from the Plan in accordance with Plan provisions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when paid.

Note 3 - Fair Value Measurements

In accordance with ASC 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodology was used to measure the fair value of the Plan's investments:

Pooled Separate Accounts (PSAs) - Units held in PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities). While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the PSAs are not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to the PSAs.

Collective Investment Trusts (CITs) - Units held in the CITs are valued at NAV as reported by the trustee, as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CITs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to the CITs.

The stable value CIT NAV is based on the contract value. Investments held by a CIT are required to be reported at fair value. However, contract value is the relevant measurement characteristic for that portion of the net assets of a CIT attributable to fully benefit-responsive investment contracts. This is because contract value is the amount participants would receive if they were

to initiate permitted transactions under the terms of the underlying defined-contribution plans, which approximates fair value.

Mutual Funds - These funds are valued at quoted market prices in an exchange and active market, which represents the NAVs of shares held by the Plan.

Note 4 - Investments and Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA as of December 31, 2024 and 2023 and for the years then ended. Accordingly, Principal Trust Company, Principal Global Investors Trust Company, and Principal Life Insurance Company, qualified institutions, have certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Party-in-Interest Transactions

The Plan investments in PSAs are managed by Principal Life Insurance Company. Principal Life Insurance Company is the contract holder as defined by the Plan. Principal Global Investors Trust Company is the trustee of the Principal Stable Value Fund and the Principal CIT funds. Therefore, these transactions qualify as party-in-interest transactions. Fees paid to Principal were \$80,780 and \$64,940 for the years ended December 31, 2024 and 2023, respectively.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan upon written notice to all parties concerned. In the event of plan termination, participants will become 100% vested in their account balances.

Note 7 - Tax Status of Plan

The Plan adopted the Principal Financial Group 401(k) Non-Standardized Pre-Approved profit-sharing plan. The plan obtained an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Non-Standardized Pre-Approved profit sharing plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended subsequent to the IRS ruling. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability, or tax asset, if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there currently are no audits for any tax periods in progress.

Note 8 - Pending Qualified Nonelective Contribution (QNEC) Correction

During 2025, the Plan Sponsor identified a compliance issue related to missed elective deferrals for an eligible participant during the year ended December 31, 2024. In accordance with the Internal Revenue Service's Employee Plans Compliance Resolution System (EPCRS), the Plan Sponsor intends to correct this issue by making a Qualified Nonelective Contribution (QNEC) to the affected participant.

As of the date of these financial statements, the QNEC has not yet been made. The Plan Sponsor is actively working to complete the correction and expects the contribution to be made in accordance with applicable regulatory guidance. The financial impact of the pending correction is not reflected in the accompanying financial statements for the year ended December 31, 2024.

The Plan Sponsor believes this correction will not materially affect the overall financial position of the Plan.

Note 9 - Subsequent Events

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date when the financial statements were available to be issued.
