# PSYCHOTHERAPEUTIC 401(K) PROFIT SHARING PLAN AND TRUST

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. THE PLAN

The following description of the Psychotherapeutic 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) plan established for employees of Psychotherapeutic Evaluation Programs, Inc., (the Company or Plan Sponsor). The Plan is administered by management of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

All employees, except employees covered by a collective bargaining agreement, leased employees, or merger and acquisition employees, who are at least age 21 and who have completed 1 year of service are eligible to begin salary deferrals and receive employer discretionary contributions on the first day of each calendar quarter following completion of the eligibility requirements.

#### **Contributions**

Participants may elect to defer a percentage of their eligible pay every pay period through traditional 401(k) elections (pre-tax), Roth 401(k) elections (after tax), or a combination of both. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are automatically invested in a designated balanced fund until changed by the participant.

At its discretion, the Company may contribute employer profit sharing contributions to the Plan for each employee that meets the eligibility requirements. A participant is eligible for this contribution if they worked 1,000 hours during the Plan year and were employed on the last day of the year. If the Company decides to make a contribution, it will be allocated to the employees at the end of each Plan year. Employer contributions for the years ended December 31, 2024 and 2023 amounted to \$1,890,000 and \$1,250,000, respectively. The Plan Sponsor has elected to have the forfeiture balance available to offset the employer contribution, which amounted to \$90,000 and \$250,000 for the years ended December 31, 2024 and 2023, respectively.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions along with an allocation of (a) the Company's contribution, (b) plan earnings and losses, and (c) administrative expenses. Contributions allocated to an employee's account are invested according to the employee's discretion. The entitled benefit is the participant's account balance subject to vesting.

#### **Investment Options**

The Plan currently offers investment options through a regulated investment company, including mutual funds and a fully benefit responsive guaranteed investment contract. Participants may change their investment options daily.

## 1. THE PLAN (Continued)

### Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of the nonforfeitable amount of their account balance. No loans less than \$1,000 will be made. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime rate plus 1 point. Principal and interest is paid in substantially equal payments over the life of the loan through payroll deductions. The loan in its entirety must be repaid within 5 years of the date the loan proceeds are received, unless used to acquire the principal residence.

### Payment of Benefits

If an employee is terminated, the participant's vested benefit can be received in a single lump sum payment or have the payment paid as a "direct rollover" to an individual retirement account or individual retirement annuity or to another employer's qualified tax plan. If the value of the employee's vested account balance is \$7,000 or less on the applicable valuation date as provided under the Plan, the Company can cash the employee's entire vested account balance out of the Plan. Otherwise, payments can be made in installments.

On termination of service due to death and disability prior to age 65, before distribution of the employee's benefits has begun, the employee becomes 100% vested and the vested account balance will be payable in a single lump sum to the participant's beneficiary.

While employed, a participant may also withdraw his or her vested account balance on account of financial hardship, as defined in the Plan Document. All hardship withdrawals must comply with the rules relating to hardships which are uniformly applicable to all participants and be used to pay qualifying expenses of certain immediate and heavy financial need.

### Vesting

A participant is vested immediately in their contributions plus actual earnings and losses thereon. Vesting of Company profit sharing contributions is as follows:

### Forfeitures

Forfeitures may be used to pay administration expenses of the Plan, and reduce the employer discretionary contribution. Participants who terminate employment before they vest will forfeit their interest in employer contribution accounts. These accounts will be held in the Plan to meet any obligations to pay plan expenses if the employer elects not to pay such expenses directly. The forfeiture balance approximated \$118,000 and \$258,000 at December 31, 2024 and 2023, respectively. During 2024 and 2023, approximately \$12,000 and \$14,000 of forfeitures were used to pay plan expenses, respectively. As mentioned above, the Plan Sponsor has elected to have the forfeiture balance available to offset the employer contribution receivable, which amounted to \$90,000 and \$250,000 as of December 31, 2024 and 2023, respectively.

### Administrative Expenses

The Plan permits the payment of plan expenses to be paid by the Company or from the Plan, or both. Any expenses paid by the Plan are paid by plan participants as a reduction of investment income.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts of net assets available for Plan benefits.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

### **Investment Valuation and Income Recognition**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Financial Instruments Measured at Fair Value**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities. The Plan's investments in mutual funds are valued based upon quoted prices in active markets.
- Level 2 inputs are observable prices that are based on inputs not quoted in active markets but corroborated by market data. The Plan does not have any Level 2 investments as of December 31, 2024 and 2023.
- Level 3 inputs are unobservable inputs that are used when little or no market data is available. The Plan does not have any Level 3 investments as of December 31, 2024 and 2023.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. The fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds* - Value based on quoted price in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used in the prior year.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3. A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 4.

### **Payment of Benefits**

Payment of benefits to participants are recorded when paid.

### 3. CERTIFIED INVESTMENT INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **5. GUARANTEED INVESTMENT CONTRACT**

The Plan holds a fixed annuity contract with the Empower Life & Annuity Insurance Company of New York, which is reported as fully benefit-responsive. The contract is a group unallocated contract, which means the deposits and earnings on those deposits are credited to the group as a whole, rather than individual participants.

Certain events may limit the Plan's ability to transact at contract value with the Plan's custodian. Such events may include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that may limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Interest crediting rates are determined based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rates are reset quarterly. During the years ended December 31, 2024 and 2023, the average rates were 1.81% and 1.59%, respectively.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## **7. TAX STATUS**

The Plan is a Prototype Standardized Sharing Plan with CODA issued through Document Agility, Inc. The Internal Revenue Service has determined by letter dated June 30, 2020 that the Plan and related trust were designed, at that time, in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, were exempt from federal income taxes. The Plan has been amended since that date. The Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

**8. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Transactions between Empower Retirement, LLC, Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York and the Plan qualify as party-in-interest transactions since these organizations provided custodial and recordkeeping services to the Plan during the reporting period.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, loan transactions between participants and the Plan qualify as party-in-interest transactions.

**9. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

**10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
