1. Description of Plan

The following description of Family 1st Dental 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering all eligible employees of Family First Dental Associates of Nebraska, P.C. (the “Employer” or “Company”). Employees are eligible to participate the month following attaining the age of 20 and completing 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

B. Contributions

Each year, participants may elect to contribute a percentage (up to 100% for pre-tax deferrals) of their compensation, as defined by the plan, as either pre-tax or after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts that represent distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may contribute at its discretion matching and profit sharing contributions. In 2024 and 2023, the discretionary Employer matching contribution was 10% of the first 5% of employee deferrals for the years ended December 31, 2024 and 2023. Employer profit sharing contributions are determined by the Employer and are made within the time permitted by the Internal Revenue Code (“IRC”). No Employer profit sharing contribution was made for 2024 and 2023. Employer profit sharing contributions are allocated based upon participant earnings as defined by the Plan. Participant and Employer contributions are subject to limitations set by the IRC.

C. Participant Accounts

Each participant account is credited with the participant’s contribution and Employer matching contributions, as well as allocations of the Employer’s profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Employer discretionary matching and profit sharing contributions plus actual earnings (losses) thereon is based on years of continuous service. A participant is 20% vested after one year of credited service and is vested additional 20% each year until fully vested after five years of credited service. Participants' accounts become fully vested in the event of death, or disability.

E. Notes receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the Employer. Principal and interest are paid through payroll deductions or by check.

F. Payment of Benefits

The payment of benefits can be made upon reaching age 59 ½, death, disability, hardship, or termination of employment. Hardship distributions are also permitted from the elective deferral source of a participant's vested account. The Plan requires distribution payments of \$5,000 or less to be rolled over to an individual retirement account designated by the plan administrator, if the participant does not elect otherwise. For vested account balances exceeding \$5,000, the participant or beneficiary may elect to receive either a lump sum, non-recurring partial payments, or recurring installment payments.

G. Forfeited Accounts

Nonvested employer contributions of terminated participants become forfeitures in the year in which a participant incurs a break in service as defined in the Plan. Forfeitures are used to reduce the Employer contributions. As of and for the year ending December 31, 2024 and 2023, there were no significant forfeited accounts available or used.

2. Summary of Accounting Policies

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

2. Summary of Accounting Policies - Continued

B. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

E. Payment of Benefits

Benefits are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

G. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in markets not active;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Investment Contract with Nationwide

The Plan entered into a fully benefit-responsive guaranteed investment contract with Nationwide totaling \$218,474 and \$190,339 at December 31, 2024 and 2023, respectively. Nationwide maintains the contributions to the Fixed Select Contract (the "Account") in a general account. The Account under the contract is credited with interest and charged for participant withdrawals and administrative expenses. Nationwide is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Nationwide and reviewed quarterly for resetting. Nationwide may terminate the contract with the Plan by providing 90 days prior written notice.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Nationwide's ability to meet its financial obligations. Nationwide's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Withdrawals from the account directed by the Company due to Plan termination, merger of the Plan, or reduction in the number of participants may limit the ability of the Plan to transact at contract value. In the event the payments are made directly to affected participants, these payments must be made within 30 days of written notice; if the payments are transferred to a new plan, the payment must be made within 90 days. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Nationwide and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Party in Interest Transactions

The Plan includes various investments managed by Nationwide Financial Services, and its subsidiaries. Nationwide Financial Services and its subsidiaries serve as the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

8. Tax Status

The Company adopted the Benefit Plans, Inc. non-standardized defined contribution pre-approved plan on January 1, 2022. On June 30, 2020, the Internal Revenue Service stated the pre-approved document adopted by the Company, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not received a determination letter specific to the Plan. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator believes the Plan has no significant uncertain tax positions. Therefore, no provision or liability for uncertain taxes has been recorded in the financial statements.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statement was the valuation of investments as certified by Nationwide Trust Company.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We did not identify any misstatements.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. See "Internal Control Deficiency Matters" below.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Internal Control Deficiency Matters

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Plan in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to investment information. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected, on a timely basis.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

We have prepared the financial statements; you, however, are responsible for the statements. Effective internal control is essential to prevent, detect and correct misstatements in financial statements. Preparation of financial statements in accordance with generally accepted accounting principles is a significant part of an entity's internal control. Our firm has appropriate controls over financial statement preparation; however, our controls cannot be considered as a substitute for or part of your internal control.

We consider the following to be reportable findings:

During our testing of participant deferrals, we noted certain employees had Roth contributions remitted as pre-tax contributions and certain employees had pre-tax contributions remitted as Roth contributions. The source of contributions has tax effects on participants when distributions are taken. We recommend Plan management improve its policies and procedures to ensure contributions are remitted to the Plan with accurate source type and review by someone other than the preparer.

During our testing of participant deferrals, we noted certain employee data did not match between payroll and Nationwide records, specifically date of hire, date of birth, date of termination, and date of rehire, and therefore, alternative procedures were used to ensure the discrepancies did not affect Plan operations. We recommend Plan management put policies and procedures into place to ensure employee data captured in the recordkeeping system is reviewed for accuracy to support employee eligibility, vesting provisions, and benefit payment requirements.

Other Matters

With respect to the ERISA-required supplemental schedules accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.
