### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the BioMatrix Specialty Pharmacy, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was adopted effective January 1, 2013 as a defined contribution plan by Biomatrix Specialty Pharmacy, LLC, and has been amended and restated over the years to admit related employers into the Plan and comply with tax legislation. The Plan is sponsored by BioMatrix Specialty Pharmacy, LLC, and its controlled group affiliates, FFP Holdco, LLC, FFP, LLC dba Matrix Health, FFP Acquisition I, LLC dba Medex BioPharm, Factor Support Network Pharmacy, Inc. dba FSN Specialty Pharmacy, CMC Pharmacy, LLC dba Med Center Specialty Pharmacy, BioMatrix Care Coordination, LLC, BioMatrix Specialty Pharmacy, Injectable Therapy Services, Inc (ITS) dba BiologicTx a California Corporation, Sunshine Infusion Services, Inc. dba BiologicTx, Pharmacy an Illinois Corporation, Biologictx, LLC; Nevada LLC, BioMatrix of Maryland, LLC, City Drugs, LLC Decillion Healthcare LLC dba Decillion Healthcare, FFP Acquisition II, LLC dba Medex Biocare, K&K Rx Services Genpar, LLC, K&K RX Services, LP dba Elwyn Pharmacy, Elwyn Rx at Fair Acres and Elwyn Specialty, Elwyn Pharmacy Group, LLC, GRM Pharmacy, LLC dba Glen Rock Medical Pharmacy, and InfuCare, Ltd. (collectively, the Sponsor or Employers). The Plan is available to the eligible employees of the Sponsors. Employees of the Sponsors may participate in the Plan upon completing three months of credited service and reaching age twenty-one (21). An eligible employee may participate in the Plan beginning on the first day of the month following the date the employee meets the requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration of the Plan

Lincoln Financial Group Trust Company, Inc. (the Trustee) holds the Plan's investments, executes transactions, and provides recordkeeping services through its affiliate, Lincoln Retirement Services Company, LLC (Lincoln). The Plan Administrator is the Plan's Sponsor. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants may voluntarily contribute up to 90% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan's provisions also provide for Roth 401(k) elective deferrals.

For the year ended December 31, 2024, the Employers made safe harbor matching contributions to eligible participants equal to 100% of a participant's contributions up to 4% of a participant's eligible compensation, as defined. For the year ended December 31, 2024, the Employers safe harbor matching contributions totaled \$739,789. All safe harbor matching contributions are invested as directed by the participants.

In addition to the safe harbor matching contributions, in any Plan year, the Employers may elect to make a discretionary contribution. A participant is eligible to receive discretionary matching contributions if they have completed 1,000 hours of credited service and are employed on the last day of the Plan year. There were no discretionary contributions made for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

### Note 1 – Description of Plan, Continued

#### Participant accounts

Each participant account is credited with the participant's contribution, and an allocation of: (a) the Employers' contributions (if any), and (b) an allocation of Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion of their accounts.

#### Vesting

Participants are immediately vested in their individual contributions and their Employers' safe harbor contributions, plus actual earnings or losses thereon. Participants who become eligible, and are enrolled in the Plan, will receive vesting credit for years of service based on the elapsed time method, as defined. A participant is fully vested in their Employers' discretionary matching contributions after five years of credited service in accordance with a graded vesting schedule. Participant accounts become fully vested in the event of normal retirement (65), death, disability, or termination of the Plan.

#### Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future Employers' contributions. During the year ended December 31, 2024, forfeitures approximating \$4,000 were used to reduce the Employers' contributions and offset certain Plan administrative expenses. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$4 and \$3,632, respectively.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested account balance in the participant's account, and bear interest at the prime rate plus 1%, determined as of the date of the loan request. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed ten years.

#### Payment of benefits

Upon termination of service due to death, disability, or normal retirement age (65), a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$5,000 receive a lump-sum distribution. Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal in accordance with IRS guidelines. Participants may also withdraw their vested account balances at any time on or after age 59½. Distributions may be in the form of a lump-sum payment, or a rollover into another qualified plan.

#### Plan administration

The Employers are the Administrator of the Plan, and as such, they control and manage the operations of the Plan. Plan management has engaged Lincoln Financial Group Trust Company, Inc. (the Trustee) to act as the Plan's trustee. The Trustee's affiliate, Lincoln, is the Plan's recordkeeper and manages the Plan's investments. Participant and the Employers' contributions are held and managed by the Trustee who invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of the participants). Fees from covered service providers of the Plan are in compliance with Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

### Note 2 – Summary of Significant Accounting Policies

#### Basis of accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and the Plan's Trustee.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the note receivable is reduced and a benefit payment recorded.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and those differences could be material.

#### Risks and uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the level of risk associated with certain investment securities, including the uncertainty related to changes in the value of investment securities, it is at least reasonably possible changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

#### Payment of benefits

The Plan records benefits when paid.

#### Plan expenses

Investment related expenses are included in net appreciation in fair value of investments. Certain administrative expenses, such as recordkeeping, trustee, and third-party administrator fees, are paid from Plan assets and classified as an expense rather than as a reduction of investment income. Certain other administrative expenses are paid by the Employers and are not reflected in these financial statements. Participant directed transactions such as loan processing fees are charged directly to participants' accounts.

#### Uncertain tax positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan management has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

### Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information, is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

### Note 4 – Fair Value Measurements, Continued

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial investments into or out of Level 3.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds* – are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are deemed to be actively traded on national exchanges and transact at their published daily net asset value (NAV).

The preceding method described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Group Annuity Contract with Insurance Company

The Plan invests in a group fixed annuity contract issued by The Lincoln National Life Insurance Company (LNLI or the issuer). LNLI may impose restrictions on transfers and withdrawals involving the LSVA if competing investment options are offered.

The LNLI guarantees the contracts principal and guaranteed minimum interest rate (GMIR) for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract. The current rate, the guaranteed minimum floor rate, and the GMIR are expressed as annual effective yields. For the year ended December 31, 2024, the average interest crediting rate was 2.30%. Contract value, as reported by LNLI, as of December 31, 2024 and 2023, was \$851,332 and \$870,384, respectively.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by LNLI, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

### Note 5 – Group Annuity Contract with Insurance Company, Continued

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. LNLI's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Lincoln and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow LNLI to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of LNLI.

Based on ongoing credit evaluations of its guaranteed investment contract investments, Plan management does not expect payment defaults or delinquencies and has not recorded an allowance for credit losses for these investments as of December 31, 2024 and 2023.

### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

### Note 7 – Party-In-Interest Transactions

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers, and certain others. The Plan's investments are managed, administered, and/or issued by the Trustee or its affiliate, LNLI. The Trustee's affiliate, Lincoln is the Plan's recordkeeper. Therefore, transactions with the Trustee, LNLI, and Lincoln qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Sponsor. No officer or employee receives compensation from the Plan for these services.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

### Note 8 – Tax Status

On June 30, 2020, the IRS stated that the non-standardized pre-approved profit-sharing plan with CODA adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the Plan and its related trust are tax-exempt. The Plan has not received a determination letter specific to the Plan itself, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8 – Tax Status, Continued**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 9 – Delinquent Participant Contributions**

During the year ended December 31, 2024, participant contributions and loan repayments totaling \$138,786 were not remitted to the Plan within the period prescribed by DOL regulations. Late remittances of participant contributions constitute prohibited transactions under ERISA Section 406, regardless of materiality. Lost earnings related to the 2024 delinquent participant contributions have not been remitted to the Plan and, accordingly these delinquent contributions and loan payments have not been corrected.

#### **Note 10 – Subsequent Events**

Management evaluated activity of the Plan subsequent to December 31, 2024 through October 13, 2025, the date on which the financial statements were available to be issued, for events that require recognition in the financial statements or disclosure in the notes thereto.
