**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of **ALEXANDER & ASSOCIATES PROFIT SHARING AND 401(k) PLAN** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Alexander & Associates (the Company) Profit Sharing and 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all full-time employees of the Company who are twenty-one years old or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

2. Contributions

Employees are eligible to make elective deferral contributions and to receive matching contributions on the first day of each plan quarter, coinciding with or following the date they first perform an hour of service as an eligible employee. Each year, participants may contribute up to 100 percent of pretax annual compensation until certain plan limits are met, as defined in the Plan. Participants are eligible for profit sharing contributions after completion of one year of service. The Company matches 100% of deferrals up to 1% of eligible compensation plus 50% of deferrals over 1%, but not exceeding 6% of compensation. Absent an affirmative deferral election, all new plan participants automatically have 6% of eligible compensation withheld and contributed to the plan. Additional profit sharing amounts may be contributed on behalf of the participants at the option of the Company's board of directors. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a common/collective trust fund as investment options to participants. Contributions are subject to certain limitations.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and profit sharing contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or a fixed formula related to compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's contributions is based on years of continuous service. The Plan was amended, effective January 1, 2007, so that the company's profit sharing contribution is 100 percent vested after three years of credited service.

5. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. In 2020, the Plan adopted the distribution provision of the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act). A CARES Act distribution allows the Plan's participants to receive a COVID-19 pandemic related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020.

6. Forfeited Amounts

At December 31, 2024, there were no forfeited nonvested account balances. At December 31, 2023, forfeited nonvested account balances totaled \$68. These balances can be reallocated to participants as employer contributions or used to offset plan administrative expenses. Forfeitures reallocated to participants and used for plan expenses in 2024 and 2023 totaled \$1,746 and \$1,000, respectively.

7. Participant Loans

Plan participants may apply for a loan. The loan may not exceed 100% of the participant's vested account balance and the maximum dollar amount of the loan outstanding to any participant may not exceed \$100,000. Plan provisions require that loans must be evidenced by a signed promissory note and bear interest at 1% over the prime rate. The term of the loan may not exceed five years. Loan payments of principal and interest must be made through payroll deductions, provided that the Plan Administrator may allow payment by other means for prepayment in full. Participants on authorized leave of absence, as determined by the Plan Administrator, can request suspension of loan repayments. In 2020, the plan adopted the temporary loan repayment deferral provision of the CARES Act. The deferral provision adopted by the Plan allows qualified Plan participants who have Plan loans outstanding from March 27, 2020 to December 31, 2020 to defer repayments of those loans for up to one year.

8. Subsequent Events

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (Note H), with the exception of its investment in a collective investment fund, which is discussed separately below. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The Plan invests in the Galliard Stable Return Fund C, a collective investment fund. The Galliard Stable Return Fund C invests in investment contracts issued by insurance companies and other institutions. The Plan's investment in the Galliard Stable Return Fund C is included in the statement of net assets available for benefits at net asset value (NAV). NAV represents contributions made to the Galliard Stable Return Fund C, plus earnings, less participant withdrawals and administrative expenses. NAV is reported to the Plan by the trustee. The gross crediting interest rate for the Galliard Stable Return Fund C was 4.88% and 4.92% for the years ended December 31, 2024 and 2023, respectively.

4. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative Expenses

Certain expenses of the Plan are paid by the Company.

**NOTE C – PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS**

In 2024 and 2023, certain Plan investments were shares of mutual funds managed by Charles Schwab. Charles Schwab Trust Bank (Schwab) is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Pension Corporation of America (PCA) is the Plan's administrator. PCA Investment Advisory Services (PIAS) is the Plan's investment advisor. The Company, Schwab, PCA and PIAS are parties-in-interest to the Plan. Notes receivable from participants are also considered party-in-interest transactions.

**NOTE D - ADMINISTRATION OF PLAN ASSETS**

Company contributions are held and managed by the trustee, who invests cash received, interest and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE F - TAX STATUS**

The Trust established under the Plan is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Plan has been provided an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan adopted by the Plan sponsor, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related Trust was tax-exempt as of the financial statement date.

**NOTE G – INFORMATION CERTIFIED BY THE TRUSTEE**

All information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investment assets at December 31, 2024 and 2023, and the related net dividend, interest and other income, and the related net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Schwab.

**NOTE H – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The following is a description of the valuation methods used for assets measured at fair value:

Mutual Funds – The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

Collective Investment Fund – The Galliard Stable Return Fund C is valued based on the reported NAV. The NAV is used as a practical expedient to estimate fair value.
