INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee and the Plan Administrator of Pension Plan of Masonicare Corporation and Its Affiliates

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pension Plan of Masonicare Corporation and Its Affiliates (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (liquidation basis) and December 31, 2023 (ongoing) and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 (liquidation basis) and December 31, 2023 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 (liquidation basis) and December 31, 2023 (ongoing), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Trustees voted to terminate the Plan effective December 15, 2024. All benefit accruals under the Plan ceased as of this date. The assets of the Plan are in the process of being distributed. As a result of the termination, the Plan changed its basis of accounting from the going concern basis to the liquidation basis. In December of 2024, the Plan purchased a group annuity contract on behalf of Plan participants with American United Life Insurance Company ("AUL") for commencement of benefits on January 1, 2025. All assets of the Plan were either transferred to AUL or distributed to participants of the Plan by February of 2025. As a result, the Plan ceased to exist as of February 12, 2025. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

1. Description of the Plan

The following description of the Pension Plan of Masonicare Corporation and Its Affiliates (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined benefit pension plan covering substantially all employees of Masonicare Corporation (the "Company") who have attained the age of 21 and one year of service in which at least 1,000 hours worked. Participation within the Plan was frozen effective December 31, 2002. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company is the Employer and Plan Sponsor.

In November of 2024, the Board of Trustees voted to terminate the Plan effective December 15, 2024. As a result, all benefit accruals under the Plan ceased as of this date. During the year ended December 31, 2024, the Plan was required to accrue and separately present activity for future periods related to (1) any contributions made by the Company, (2) any costs that it expects to incur, (3) any interest and dividends it expects to earn during liquidation; and (4) any adjustments to investments through the liquidation period.

In December of 2024, the Plan purchased a group annuity contract on behalf of Plan participants with American United Life Insurance Company ("AUL") for commencement of benefits on January 1, 2025. The annuity is for the purchase of benefits from the Plan and represents contracts under which AUL is obligated to pay benefits to named employees or their beneficiaries. Funds applied for the purchase of the annuity are excluded from the Plan's assets in 2024.

All assets of the Plan were either transferred to AUL or distributed to participants of the Plan by February 12, 2025. As a result, the Plan ceased to exist as of February 12, 2025.

Pension Benefits

Employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to the difference of (a) 50% of average compensation multiplied by a fraction (not greater than one), the numerator of which is the actual service and the denominator of which is 30 reduced by (b) 35% (50% for employees of certain affiliates of the Company) of the primary social security benefit multiplied by a fraction (not greater than one), the numerator of which is the actual service and the denominator of which is 30. The Plan permits early retirement at age 60. Employees may elect to receive their pension benefits in the form of a joint and survivor annuity. If employees terminate before rendering five years of service, they forfeit the right to receive their accumulated plan benefits attributable to the Company's contributions. Employees may elect to receive the value of their accumulated plan benefits as a lump-sum distribution upon retirement or termination, or they may elect to receive their benefits as a life annuity payable monthly from retirement. For each employee electing a life annuity, payments will not be less than the greater of (a) the employee's accumulated contributions plus interest or (b) an annuity for five years.

Death and Disability Benefits

If an active employee dies at age 65 or older, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. Participants retiring from service with the Company on account of permanent disability, after having been credited with at least five years of service and remaining disabled until normal retirement date, are fully vested and entitled to receive a monthly pension benefit payable immediately. The disability benefit shall be an amount equal to the participant's accrued benefit as of the participant's disability date.

Administrative and Investment Management Expenses

The Plan's trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan. All other expenses of the Plan are paid by the Company.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the Plan termination (see Note 1), the Plan changed its basis of accounting from the going concern basis to the liquidation basis. The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

As of December 31, 2024, one investment approximated 99% of net assets available for benefits.

Payments of Benefit Payments

Benefit payments to participants are recorded upon distribution.

Expenses

Administrative expenses are paid from the assets of the Plan.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

3. Investments Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules (1) Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) and (2) Schedule H, Part IV, Line 4j – Schedule of Reportable Transactions, including investments held at December 31, 2024 (liquidation basis) and December 31, 2023 (ongoing), and net appreciation in fair value of investments and interest and dividends income for the years ended December 31, 2024 (liquidation basis) and 2023 (ongoing), was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”), a qualified institution.

4. Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data.

Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). All mutual funds are valued using Level 1 inputs.

4. Fair Value Measurements *(continued)*

Pooled Separate Accounts: The pooled separate accounts are valued at the net asset value (“NAV”) of units held by the Plan. The NAV, as provided by the trustee Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liabilities. The practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. The Plan’s pooled separate accounts investment is entirely in the Principal LDI Short Duration Separate Account (PLDI). PLDI units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the PLDI. The PLDI has no unfunded commitments at December 31, 2024 and 2023.

5. Funding Policy

Employer contributions to the Plan are made in amounts approved by the Company’s Board of Directors. Such contribution amounts must adhere to or exceed the minimum funding requirements under ERISA, as determined by the Plan’s actuary. The Company’s contributions to the Plan for the years ended December 31, 2024 and 2023 satisfied the minimum funding requirements of ERISA. Participant contributions are not permitted under the Plan.

6. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during their last five or ten years, depending on the entity for which the individual was employed, of credited service. The accumulated plan benefits for active employees are based on their average compensation during the five or ten years ending on the date as of which the benefit information is presented (valuation date). Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary from Principal Life and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations were as follows:

Mortality: For 2022, Pri-2012 mortality tables projected with MP-2022 improvement scale. For 2023, Pri-2012 mortality tables projected with the Principal Mortality Improvement Scale (Principal 2023).

Retirement age: Graded from age 60 to 70 for both 2022 and 2023.

Investment return: The assumed average rate of return increased from 6.5% in 2022 to 6.75% in 2023.

Inflation: The inflation assumption stayed consistent at 2.40% for both 2022 and 2023.

Discount rate: The discount rate used increased from 5.75% in 2022 to 6% in 2023.

The Plan was terminated effective December 15, 2024. Accrued benefits of active participants were frozen as of December 15, 2024. The prior computation of the actuarial present value of accumulated plan benefits was made as of January 1, 2024 and 2023. Had the valuations been performed as of December 31, there would be no material differences.

7. Related Party Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the plan, any party rendering service to the plan, the employer, and certain others. Amounts paid by the Plan to parties in interest included fees paid for investment management and actuarial services. Certain professional fees for the administration and audit of the Plan were paid by the Company. The Plan holds investments from the trustee and Principal Life. The trustee and Principal Life are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to them qualify as party-in-interest transactions. Various administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated July 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions and the actuarial present value of accumulated plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.
