Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bancroft Construction Company, Inc. Cash or Deferred Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

DECEMBER 31, 2024 AND 2023

Note 1 - Description of the Plan

The following description of the Bancroft Construction Company, Inc. Cash or Deferred Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was adopted on January 1, 1986. The Plan is a defined-contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering all employees of Bancroft Construction Company, Inc. and Bancroft Homes, Inc. (the Companies) who are not covered by a collective bargaining agreement, who have reached the age of eighteen and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustee.

Contributions

Each year, participants may contribute up to 100% of their annual earnings, as a pre-tax elective deferral contribution, as an after-tax Roth contribution or a combination of both, subject to the limitations under applicable provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Companies may make matching, profit sharing and qualified non-elective contributions as defined in the Plan document. All matching and profit sharing contributions are at the discretion of the Companies. For the year end December 31, 2024, the employer matching contribution totaled \$347,499.

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options at any time throughout the year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Companies' contributions and Plan earnings, benefit payments, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and contributions or account balances, as defined in the Plan

document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions and qualified non-elective contributions plus actual earnings thereon. Vesting in the Companies' matching and profit sharing contributions are graded based on the following schedule:

Less than 1	0%
1 but less than 2	33%
2 but less than 3	67%
3 or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000. A maximum of one loan may be outstanding at any one time for any eligible participant, with a maximum loan amount available of the lesser of 50% of the participant's vested account or \$50,000. Within each eligible participant's account, a loan sub-account is maintained in order to track principal and interest amounts owed by the participant. The loans bear interest at a reasonable rate determined by the Plan Administrator which is the Prime Rate plus 2%. Interest rates range from 5.25% to 10.50% at December 31, 2024. Interest rates range from 5.25% to 10% at December 31, 2023. Principal and interest are paid ratably through payroll deductions and generally, loans must be repaid within five years unless such loan is used to acquire a participant's principal residence then the maximum loan term is ten years.

Payment of Benefits

A participant or beneficiary may elect to receive a lump sum amount or annuity equal to the value of the participant's vested interest in his or her account upon termination of employment, death, disability, or retirement. Normal retirement age is the later of the date you reach 65 or the fifth anniversary of participation in the plan. The Plan also allows in-service distributions, including hardships, if certain conditions described in the Plan document are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$192 and \$-0-, respectively. Any portion of a terminated participant's account balance that is not vested at the date of termination can be used to offset future employer contributions, pay for Plan administrative expenses and restore previously forfeited amounts. At December 31, 2024, forfeitures were used to pay Plan administrative expenses in the amount of \$4,608.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by their investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain Plan assets represent parties-in-interest as defined by ERISA.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Note 3 - Information Certified and Provided by Matrix Trust Company

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the framework are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at quoted prices as reported on the active market in which the investments are traded.

Money Market Fund: Valued at fair value based on prices of the underlying assets within the fund.

Note 5 - Risk and Uncertainties

The Plan invests in various securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 6 - Income Tax Status

The Plan adopted a prototype non-standardized plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 8 - Party-In-Interest

Certain Plan investments managed by Matrix Trust Company, hold the Plan's assets, invests interest and dividend income and cash received and initiates distributions to participants. Matrix Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transactions rules.

Note 10 - Qualified Nonelective Contribution

During 2024, the Plan administrator discovered that there was an employee not enrolled in the Plan after reaching eligibility as defined by the Plan document and completing their deferral election. As a result, the Plan made a corrective qualified nonelective contribution (QNEC) during 2024 to compensate for the missed deferral opportunity including earnings. Northwest Investment Consulting, Inc. (NWPS), third party administrator, was contacted to assist with the QNEC. The QNEC totaled \$2,177 for the year ended December 31, 2024 and is included in employer contributions on the statement of changes in net assets available for benefits.

Note 11 - Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
