## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of the Michael Dunn Center Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies of this publication are available from Michael Dunn Center (the “Plan Sponsor”).

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of the Plan Sponsor, except for leased employees, employees who are subminimum wage and minimum wage with disabilities, service recipients, contract employees, and Plan Sponsor clients. Eligible employees may enter the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Contributions**

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants may direct both Plan Sponsor and participant contributions to various investment options. Participants can change the investment options previously elected at any time.

During 2024, the Plan Sponsor made discretionary matching contributions equal to 100% of each participant’s elective deferrals up to 3% of eligible compensation. Participant contributions to the Plan are made through periodic payroll contributions, and Plan Sponsor discretionary matching contributions are remitted to the Plan after each payroll period.

Cash contributions receivable, if any, are unsecured.

#### **Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their contributions, rollover contributions, and Plan Sponsor contributions, plus actual earnings thereon.

**1. Description of the Plan (continued)**

**Notes Receivables from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. One loan may be outstanding at a time per participant, and the loans generally bear interest at the prime interest rate plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over a period of time up to 30 years. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their vested interest in their account. If the participant does not voluntarily withdraw their balance, and their vested balance, excluding his or her rollover balance, does not exceed \$5,000 at the time of termination of employment, the participant's vested balance shall be distributed in a single lump-sum payment or in the form of a rollover into an individual retirement account within one year of the participant's termination date. Participants may also withdraw their vested balances at any time on or after the age of 59½, or upon retirement, death, or disability. In-service hardship withdrawals are also available in certain circumstances.

**Termination of the Plan**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP)

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

Empower Trust Company, LLC (Empower) holds the Plan's investments in various mutual funds, which are stated at fair value, and a guaranteed interest fund, which is stated at contract value.

The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments. The investments, with the exception of its fully benefit-responsive contract, are stated at fair value. Fully benefit-responsive contracts are valued based on contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are netted in net realized and unrealized appreciation in the fair value of investments.

**Subsequent Events**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**3. Income Tax Status**

The Plan Sponsor adopted a volume submitter plan sponsored by FIS Business Systems, LLC that received a favorable opinion letter from the IRS dated March 31, 2017, which states the form of the plan is acceptable for use under applicable sections of the IRC. The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

**4. Certified Information (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, investment income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

**5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820, *Fair Value Measurements*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**5. Fair Value Measurements (continued)**

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Empower Guaranteed Interest Fund**

The Plan invests in a fully benefit-responsive traditional investment contract held in the Empower Guaranteed Interest Fund (Guaranteed Interest Fund). The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract can be terminated by either the issuer or the Plan with 75 days' notice.

Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**6. Empower Guaranteed Interest Fund (continued)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without consent of the issuer.

**7. Other Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Empower; therefore, these transactions qualify as party-in-interest transactions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**9. Delinquent Participant Contributions**

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During 2024, contributions totaling \$73,622 were not remitted within the required time period. As of October 13, 2025, the Plan Sponsor is in the process of correcting, including remitting lost earnings to the Plan, these 2024 delinquent participant contributions.
