**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Grunley Construction, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all employees not covered by a collective bargaining agreement or specifically excluded by employee classification in the Plan document, of Grunley Construction Company, Inc. (Company), provided the employee is at least 18 years old and has completed three months of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each year, participants may elect to defer up to the maximum amount of pretax annual compensation as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC). Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may designate some or all of their own contributions as Roth 401(k) contributions. Participants may also rollover distributions received from other qualified plans. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants with automatic elective deferrals are subject to an automatic deferral increase of 1% effective October 1 of each calendar year, up to a maximum deferral of 10% of their annual compensation unless they affirmatively elect otherwise.

The Company contributes a stated match equal to 100% of each participant's elective deferrals, up to 3% of the participant's annual compensation.

The Company may elect, at its sole discretion, to make additional profit-sharing contributions, determined on an annual basis. Participants who have completed 1,000 hours of service and are employed on the last day of the Plan year are eligible to receive discretionary profit-sharing contributions. There were no profit-sharing contributions made to the Plan for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*(See Independent Auditors' Report)*

***Notes Receivable From Participants***

Participants may borrow against the balance in their accounts up to the lesser of 50% of their vested balance of \$50,000 with a minimum borrowing amount of \$500. Principal and interest are repaid through payroll deductions. Participants may also make additional loan payoff payments directly to the Plan.

***Vesting***

Participants are immediately vested in their contributions, qualified nonelective, discretionary profit-sharing and employer matching contributions, and earnings thereon.

***Payment of Benefits***

Benefits are payable as soon as practicable following normal retirement, retirement due to permanent disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan document. If the balance of the account is less than \$5,000, the balance is automatically distributed as a lump-sum payment. Hardship withdrawals are permitted by the Plan.

***Administrative Expenses***

Substantially all administrative expenses are paid by the Plan.

***Investment Options***

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

***Plan Termination***

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by

the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Basis of Presentation***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

The Plan's investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Reclassifications***

Certain prior year amounts were reclassified to conform with the current year presentation.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 4**    **VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2    Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

*(See Independent Auditors' Report)*

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Common and Collective Trusts: Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying instruments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by The Vanguard Group, Inc. (Vanguard), which has retained Ascensus, LLC as a subcontractor to provide recordkeeping services on behalf of Vanguard, and therefore, these transactions qualify as party-in-interest transactions. The Plan paid administrative fees of \$60,926 to the Trustee for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

**NOTE 6 TAX STATUS**

The Plan obtained its latest determination letter in June 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan since was amended. The Plan Administrator believes the Plan is designed and operating in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions taken as of December 31, 2024 and 2023.
