NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Dart Appraisal.com Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan that was established January 1, 2003 to provide benefits to eligible employees of Dart Appraisal.com (the "Company"). The plan was restated October 1, 2022. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Administration and Expenses

Empower Trust Company, LLC ("Empower") is the trustee and custodian, respectively, of the Plan, and The Retirement Advantage, Inc (TRA) is the third party administrator. Fund operating expenses are incurred directly by the fund and are therefore factored into each fund's investment return. Other costs of administering the Plan may be paid by the Plan or the Company at the discretion of the plan administrator.

C. Eligibility

The Plan covers substantially all employees of the Company. Employees are eligible to participate in the Plan on the first day of the month after attaining age 21 and completing three months of service.

D. Contributions

Participants may elect to make pre-tax and or Roth after-tax contributions. Pre-tax deferrals and Roth contributions are limited to 75% of eligible compensation and subject to applicable Code limits. Participants age 50 and older may elect to make additional catch-up contributions as allowed under Code regulations. Employee contributions from all deferral sources remain subject to a maximum of 75% of eligible compensation and applicable Code limits.

Newly hired employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan on the first day of the month after attaining eligibility at a pre-tax deferral rate equal to 5% of compensation.

The Plan permits participants to make rollover contributions of eligible amounts received from other tax-qualified retirement plans subject to the approval of the plan administrator. Such contributions are invested in accordance with participant directions.

The Company is allowed to make discretionary matching contributions, as defined in the Plan and as approved by the Board of Directors. The Company matched 40% of participant's deferred contributions up to a maximum of 5% of the participant's annual salary.

E. Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, if any, rollovers, and the participant's share of investment earnings or losses and expenses. Assets of the Plan are invested based solely on participant directions. The accounts of participants who decline to make an investment election are invested in the Franklin Total Advantage Target Retirement Fund that is appropriate based on the individual's age and projected date of retirement.

F. Vesting

Participants are immediately 100% vested in their contributions, rollovers and related earnings. Participants vest in Company contributions and related earnings allocated to their accounts at the rate of 20% after year two, 40% after three years, 60% after four years, 80% after five years, and 100% after six years of service. Forfeitures of terminated participants' non-vested accounts may be used to pay Plan administrative expenses or to reduce Company contributions. As of December 31, 2024, Plan investments included a forfeiture reserve of approximately \$10,360, respectively.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears a fixed rate of interest commensurate with commercially available borrowing rates determined at loan inception and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence in which case the repayment period may be extended. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through March 2029.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement, or attainment of age 59½ a participant or beneficiary may maintain his or her account in the Plan or receive benefits in a lump sum equal to the value of the participant's account or partial payments. Hardship withdrawals are permitted under limited circumstances as defined in the Plan document. The Plan provides for mandatory distribution of terminated participant accounts valued at \$5,000 or less. If the value of such account is between \$1,000 and \$5,000 and no distribution election has been received from the participant or beneficiary of the account, the account will be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$1,000, the balance will be paid in a lump sum.

I. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Net appreciation includes realized and unrealized gains and losses on investments bought and sold as well as held during the period.

D. Payment of Benefits

Benefits are recorded when paid.

E. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in markets, interest rates, or other factors in the near term would materially affect participant accounts and the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Payment of certain costs of Plan administration to Plan service providers as described in Note 1-B are considered party-in-interest transactions under ERISA. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information relating to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and net appreciation of investments, for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the trustee.

NOTE 6 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Pooled separate accounts are variable annuity investment options which are valued daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day. The following table summarizes Plan investments at December 31 based on the inputs used to value them:

NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

Participant contributions totaling approximately \$2,697 withheld from participants' pay were not received by the trustee within the time frame established by Department of Labor regulations during the 2024 Plan year. The plan administrator engaged in a prohibited transaction under ERISA as a consequence of the failure to timely remit participant deferrals to the Plan.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the Plan's financial statements.
