Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Tilson HR, Inc. Employee Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the benefit obligations and net assets available for benefits of Tilson HR, Inc. Employee Benefit Plan as of December 31, 2024 and 2023, and the changes in its benefit obligations and net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of Tilson HR, Inc. Employee Benefit Plan (the Plan) provides only general information. Plan participants should refer to the Plan Trust Agreement and the related Summary Plan Descriptions for a more complete description of the Plan's provisions.

General

The Plan was established by Tilson HR, Inc. (the Employer) on January 1, 1999, to provide certain medical and dental benefits to participating employees and their eligible dependents. Tilson HR, Inc. is a Professional Employer Organization (PEO) which sponsors the Plan. The Plan's design offers numerous options to participating employees which provide varying contributions, benefits, co-payments, and other features. The Plan is a partially self-insured program funded through contributions by the Employer and the participants. The Employer carries stop-loss insurance to cover a portion of unusually large claims and to protect the Employer from catastrophic losses through December 31, 2023. The Plan administrator was assisted in its administrative duties by Humana Insurance Company and Humana Dental Insurance Company through December 31, 2023. Effective January 1, 2024, the Employer switched to United Health Care as the provider. The new plan is a level funded plan, which has elements of both fully insured and self-funded insurance plan. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA). Assets of the Plan are held in, and transactions are processed through Tilson HR, Inc. Group Health Plan Trust (the Trust).

Contributions

The Employer is required to make contributions to provide the Plan with sufficient funds to pay all claims, insurance premiums, collateral cash, and expenses of Plan administration. Participant contributions are determined by each participating employer and are normally withheld through payroll deductions before being remitted to the Trust.

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short-term and long-term disability benefits, accidental death, and dismemberment benefits to eligible members, and to their beneficiaries and dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Termination

Upon termination of the Plan, the Plan administrator is required to compute the value of the Trust. The trustee will disburse, retain, or transfer the funds in the Trust in any matter mandated by the Plan administrator. In no event will any part of the corpus or income of the Trust be paid to or for the benefit of the Employer.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Benefit Obligations

Benefit obligations for health claims incurred by participants but not reported at the financial statement date are based on experience for unreported claims. Generally, all claims are reported to and paid by the Plan within one year of their incurred dates. From time to time, the Plan's benefit obligations are in excess of net assets available for benefits. These deficits are expected to be funded through future contributions from the Employer and participants.

The liability for Estimated Claims Incurred But Not Reported (IBNR) on the accompanying statements of benefit obligations and net assets available for benefits at December 31, 2024 and 2023, was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor and are included in Benefits Paid in the accompanying statements of benefit obligations and net assets available for benefits.

Premiums paid are recorded as Insurance Premiums in the accompanying statements of changes in benefit obligations and net assets available for benefits.

Cash Deposits

Cash deposits to be used for future claim payments are held by the claims processing service provider.

Collateral Cash Held by UnitedHealthcare

Effective January 1, 2024, the Employer maintains an accumulated cash surplus held by UnitedHealthcare to cover future claims.

Expenses of the Plan

Certain expenses of the Plan, including claim administrative fees, are paid by the Plan as incurred. The Employer pays other expenses including legal fees and Affordable Care Act transitional reinsurance fees.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Refunds

Refunds are recorded when earned. Refunds due as of the financial statement date, if any, are reported as a receivable, with the offset being netted against claims paid.

Stop-Loss

The Plan's stop-loss policy is held by the Employer, but the Employer has elected to contribute the proceeds of reimbursements to the Plan. The proceeds of reimbursement claims filed in connection with the stop-loss coverage are included in the statements of changes in benefit obligations and net assets available for benefits as an offset to benefits paid. There was \$-0- and \$657,971 reimbursed in 2024 and 2023, respectively. With the plan change effective January 1, 2024, the Plan no longer maintains a stop-loss policy but has a predetermined maximum claim expense for 2024.

Income Tax Status

The Trust was established on June 30, 2006, to comply with state insurance regulations (see Note 4). Although the Trust is written to satisfy the requirements of a Voluntary Employee Benefit Association (VEBA) under Section 501 (c)(9) of the Internal Revenue Code (IRC), the Employer has not applied for a determination letter from the Internal Revenue Service (IRS) to establish the tax-exempt status of the Trust. Therefore, the Trust is subject to tax. Management is not aware of any activities that would generate taxable income. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

Subsequent Events

Management evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

On May 27, 2025, the Employer entered into a transaction whereby a majority of the company was acquired by Tilson HR Acquisition, LLC.

NOTE 3 PLAN RESTATEMENT

The Summary Plan Descriptions (SPDs) for the six health plan variations and the dental plan have been restated effective January 1, 2024. Additionally, the Plan introduced an additional health plan variation effective January 1, 2024. The SPDs reflect annual changes in Plan provisions relating to, among other items, covered services, deductibles, and co-payments. The SPDs also contain provisions to comply with changes in laws and regulations related to health care reform.

NOTE 4 REGULATORY REQUIREMENTS

Through December 31, 2023, as a PEO, the Employer is regulated under Title 760 of the *Department of Insurance*, state of Indiana. PEOs which sponsor a self-insured welfare plan are required to maintain a minimum net worth of \$50,000. A self-insured plan is required to obtain adequate stop-loss insurance coverage, to maintain a segregated trust account with a minimum balance of \$100,000, to obtain an annual actuarial opinion from a qualified actuary, to obtain an annual audit of the Plan's financial statements, and to provide enhanced disclosures to participants.

The Employer has obtained a \$400,000 bank letter of credit as of December 31, 2023, as required by and for the benefit of the *Department of Insurance*, state of Indiana. The bank letter of credit is solely for the purpose of satisfying benefit obligations should the Plan have insufficient funds to do so. At December 31, 2023, the letter of credit has not been drawn upon.

As of January 1, 2024, the Employer has a minimum premium plan with its healthcare provider that operates like a self-insured plan but is not subject to the regulatory requirements noted above.

NOTE 5 CONCENTRATIONS OF CREDIT RISK

The Company maintains its cash account balances with a local bank. As of December 31, 2024 and 2023, cash balances were insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor. Periodically throughout the years, the Company's cash balances may exceed this FDIC coverage limit; however, management does not anticipate nonperformance by the bank.

NOTE 6 RELATED PARTY TRANSACTIONS

Fees paid by the Plan for administrative services, including fees paid to the claims processing service provider, constitute permitted party-in-interest transactions.

The Employer provides certain accounting and administrative services to the Plan for which it receives no compensation. The Employer also paid the stop-loss insurance premiums on behalf of the Plan through December 31, 2023.
