### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Obtain an understanding of internal controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal controls. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The Supplemental Schedule of Assets Held at End of Year (Schedule H) and Schedule of Delinquent Participant Contributions (Schedule H Line 4a) are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in supplemental schedules that agreed to or derived from the certified investment information compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of the Teton Automotive Group Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all full-time employees of the Company who have completed 1,000 hours of service within the twelve-month time period following the employee's employment commencement date, have attained age eighteen and are not considered an excluded employee. The Plan uses Voya Retirement Insurance and Annuity Company (Voya) as the trustee.

Contributions

Employees are permitted to make salary deferral contributions to the Plan under a 401(k) arrangement up to the maximum allowable amount not to exceed limits of Code Section 401(k), 402(g), 404, and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan permits participant non-deductible contributions.

The Plan provides for employer matching contributions up to 4 percent of employee compensation at the discretion of the Board of Directors. Employer matching contributions are determined each pay period.

The Company may also contribute a profit-sharing contribution determined annually at the discretion of the Company's management. To be eligible for an allocation of the profit-sharing contribution, a participant must meet eligibility requirements listed above. After meeting eligibility requirements, participants will receive their share of profit-sharing contributions regardless of how many hours they have worked during the year or whether they terminate during the year. The profit-sharing contribution, if any, is allocated to the participants' accounts based upon the participants' compensation as a percentage of the total. This may be a percentage of compensation or a dollar amount. Profit-sharing contributions for the years ended December 31, 2024 and 2023, were \$654,027 and \$760,225, respectively.

Participant Accounts

The participant's accounts are set up in self-directed accounts that are administered by the Voya Retirement Insurance and Annuity Company. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers registered investment accounts and a guaranteed interest account. Participant individual accounts are valued on a daily basis. Contributions and Plan earnings or losses are credited to the participants as soon as the amounts are received by the investment funds. The benefit to which a participant is entitled is limited to the vested amount in the participant's account

Vesting

A participant is 100 percent vested in all employee deferral contributions plus actual earnings thereon. Company matching and profit-sharing contributions vest are as follows:

Forfeited Accounts

Per the Plan document, forfeitures of non-vested amounts are used to reduce future Plan expenses or Company contributions. Earnings are credited to the funds and are also used to reduce future Plan expenses or Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$72,590 and \$12,898, respectively. These accounts will be used to reduce future contributions or administrative expenses. In 2024 and 2023, forfeitures of non-vested accounts that were used to reduce employer contributions or to pay Plan expenses totaled \$31,276 and \$19,188, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have one outstanding loan at a given time. The loans are secured by the balance in the participant's account.

Loan terms range from one to five years and bear interest at a rate comparable to local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

Loans are treated in default if any scheduled payment remains unpaid more than 120 days.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive a lump-sum amount equal to the value of his or her vested benefit, substantially equal installments, or partial withdrawals. The Plan also allows for in-service distributions for participants who have attained age 59 1/2.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to have its financial statements prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company has paid for substantially all costs incurred to administer the Plan, including legal and accounting fees. The Plan pays for investment fees and commissions that are charged directly against participant individual accounts as incurred.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Common Collective Funds:* Valued at fair value based on the Net Asset Value (NAV) of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund, less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

4. RESTATEMENT OF PRIOR YEAR FINANCIAL STATEMENTS DUE TO AMENDED FORM 5500

Subsequent to the issuance of the Plan's financial statements for the year ended December 31, 2023, management determined that certain information previously reported on Form 5500 required correction. As a result, an amended Form 5500 was filed with the Department of Labor to reflect these corrections. The corrections primarily related to the addition of a profit-sharing contribution receivable and the associated addition to reported contributions that had not been calculated prior to issuing, which affected the amounts previously reported in the statements of net assets available for benefits and the related disclosures.

Accordingly, the accompanying financial statements as of and for the year ended December 31, 2023, have been restated to conform to the amended Form 5500. The following table summarizes the effects of the restatement on the previously reported amounts:

Management believes that the restatement is necessary to ensure consistency between the Plan's financial statements and the information reported on the amended Form 5500, as required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Additional information regarding the nature of the changes can be found in the amended Form 5500 filed for the year ended December 31, 2023.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general investment account (GIA). The principal is guaranteed as long as the contract is in force. This contract provides a fixed crediting interest rate, and a financially responsible entity guarantees liquidity at contract value prior to maturity for any and all participant-initiated benefit withdrawals, loans, or transfers arising under the terms of the Plan, which allows access for all participants. The investment options in the GIA are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya Financial, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax Counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that it is no longer subject to income tax examinations for the years prior to 2021.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a third-party administrator. Administrative fees were paid by the Plan in accordance with the Plan document. The Plan's investments were held by Voya Retirement Insurance and Annuity Company, which is the Custodian as defined by the Plan; therefore, these transactions, as well as forfeiture balances, qualify as exempt party-in-interest transactions.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

10. CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the trustee of the Plan).

11. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

There are no reconciling items between the financial statements and Form 5500 as filed with the Department of Labor.
