We have completed a U.S. Department of Labor (“DOL”) limited-scope audit of the financial statements of Mar-Mac Manufacturing Co., Inc. 401(k) Profit Sharing Plan as of and for the year ended December 31, 2024, and have issued our report thereon dated October 13, 2023. As permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”), the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information certified by the Trustee and summarized in Note 4 to those financial statements. Because of the significance of the information that we did not audit, we are unable to, and have not, expressed an opinion on those financial statements and supplemental schedules taken as a whole. We did, however, audit the form and content of the information included in the financial statements and supplemental schedule, other than that derived from the information certified by the trustee and custodian, in accordance with auditing standards generally accepted in the United States of America and found them to be presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Professional standards require that we provide you with information about our responsibilities in accordance with auditing standards generally accepted in the United States, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated September 12, 2025. Professional standards also require that we communicate to you the following information related to our audit.

## **Significant Audit Findings**

### ***Qualitative Aspects of Accounting Practices***

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Mar-Mac Manufacturing Co. Inc. 401(k) Profit Sharing Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant

accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Accounting estimates are an integral part of the financial statements and are based on your management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. Certain financial disclosures are particularly sensitive because of their significance to the financial statement users. There were no particularly sensitive accounting estimates or financial disclosures to report.

The financial statement disclosures are neutral, consistent, and clear.

### ***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in performing and completing our audit.

### ***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. You have corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in aggregate, to the financial statements taken as a whole.

### ***Disagreements with Management***

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### ***Management Representations***

We have requested certain representations from management that are included in the management representation letter dated October 13, 2025.

### ***Management Consultations with Other Independent Accountants***

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### ***Other Audit Findings or Issues***

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

**Other Matters**

With respect to the supplementary information accompanying the financial statements, we made certain inquiries of you and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. ## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Mar Mac Manufacturing Company, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Mar Mac Manufacturing Company, Inc. 401(k) Profit Sharing's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1. Description of the Plan

The following description of the Mar-Mac Manufacturing Co., Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### A. General

The Plan is a defined salary reduction contribution plan covering all employees of the Company who are at least twenty-one years of age and have completed 90 days of service. The Plan allows for matching and discretionary profit sharing contributions for employees of the Company who are at least twenty-one years of age and have completed one year of service and credited with at least one thousand hours of service. The Plan was amended and restated on March 1, 2000, to provide the 401(k) option for employees to defer a portion of their income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

#### B. Contributions

Each year, participants may contribute up to the maximum allowable by Internal Revenue Code (the “Code”) Sections 401(k), 404 and 415. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds and an insurance investment contract as investment options for participants. Company profit sharing contributions are determined annually at the discretion of the Board of Directors. The Company contributed approximately \$100,186 and \$93,021 for 2024 and 2023, respectively. The Company matching contributions were approximately \$42,364 and \$47,228 for 2024 and 2023, respectively.

#### C. Vesting

Participant contributions are fully vested and non-forfeitable at all times. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based upon years of continuous service. The Plan was amended and restated on January 1, 2002, to provide for two year to six year graded vesting. The matching contributions vest according to the following schedule:

#### D. Payment of Benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment. The participant's vested interest will be paid to the participant as soon as administratively possible at the participant's election.

#### E. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (1) the Company's contribution, (2) Plan earnings, and (3) forfeitures of terminated participants' non-vested contributions and charged with an allocation of administrative expenses. Company profit sharing contributions and plan forfeitures are allocated based on the ratio of each participant's compensation to the total compensation for all plan participants for the plan year. An earnings factor equal to the ratio of the net earnings of the Plan's investments to the total assets available at the beginning of the plan year is applied to each participant's beginning balance in allocating the income of the Plan. The employer's matching contributions are credited to participants' accounts based on voluntary contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### F. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$10,057 and \$6,298, respectively. These accounts will be used to reduce employer contributions or pay plan expenses. During 2024 and 2023, forfeitures were not used to reduce employer profit sharing contributions. Forfeitures used in 2024 and 2023 amounted to \$0 and \$0, respectively.

### Note 2. Summary of Significant Accounting Policies

#### A. Basis of Accounting

The financial statements of the Plan have been prepared on an accrual method of accounting in conformity with United States generally accepted accounting principles. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the plan.

#### B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Note 2. Summary of Significant Accounting Policies (continued)**

**C. Investment Valuation and Income Recognition**

Investments of the Plan that are marketable securities in registered investment companies are stated at fair value as determined by quoted market prices. The Plan's investment in a fully benefit-responsive investment contract is valued at contract value. The net increase or decrease in the fair value of the investments from one period to the next is recognized as unrealized appreciation or depreciation. Interest is recorded on an accrual basis as earned. Dividends are recorded as received, which approximates the ex-dividend date.

**D. Payments of Benefits**

Benefits are recorded when paid.

**E. Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the plan sponsor and no employee receives compensation from the Plan. Expenses related to specific participant transactions (distributions) are charged directly to the participant's account. Expenses paid directly by the Plan Sponsor totaled \$37,966 and \$34,287 for the year ending December 31, 2024 and 2023.

**Note 3. Tax Status**

The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service under approved revenue procedures. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes the Plan was qualified as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### Note 6. Fair Value Measurements

The fair value hierarchy, issued by the Financial Accounting Standards Board (FASB) under ASC 820-10 Fair Value Measurement within its Accounting Standards Codification (ASC), was established to distinguish between those inputs that are observable and unobservable. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The levels of hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities. An active market for the asset is defined as a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis. Plan's Level 1 measurements in the current year consist of registered investment companies and money market funds.

Level 2 – Inputs other than quoted prices included in Level 1 that are either directly or indirectly observable for the asset as of the reporting date. These inputs are derived principally from, or corroborated by, observable market data.

Level 3 – Unobservable inputs that are supported by little, if any, market activity and are significant to the fair value of the asset as of the measurement date. The Plan has no Level 3 measurements.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Money Market Funds** – Money market funds are publicly traded investments and are valued daily at the closing price reported on active markets where the funds are traded.

**Registered Investment Companies (Mutual Funds)** – Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

### **Note 7. Fully Benefit-Responsive Investment Contract**

The Plan holds a fully benefit-responsive investment contract with Wilmington Trust Insurance Company called Metlife Group Annuity Contract No.25554 (“GAC”). Metlife maintains the contributions to this investment in a general account and the account balances were \$1,227,927 and \$1,411,093 at December 31, 2024 and 2023, respectively.

The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Metlife, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### **Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. Should the Plan be terminated at some future time, the net assets available for Plan benefits at the termination date would be distributed to participants based on amounts that have been allocated to their respective accounts.
