Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kotaco Fuels, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 PLAN DESCRIPTION

The following description of the Kotaco Fuels, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor contribution plan covering qualified employees of Kotaco Fuels, Inc. (the Company), or any affiliate who has adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a management personnel appointed by the Company. Third Party Administrators serve as the providers of the Plan, maintain the records of participant data and hold the Plan assets.

Eligibility

Employees of the Company are generally eligible to make contributions to the Plan upon attainment of age 21.

To be eligible for the discretionary profit sharing contribution, an employee must be 21 years of age. Once eligible, an employee must be employed on the last day of the Plan year and worked at least 1 hour during the Plan year in order to receive the discretionary profit sharing contribution. There are exceptions for death, disability or attainment of normal retirement age.

Contributions

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Company contributes a safe harbor matching contribution of 100% of participants' elective deferrals that do not exceed 4% of their compensation.

The Company may make an annual discretionary profit sharing contribution. Profit sharing contributions are determined by the Company using the new comparability – one group per participant formula. Under this formula each participant is considered a group and the Company designates an amount for each group (i.e. participant). The discretionary profit sharing contributions for the years ended December 31, 2024 and 2023 were both 0%.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administration expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Vesting

Participants are immediately vested in their deferral contributions, rollover contributions, and corresponding safe harbor matching contributions, plus actual earnings thereon. Discretionary profit sharing and non-elective contributions are vested based on a 4 year schedule.

Participants' Investment Options

Participants must direct their salary deferral contributions and Company contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting John Hancock Life Insurance Company (U.S.A.).

Payment of Benefits

Upon termination of employment, death, disability or retirement, a participant with a vested account balance of more than \$5,000 can receive a lump sum payment or installment payments equal to the value of the participant's vested interest. Distribution of benefits upon termination become automatic if the participant's account balance is less than \$5,000. In-service distributions are allowed upon the attainment of age 59 1/2 or if the participant becomes disabled. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Forfeitures

Forfeitures are used to pay plan expenses, reduce employer contributions, or be re-allocated to participants. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. For the year ended December 31, 2024, no forfeitures were used for any of the qualified purposes.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participant accounts are assessed a separate fee for the administration of benefit payments.

Contributions

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

Notes Receivable from Participants

Participant loans are not permitted in the Plan.

NOTE 4 CONTRACT WITH INSURANCE COMPANY

The Plan holds pooled separate accounts through a Group Annuity Contract with John Hancock Life Insurance Company (U.S.A.). The pooled separate accounts are credited with the earnings of the underlying investments and charged for participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the long-term credit rating of the issuer was “A+” as reported by A.M. Best.

NOTE 5 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any assets to be classified within the fair value hierarchy table. See investments measured using the net asset value per share practical expedient in the following table to reconcile to investments at fair value on the statement of net assets available for benefits.

Conservative accounts seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Income accounts invest in bonds or other fixed-income securities as well as preferred shares and dividend stocks. These investments prioritize current income, often in the form of interest or dividend-paying investments.

Growth and income accounts include investments that are dual strategy and generate growth and income through dividends or interest payments.

Growth accounts include investments that invest in companies the account manager believes have above-average growth potential. Most underlying holdings are in common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These managers are generally willing to pay higher market multiples for the superior growth rates and profitability they anticipate. As a result, stocks in growth portfolios will tend to have higher price/earnings ratios and will generally pay little or no dividends.

Aggressive growth accounts invest in stocks of companies with potential for rapid growth. These investments seek long term growth of capital.

NOTE 6 INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by the Provider. The Internal Revenue Service informed the provider by an advisory letter dated June 30, 2020 that the Volume Submitter plan is acceptable under section 401 of the Internal Revenue Code. The Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES IN INTEREST

John Hancock Life Insurance Company (U.S.A.) is the provider of the Plan as defined by the plan document. As such, transactions with the provider qualify as party-in-interest transactions. Total fees paid to the provider for asset management and recordkeeping services amounted to \$1,875 and \$1,575 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through October 14, 2025, which is the date these financial statements were available to be issued.
