NOTE A – DESCRIPTION OF PLAN

The following description of the Elite Comfort Solutions (ECS or the Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan is a defined contribution plan covering employees who meet eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated August 15, 2024.

Eligibility of Employees

Employees become eligible to participate in the Plan on the entry date coinciding with or following the date on which they attain age 21 and complete six months of service. If a previously ineligible employee changes employment status and, as a result, meets the above criteria, the employee may generally participate in the Plan as soon as administratively reasonable. The entry dates are the first day of each month on or after meeting the eligibility requirements.

Contributions

Participants may elect to voluntarily contribute any whole percentage of compensation, limited by annual Internal Revenue Service (IRS) contribution limits. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account.

The Plan allows catch up contributions for participants age 50 and over. Catch up contributions are eligible for a Company matching contribution.

Company contributions, including safe harbor matching contributions, are made in accordance with the Plan document. Safe harbor matching contributions to the Plan are made by the Company in an amount equal to 100% of participant contributions that do not exceed 3% of compensation, plus 50% of participant contributions that exceed 3% of compensation but do not exceed 5% of compensation, for a maximum match of 4% of compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions and allocations of Plan earnings, and charged with an allocation of certain participant expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Distributions

Participants are always 100% vested in their employee contributions, Company contributions, rollover accounts and qualified non-elective contributions (QNECs). At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,492 and \$774, respectively. These accounts will be used to offset future administrative expenses.

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period, if the vested portion is greater than \$7,000 for 2024, as amended on January 1, 2024, or \$5,000 for 2023. If the participant's account balance is less than \$7,000 for 2024 or \$5,000 for 2023, the Plan administrator directs the trustee to make a lump-sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals are allowed by participants after reaching age 59½.

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Plan Trustee

Reliance Trust Company (Reliance), the sole trustee of the Plan, holds all plan assets, executes all of the investment transactions, and maintains the financial records relating to the trust and makes all benefit payments as directed by the Plan Administrative Committee.

Notes Receivable from Participants

Notes receivable from participants (loans) are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their vested participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rate will be set at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The maximum number of loans that may be outstanding at any one time is one. A loan is considered to be in default if a participant, active or terminated, fails to make all or part of a required loan repayment by the end of the calendar quarter which follows the calendar quarter in which the repayment is due. Loan balance in default will be treated as outstanding for purposes of determining any future loan amounts. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Administrative Expenses

Administrative expenses are paid by both the Company and the Plan. Expenses that are paid by the Company are not reflected in the financial statements of the Plan. Investment related expenses are included in net appreciation in fair value of investments in the accompanying Statement of Changes in Net Assets Available for Benefits. These transactions are allowable party-in interest transactions. Forfeitures used to pay Plan expenses were \$1,258 and \$0 in 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, ECS has the right to terminate the Plan at any time. Upon any such termination, the Company will distribute the Plan's assets to participants in accordance with the terms of the plan agreement.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ materially from those estimates.

Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan offers an investment option in the T. Rowe Price Stable Value Fund, which is classified as a common collective trust fund. The fair value of the fund is valued at net asset value (NAV) and is repriced daily. The Company determines the Plan's valuation policies utilizing information provided by the trustee.

The fair value of mutual fund investments is based upon quoted market prices as of the close of business on the last day of the year. These are classified within Level 1 of the valuation hierarchy as the quoted price is in an active market.

See *Note D* for discussion of fair value measurements.

Investments and Income Recognition - Continued

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan adopted a form of a non-standardized pre-approved defined contribution (defined contribution) plan that obtained an opinion letter dated June 30, 2020, in which the IRS stated that the profit sharing plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC) and therefore not subject to tax. The defined contribution plan has subsequently been amended, however, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE C – CERTIFICATION OF PLAN TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company for the period of January 1, 2023 through December 31, 2024, a qualified institution, has certified the following investment information included in the financial statements and ERISA-required supplemental schedules are complete and accurate:

- i. investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- ii. investment income and interest income from notes receivable from participants as shown in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- iii. investment information and notes receivable from participants included in the accompanying Schedule of Assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

NOTE D – FAIR VALUE MEASUREMENTS

ASC Topic 820, *Fair Value Measurements*, specifies a fair value hierarchy and defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The primary area in which the Plan utilizes fair value measurements is valuing the Plan’s investments. See *Note B* for discussions of the methodologies and assumptions used to determine the fair value of the Plan’s investments. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1: Quoted prices for identical assets or liabilities in active markets.
- Level 2: Other significant inputs observable either directly or indirectly (including quoted market prices for similar securities, interest rates, yield curves, credit risk, etc.)
- Level 3: Unobservable inputs that are not corroborated by market data.

NOTE E – PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with the Company, fiduciaries, or any person who provides services to the Plan. Expenses paid to parties-in-interest aggregated \$16,950 and \$12,120 for December 31, 2024 and 2023, respectively. The vast majority of parties-in-interest fees are paid to T. Rowe Price. The Company provides certain administrative services at no cost to the Plan.

Notes receivable from participants were \$713,410 and \$599,633 at December 31, 2024 and 2023, respectively.

These transactions are allowable party-in-interest transactions under Section 408(b)(8) of ERISA and the regulations promulgated there under.

NOTE F – RISKS, UNCERTAINTIES AND SUBSEQUENT EVENTS

The Plan invests in various investment securities. Investment securities are also exposed to market, credit, and interest rate risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits. The financial statements have been prepared using values and information currently available to the Plan.

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
