## **Independent Auditors' Report**

To the Plan Administration of  
Kelley Drye & Warren LLP Retirement Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Kelley Drye & Warren LLP Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

## **KELLEY DRYE & WARREN LLP RETIREMENT SAVINGS PLAN NOTES TO FINANCIAL STATEMENTS**

### **NOTE 1: PLAN DESCRIPTION**

The following description of the Kelley Drye & Warren LLP Retirement Savings Plan (the "Plan") (formerly, the Kelley Drye & Warren LLP Savings and Investment Incentive Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan, a defined contribution plan, administered by the Retirement and Benefits Committee of Kelley Drye & Warren LLP (the "Firm"), was established on January 1, 1984 to provide for a 401(k) option under Section 401(k) of the Internal Revenue Code ("IRC") as the Kelley Drye & Warren LLP Savings and Investment Incentive Plan. Effective December 31, 2002, the Kelley Drye & Warren LLP Savings and Investment Incentive Plan was renamed the Kelley Drye & Warren LLP Retirement Savings Plan and added a profit-sharing feature for partners and administrative staff.

Partners and employees who have attained 21 years of age automatically become Plan participants and commence their basic 401(k) contributions. Partners and employees become Profit-Sharing Participants on the January 1st, April 1st, July 1st or October 1st following the one-year anniversary of their date of hire. A partner hired in the fourth quarter of the year becomes a Profit-Sharing participant one year from date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

##### Elective Basic Contributions

Each year, participants may elect to contribute up to fifty percent (50%) of pre-tax annual compensation, as defined, to the Plan. In addition, the Plan provides a Roth contribution option whereby participants may elect to make after-tax contributions of between one percent (1%) and fifty percent (50%) of compensation, as defined. Employees hired after September 1, 2007, who expressly do not enroll in the Plan or expressly do not elect a zero percent (0%) contribution rate within sixty (60) days of their date of hire, are automatically enrolled and deemed to have elected a pre-tax contribution rate of two percent (2%) invested in a retirement date targeted fund (effective April 1, 2017, this was changed to 3%). Combined elective contributions cannot exceed the annual maximum amount as permitted by the IRC. Participants who are making maximum contributions and have attained age 50 or older before the end of the Plan year, are eligible to make catch-up contributions of pre-tax contributions, Roth contributions, after-tax contributions, or a combination of both, up to the maximum as permitted by the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

##### Recurring Contributions

The Firm, on behalf of the participant, will contribute as of each pay period, an amount equal to three percent (3%) of each eligible Profit-Sharing Participant's compensation earned in the pay period.

##### Discretionary Annual Contributions

The Firm may, but is not required to, contribute an amount equal to a percentage of each eligible profit-sharing participant's compensation for the year.

##### Member Contributions

For each Plan year, the Firm may contribute an amount, determined by the Firm's Executive Committee, to all profit-sharing participants who are partners of the Firm, based on their pro-rated compensation.

##### Rollovers and Transfers

A participant may, with the consent of the Plan administrator, make transfers between the Plan and plans qualified under Section 401(k) of the IRC or individual retirement accounts upon the occurrence of the events described in "Payment of Benefits" below. Participants may also make transfers to the Plan of eligible rollover distributions from another qualified plan or individual retirement account, as defined in the Plan document.

**NOTE 1: PLAN DESCRIPTION (Continued)**

**Participant Accounts**

An account is established on behalf of each participant. Each participant's account is credited with the participant's basic contribution and allocations of (a) recurring contributions, discretionary annual contributions, supplemental contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. In addition, specific fees may be charged directly to a participant's account for participant requested transactions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective basic contributions plus actual earnings thereon. Vesting in the Firm's discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent (100%) vested after three years of credited service. Participants who have not completed three years of service are not entitled to a distribution of recurring or discretionary annual contributions.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their account balance, subject to the provisions set forth in Article XVI of the Plan. The loans are secured by the balance in the participant's account and bear interest at rates that range from three and one quarter percent (3.25%) to eight and a half percent (8.50%), which are commensurate with the Prime Rate as determined annually by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions over a period of time not to exceed five years. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.

**Payment of Benefits**

On termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$178,096 and \$103,793, respectively. These accounts will be used to reduce future Firm contributions and Plan expenses. During 2024, Firm contributions were reduced by \$35,137 and fees were reduced by \$79,582 and were paid from these accounts.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Firm's Retirement and Benefits Committee determines the Plan's valuation policy utilizing information provided by the investment advisers and custodians. See Note 4 for a discussion of fair value measurements.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Revenue Credits**

If recordkeeping revenue received in connection with Plan services exceeds agreed-upon compensation, the Trustee can allocate amounts equal to such excess revenue to accounts of eligible participants.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan, which may include legal, accounting, trustee, recordkeeping and other administrative fees, are paid directly by the Firm and excluded from these financial statements.

Fees and expenses associated with participant requested transactions, including those related to the administration of notes receivable from participants and investment management services, are charged directly to the participant's account and are included in administrative expenses.

Asset-based investment operating expenses, including management and other fees, which are paid by all shareholders of an investment option are typically reflected as a percentage of the total assets invested in the option. These expenses are deducted from an investment option's assets and are included in net appreciation in fair value of investments.

**NOTE 3: INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AS COMPLETE AND ACCURATE**

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Common Collective Trust Funds**

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Money Market Mutual Funds**

Money market mutual funds are investment mutual funds comprised of high credit quality short-term securities that aim to pay money market interest rates while maintaining a NAV of \$1 per share.

**Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4: FAIR VALUE MEASUREMENTS (Continued)**

**Self-Directed Brokerage Accounts**

Accounts that primarily consist of mutual funds, common stock, corporate and government bonds and certificates of deposit.

**Certificates of Deposit**

Certificates of deposit are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**Common Stock**

Common stock is valued at the closing price reported in the active market in which the individual securities are traded.

**Corporate Bonds**

Corporate bonds are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing values on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those corporate bonds are valued under a discounted cash flow approach that maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

**U.S. Government Securities**

U.S. government securities are valued using pricing models maximizing the use of observable inputs for similar securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: INTEREST IN SPECIAL ASSET HOLDINGS**

Effective July 2001, the Plan created a separate trust for each of the non-publicly traded assets with the individual beneficiary as the trustee. On June 6, 2024, the separate trust was terminated and the asset was sold.

**NOTE 6: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds, mutual funds or other investments managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Dividend income received by the Plan is net of fees charged to the mutual funds by the trustee or its affiliates. The investment fees of \$199,058 incurred by the Plan during the year ended December 31, 2024 have been offset by the Fidelity Participant Revenue Credit program, whereby any credit in excess of Fidelity fees has been paid back directly to the Plan participants. The credit of \$546,530 received for 2024 is included in investment income.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8: TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed the Firm by a letter dated April 25, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

**NOTE 8: TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS or applicable state authority.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10: SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
