We have performed the audits of the financial statements Poultry Products Company of New England LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits - modified accrual basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified accrual basis for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 1. Significant Accounting Policies

Valuation of investments: The Plan investments in registered investment companies that are reported at fair value and a stable value fund valued at contract value. See Note 3 for discussion on fair value measurement and Note 4 for contract value.

The changes in the difference between the current value and the cost of investments and realized gains and losses are reflected in the statement of changes in net assets available for plan benefits – modified accrual basis as an increase or decrease in net realized and unrealized appreciation or depreciation in the current value of investments.

Accounting method: The Plan prepares its financial statements on a modified accrual basis of accounting. Under this method, contributions and other amounts receivable are recognized, but interest and dividends earned on investments are not accrued and investments are presented at fair value. The modified accrual basis of accounting is a basis of accounting other than accounting principles generally accepted in the United States of America.

Estimates and assumptions: Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Accordingly, actual results may differ from these expectations.

Payment of benefits: Except for excess contributions, all other benefits are recorded when paid.

Note 2. Description of the Plan

The following description of the Plan is provided for general information purposes only. Further information about the Plan Document and benefit provisions is available from the Plan Administrator.

General: The Plan was adopted on January 1, 1992, and has been restated effective January 1, 2024. The Plan covers all employees of the Plan Sponsor, Poultry Products Company of New England, LLC (the “Company”) who meet certain age and service requirements discussed below. The term Company refers collectively to Poultry Products Company, Inc., Poultry Products Company of Maine, Inc., Poultry Products Company of Connecticut, Inc., and Poultry Products Company of New England, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Effective June 28, 2024, the Plan transferred assets from Empower Annuity Insurance Company of America (“Empower”) to Reliance Trust Company as further described in Note 10.

Plan management is currently evaluating the provisions of the SECURE Act to determine which amendments will be made, if any, and how the Plan will adopt controls for mandatory provisions as applicable.

Age and service requirements: Employees must have attained age 18 and completed 3 months of service with the Company, with the exception of leased employees and persons who are covered under a collective bargaining agreement, to become a participant in the Plan.

NOTES TO FINANCIAL STATEMENTS

Contributions: Under the Plan, participants may elect to make pre-tax and Roth contributions (“deferrals”) to their employee accounts in amounts up to maximum amounts allowed under Sections 415(c), 402(g), and 401(k) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company may make a discretionary profit-sharing contribution as determined by the Company’s Board of Directors. The employer profit sharing contribution is allocated to eligible employees in proportion to their compensation to the total compensation of all eligible employees. For the year ended December 31, 2024, there were no discretionary profit sharing contributions made.

The Plan allows for an employer discretionary matching contribution as determined by the Company’s Board of Directors. The Board elected to make a discretionary matching contribution equal to 50% of the first \$2,000 participants contributed to the Plan. Total discretionary matching contributions amounted to \$139,482 for the year ended December 31, 2024.

Participant Accounts: Each participant’s account is credited with the participant’s deferral and allocation of (a) the Company’s contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant’s vested account.

Taxes: Participants are not taxed on their deferrals, on the employer contributions allocated to their accounts, or on earnings thereon until these amounts are distributed. Roth contributions are made with after tax amounts. Roth contributions and earnings thereon are withdrawn tax-free provided all required of IRC Section 402A are met.

Vesting: Participants are vested immediately in their deferrals, plus actual earnings thereon. Participants are vested in the current value of the employer discretionary contribution portion of their account plus earnings thereon based on years of service. A participant is 100% vested after completing six years of service. Effective January 1, 2024, the Plan was restated to allow for participant to become 100% vested after completing four years of service. Participants shall become fully vested upon death or permanent disability.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions into various registered investments, a stable value fund and/or a CCT with varying amounts of investment risks. Participants may change their investment options and transfer funds between investment options daily.

Notes receivable from participants: Participants may borrow from the fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Note terms range from one to five years (longer for purchase of a primary residence). The notes are collateralized by the balance in the participant’s account and bear interest at the prime rate plus 1% (8.50 at December 31, 2024). Principal and interest is paid ratably through payroll deductions. A participant may only have one note outstanding at any time.

NOTES TO FINANCIAL STATEMENTS

Benefit payments: The Plan provides for participants to withdraw funds at any time after age 59 ½. The Plan also provides for withdrawals in the event of death, disability, hardship and termination. Benefit payments are in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account, as provided in the Plan Document. Participants may also withdraw from the funds in their rollover account at any time.

Forfeitures: If upon termination of employment a participant's vested percentage in his/her employer contribution account is not 100%, the non-vested amounts shall be retained. Forfeitures may be used to offset employer contributions or pay plan expenses. During 2024, no forfeitures were used. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$46,788 and \$22,624, respectively.

Funding policy: Weekly deferrals are withheld from eligible participant wages. These deferrals are remitted weekly to the Plan Custodian, Empower until June 28, 2024, then Reliance Trust Company as further described in Note 10, and are invested based on the instructions provided by the participants. Discretionary contributions made by the Plan Sponsor, were remitted to the Plan weekly for the year ended December 31, 2024.

Income tax status: The Company adopted a restated pre-approved plan document, and the IRS has determined and informed the sponsor of the pre-approved plan document is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

The Plan adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. Accordingly, management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status, does not have any significant unrelated business income and had taken no uncertain tax positions that require adjustment or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal tax authorities for years before 2021.

Note 3. Fair Value Measurements

The Fair-Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC 820-10) defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosures about fair-value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs are other than quoted prices that are observable for the asset or liability. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investments held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of shares of the trust held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The trust invests in fixed income investment funds and a variety of investment contracts and other investment products with similar characteristics in order to maintain principal value, protect against market price volatility, obtain consistent income return, and provide liquidity for benefit payments and withdrawals.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investments at Contract Value

The Plan holds investment contracts issued by Transamerica Life Insurance Company (“the contract issuer”). The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. At December 31, 2024, the total contract value of this investment amounted to \$56,051.

These contracts are designed to accrue interest based on crediting rates established by the contract issuers. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate to the Plan. The crediting rate is based on a formula established by the contract issuer. Such interest rates are reviewed on an annual basis and semi-annual basis, respectively, for resetting. The contracts do not have a maturity date.

The Plan must provide 30 day written notice to redeem its interest in the investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTES TO FINANCIAL STATEMENTS

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act at 1974.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

Note 5. Costs and Expenses

Certain costs and expenses associated with the operations of the Plan for the years ended December 31, 2024 and 2023 were paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Transactions with Parties in Interest

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services, such as trustees and other employees also are contributing participants in the Plan. These transactions qualify as party-in-interest transactions. However, under the provisions of ERISA these transactions meet the criteria for exemption and are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

The Plan invests in shares of registered investment companies or a stable value fund that are managed by an affiliate of Reliance Trust Company ("Reliance"). Reliance acts as custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 8. Risk and Uncertainties

The Plan provides for any combination of various investment options. Investments are exposed to various risks, such as interest rate, credit and market. Due to the level of risk associated with certain investments and

the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the statements of net assets available for plan benefits – modified accrual basis and the statement of changes in net assets available for plan benefits – modified accrual basis.

Note 9. Information Certified by the Plan's Custodian

The Plan Administrator has elected the methods of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified that the following data as of and for the year ended December 31, 2024. Empower has certified the following information for the 6-month period ended June 28, 2024, the date of transfer as described in Note 10 and as of and for the year ended December 31, 2023, included in the accompanying financial statements and supplemental schedule is complete and accurate:
