## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustee  
Monterey Peninsula Horticulture, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits*

We have performed audits of the financial statements of Monterey Peninsula Horticulture, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### *Basis for Opinion*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

*NOTE 1:* **DESCRIPTION OF PLAN**

The following description of the Monterey Peninsula Horticulture, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 1999. The Plan is a 401(k) salary deferral and profit-sharing plan covering substantially all employees of Monterey Peninsula Horticulture, Inc. (the “Plan Sponsor”) and the following subsidiaries: Growers Transplanting, Inc., Rocket Farms, Inc., Rocket Farms Herbs, Inc., Kumbaya, LLC, and Professional Tribe, Inc. Employees subject to collective bargaining agreements and non-resident aliens are excluded from participation. Employees who have attained the age of twenty-one and have completed three months of service are eligible to participate in the Plan. The Plan is designed to comply with Section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Lincoln Financial Group Trust Company serves as the Trustee and Custodian.

Effective April 5, 2024, eligible compensation now excludes fringe benefits, deemed §125 compensation and gift cards/gift certificates.

**Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

**Contributions**

The Plan allows for the following types of contributions:

***Participant Salary Deferral 401(k) Contributions***

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees may voluntarily contribute a percentage of their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code. Participants may also elect to make Roth after-tax contributions. Eligible employees who have not completed an elective deferral agreement are automatically enrolled at 4%. There is no auto-escalation provision effective until January 1, 2025, when a participant’s deferral percentage increase 1% annually until reaching 7%.

***Employer Discretionary Matching Contributions***

The Plan Sponsor may make matching contributions, equal to an amount, to be determined by the Plan Sponsor. The Plan Sponsor made discretionary matching contributions of \$85,374 and \$85,135 for the years ended December 31, 2024, and 2023, respectively.

***Employer Discretionary Contributions***

The Plan Sponsor may make employer contributions to the Plan at the sole discretion of the Plan Sponsor. The Plan Sponsor elected not to make employer discretionary contributions in 2024 and 2023.

***Rollover Contributions***

Employees may make rollover contributions from another qualified plan.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

**Participant Accounts and Allocations**

The Plan allows participants the ability to self-direct their accounts between various investment options. Participants are allowed to invest their accounts in any one fund or combination of funds. Investment earnings and losses are allocated based on the actual earnings and losses in participants' self-directed accounts, the benefit of which is limited to the vested interest of their individual account.

**Vesting**

Participants are always 100% vested in their elective salary deferral contributions. Employer discretionary and matching contributions, and gains/losses credited thereon, vest as follows:

Less than 1 year of credited service	0%
1 year but less than 2 years of credited service	25%
2 years but less than 3 years of credited service	50%
3 years but less than 4 years of credited service	75%
4 or more years of credited service	100%

**Forfeitures**

Forfeitures from employer contributions may be used to pay Plan expenses or reduce employer contributions. No forfeitures were used to pay Plan expenses in 2024 and 2023, respectively. \$15,165 and \$44,277 were used to reduce employer contributions in 2024 and 2023. At December 31, 2024, and 2023, there were forfeitures of \$3,916 and \$14,575, respectively, available to pay Plan expenses or reduce employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their vested account balance, reduced by any outstanding loan balance. Principal and interest are paid ratably through monthly payroll deductions and loan periods range from one to five years, unless used for the purchase of principal residence, then the loan period may not exceed thirty years.

**Retirement**

Normal retirement under the Plan is the attainment of age 65.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment of the participant; 3) upon demonstration of financial hardship; 4) death or disability of the participant; or 5) obtaining age 59 ½.

The normal form of benefit payment is a single lump sum.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan and the Plan Sponsor at the discretion of the Plan Committee. Expenses related to specific participant transactions are charged to the respective participant's account.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

Mutual funds are stated at fair value, which is based on underlying quoted market prices when available. The group fixed annuity contract is a fully benefit responsive investment contract and is stated at contract value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Changes in the unit values are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments**

Benefit payments are recorded when paid.

**Income Taxes**

The Plan as adopted is non-standardized pre-approved profit-sharing plan with a cash or deferred arrangement (CODA) which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: INFORMATION CERTIFIED BY THE CUSTODIAN**

**NOTE 4: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

**NOTE 5: GROUP FIXED ANNUITY CONTRACT**

Plan investments include an investment in a fully benefit-responsive investment contract with Lincoln Financial Group, which maintains contributions to the fund in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed investment contract's issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed by the Plan.

Because the fixed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity contract. Contract value, as reported to the Plan by Lincoln Financial Group, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As of December 31, 2024, and 2023 the contract value of fully benefit responsive fixed annuity contract was \$116,053 and \$168,998, respectively. Participants may ordinarily direct the withdrawals or transfer of all, or a portion of, their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest is credited to the fixed account at an annual effective yield that is at least equal to the minimum guaranteed interest rate in the investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract other than due to full plan termination, spinoffs, sale, layoffs, terminating participating employer, and termination by a political subdivision, agency, or instrumentality of a government plan. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The fixed annuity contract permits the insurance company to terminate the agreement prior to the scheduled maturity date with 90 days advance written notice. In such an event, Lincoln Financial Group Trust Company will pay the contractual account value after deducting any outstanding charges and fees, including the contract termination charge, if applicable.

The contract does not have a termination date. The Plan Sponsor may terminate the contract at which point Lincoln Financial Group will complete a market value payout based on a formula in the contract.

**NOTE 6: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments such as the guaranteed investment contract is managed by the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are recorded in net appreciation in fair value of investments. Fees for certain expenses related to the administration of the Plan were paid by the Plan or the Plan Sponsor. Notes receivable from participants are considered party-in-interest transactions. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 9: PROHIBITED TRANSACTIONS**

During the Plan year ended December 31, 2023, the Plan Sponsor had delinquent participant contributions of \$7,723 which were corrected during 2024.

**NOTE 10: SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued, and management has determined that no subsequent events have occurred that should be disclosed other than the matters disclosed below.

Effective April 1, 2025, the plan was amended to remove Rocket Farms Herbs, Inc. and Kumbaya, LLC as participating employers.
