INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Metro Waterproofing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits from March 1, 2024 (inception) through December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Metro Waterproofing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the period then ended, stating that the certified investment information, as described in Note (F) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Metro Waterproofing 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Metro Waterproofing 401(k) Plan's ability to continue as a going concern for a period within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(A) DESCRIPTION OF PLAN

The Metro Waterproofing 401(k) Plan (the Plan) was adopted on March 1, 2024, principally to provide retirement benefits for eligible employees. The following description of the Plan contains only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a single employer, participant-directed, defined contribution plan covering all employees of Metro Waterproofing, Inc. (the Company, Plan Sponsor, Plan Administrator) who are age eighteen or older and who have completed one year of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions - During 2024, participants may contribute up to \$23,000 of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions in accordance with the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan is a Safe Harbor plan in which the Company makes non-discretionary matching contributions to the Plan equal to 100% of the first 1% and 50% of the next 5% of eligible compensation that participants contribute to the Plan. For the period ended December 31, 2024, the Company made safe harbor non-discretionary matching contributions totaling \$109,707. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are also invested in the same investments selected for participant contributions. Contributions are subject to certain limitations. The Company did not make a profit sharing contribution for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated default investment fund until changed by the participant. A participant may decline to participate in the Plan at any time. Unless changed by the participant, the employee contribution deferral rate is increased in 1% increments annually, until the contribution deferral percentage reaches a maximum of 6% of eligible compensation. Participants may direct their contributions to any of the Plan's investment options. Participants may change their investment options daily.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Allocations are based on participants earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Vesting - Participants are immediately vested in their rollover contributions and voluntary contributions, plus actual earnings thereon. Vesting in the Company Safe Harbor matching contributions, Profit Sharing contributions and earnings thereon is based on years of continuous service. Participants become 100% vested in these contributions after completing two years of service. Also, see Note (C).

(A) DESCRIPTION OF PLAN - continued

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or payment in annual installments if the participant's vested account is more than \$5,000. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts - If a participant is terminated other than by reason of retirement, death, or total and permanent disability, the nonvested portion of the participant's account balance is forfeited. Forfeitures are used to offset administrative expenses of the Plan or to reduce Company contributions. During the period ended December 31, 2024, no amounts related to nonvested account balances were forfeited.

Administrative Expenses - For any plan year, the Company may pay the expenses of operating and maintaining the Plan. If not paid by the Company, these expenses are paid from forfeitures available for allocation and any unpaid remainder is paid from participant accounts.

(B) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan have been prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fixed Annuity Investment Contract - Investments in the fixed annuity investment contract are required to be reported at contract value. The fixed annuity investment contract is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. Notwithstanding the above, contract value is the relevant measurement attribute for investments in fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the cost plus contributions made under the contract plus interest at the contract rates less withdrawals and administrative expenses. This specifically affects the presentation of the amounts related to the Plan's participation in the fixed annuity investment contract option at December 31, 2024 (see Note H). As such, the statement of net assets available for benefits presents the contract value of the fixed annuity investment contract.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note H). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note (G) for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(B) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - continued

Recent Legislative Developments - SECURE 2.0 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan period ended December 31, 2024.

Payment of Benefits - Benefits are recorded when paid.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Investment related expenses are included in net depreciation of fair value of investments.

Date of Managements Review - Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

(C) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(D) TAX STATUS

The underlying pre-approved defined contribution plan has received an opinion letter from the IRS dated June 30, 2021, stating that the form of the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt.

The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is taking steps to bring the Plan into compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(E) RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(F) INVESTMENTS

Unaudited Information Certified by the Plan Custodian

Empower Trust Company LLC (Empower) is the custodian for the Plan. Empower holds the Plan's investment assets and executes investment transactions. Management has determined that Empower is a qualified institution and the information prepared and certified by Empower meets the requirements of ERISA Section 103(a)3(C). Certain information in the accompanying financial statements, notes to the financial statement, and Schedule H, Line 4i – Schedule of Assets (Held at end of year) and supplemental schedule, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower. The information certified included total investments of \$302,671, at December 31, 2024 and related investment loss of \$1,377 for the period ended December 31, 2024.

(G) FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits, except for the fully benefit-responsive investment contract, which is reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The "Fair Value Measurements and Disclosures" Topic of the FASB ASC establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist mostly of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring use of Level 3 inputs for the periods presented.

Mutual funds - The fair value of the mutual funds or shares of registered investment companies are valued at the NAV of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.

(H) INVESTMENT CONTRACT WITH INSURANCE COMPANY

As described in Note (B), through an investment contract, the Plan currently offers a fixed annuity investment contract as an investment option. The objective of this investment is to maintain a competitive fixed interest rate. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The fund is invested in the general asset account of Empower. The contract has certain restrictions that impact the participants' ability to collect the full contract value.

Because the fund is fully benefit-responsive, it is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the fund to transact at contract value. Such events include, but may not be limited to, the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs; (3) Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations; (4) The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC. The Company does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

(I) RELATED PARTY TRANSACTIONS

The Plan invests in shares of mutual funds and a fixed annuity investment contract managed by an affiliate of Empower. Empower is the custodian as defined by the plan, and, therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules. In addition, Plan expenses for Empower administrative fees also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(J) LATE REMITTANCE OF PARTICIPANT CONTRIBUTIONS

During the period ended December 31, 2024, the Company did not remit certain participant contributions to the Plan within the time frame required by the DOL's regulations. These regulations state that such amounts become Plan assets as of the earliest date they can reasonably be segregated from the Company's general assets.

The total amount of participant contributions that were remitted late during the year was \$6,294. As of the date the financial statements were available to be issued, these delinquent amounts had been remitted to the Plan, including lost earnings for some, while the remaining unremitted amounts of lost earnings were in the process of being corrected. The Company intends to file Form 5330 with the IRS and pay any applicable excise tax associated with these late remittances.
