Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of OBI Retiree Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of OBI Retiree Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section.

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of OBI Retiree Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United State of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United State of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United State of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of OBI Retiree Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established January 1, 2006, is a defined contribution health and welfare plan covering certain eligible retirees of One Beacon Insurance Company ("OneBeacon") and certain affiliates. Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust, which was established under Section 501(c)(9) of the Internal Revenue Code (Code). The Plan is sponsored and administered by the OBI Retiree Voluntary Employee Benefit Association (Plan Sponsor). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan management appointed AmWINS Group Benefits LLC (AmWINS) as the third-party administrator, HealthEquity Inc. as the claims and retiree medical account administrator and PNC Bank National Association (PNC) as a trustee.

Eligibility

Eligible retirees of OneBeacon and certain affiliates consist of the following:

- Retirees of Commercial Union (OneBeacon's predecessor company) who retired prior to December 31, 1980, and eligible retirees of Hawkeye Security Insurance Company, as defined by the Plan, and their dependents. These retirees are not eligible for a retiree medical account ("RMA") and are referred to as Zero Contributors.
- Retirees of OneBeacon who retired on or prior to January 1, 2006, and retirees of Hawkeye Security Insurance Company, as defined by the Plan, who were receiving a subsidy as of both October 15, 2005, and December 31, 2005, and their eligible dependents, as defined by the Plan. These retirees are eligible for an RMA.
- Retirees of Hawkeye Security Insurance Company who retired prior to September 16, 1988, as defined by the Plan, who were not receiving a subsidy as of both October 15, 2005, and December 31, 2005, and who elected in December 2005, to receive an RMA. These retirees are eligible for an RMA.

Active employees of OneBeacon who were at least age 50 with 15 years of service on June 1, 2003, and who retire after age 55. These retirees are eligible for an RMA.

Initial Plan Funding

OneBeacon sponsored a retiree health plan (the "OneBeacon Plan") under which retiree health benefits were offered to certain eligible retirees of OneBeacon and certain affiliates. The OneBeacon Plan was terminated by OneBeacon effective December 31, 2005. In connection therewith, OneBeacon agreed to contribute an amount to the OBI Retiree Medical VEBA trust, a trust established under Internal Revenue Code section 501(c)(9), in connection with a separate Plan that is not sponsored by OneBeacon. The amounts contributed by OneBeacon were intended to assist in the funding of benefits under the Plan for certain retirees who were participants under the OneBeacon Plan when it was terminated and certain OneBeacon employees who would have become eligible for same benefits under the OneBeacon Plan had that plan not been terminated. OneBeacon's sole role with respect to the Plan has been to facilitate the transition from the OneBeacon Plan. OneBeacon had contributed an amount calculated to fund benefits under the Plan, and no further contributions by OneBeacon will be made in the future.

The Plan administrator purchased a fixed annuity to fund the coverage associated for the Zero Contributors. Commencing on January 1, 2006, the fixed annuity provides for monthly payments during the Zero Contributors' lifetime on the first day of the month. The fixed annuity is held by the Plan administrator. Each year on January 1st, the annuity payment will increase by 7.00%. The monthly payments for the Zero Contributors are discontinued upon the Zero Contributors' death. For the year ended December 31, 2024, the fixed annuity payments is \$78,273 and is included on the statement of changes in net assets available for benefits (modified cash basis).

Retiree Medical, Dental and Prescription Drug Benefits

The Plan provides insured medical, dental and prescription drug benefits to eligible participants, as defined by the Plan. The Plan provides funded health care reimbursement accounts to eligible participants, as defined by the Plan.

Participant Administrative Fees

The Plan collects a monthly membership fee from participants to offset administrative expenses of the Plan. The monthly fee charged to each participant for the year ending December 31, 2024 was \$10.

Participant Retiree Medical Benefits Account

Each eligible participant's RMA is credited with an allocation of the original contribution as defined by the Plan. Allocations are based upon the participant's age and years of service, as defined in the Plan agreement. There is no allocation of Plan earnings (losses) and administrative expenses to participant's RMAs.

Forfeitures

RMA is available for reimbursement throughout the lifetime of the participant and his or her surviving spouse, if any. If any balance remains in the RMA upon the participant's death and his or her spouse's death, the balance is forfeited and held by the plan to pay expense.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under that basis, certain additions are recognized when received and certain deductions are recognized when paid. Investments are stated at fair value. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America primarily because the effects of annuities, outstanding contributions, accrued income and outstanding expenses are not included in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest and annuity income are recorded on the cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Plan expenses of maintaining the Plan are paid directly by the Plan. The administrative expenses on the statement of changes in net assets available for benefits (modified cash basis) primarily represent trustee, administrator, account, and investment fees. Certain investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect Plan balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

PNC Bank National Association (PNC), the trustee has supplied the Plan administrator with certifications as to the completeness and accuracy of the investments, interest income and net depreciation in the fair value of investments reflected on the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the supplemental schedules of assets (held at end of year) and reportable transaction as of and for the year ended December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Modified cash basis of accounting establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Money Market Funds: Money Market funds are valued at the quoted price of shares held by the Plan at year-end.

U.S. Government Securities - U.S. Government securities are valued at the closing price reported in the active market in which the individual securities are traded.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 DEPOSITS

The RMA and claims administrator requires a minimum deposit equal to a defined percentage of the estimated benefit costs. Estimated benefit cost is based on an estimate of the aggregate annual elections of all RMA participants. The cash deposit was \$51,299 at December 31, 2024 and 2023.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by PNC, the trustee as defined by the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Other parties-in-interest include third-party administrator, RMA and claims administrator, trustees and professional service firms who provide services to the Plan. Administrative expenses paid by the Plan to parties-in-interest totaled \$100,051 for the year ended December 31, 2024.

NOTE 7 PLAN TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated September 18, 2006, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Modified cash basis requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.
