## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Mumford Companies 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Mumford Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from the qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**MUMFORD COMPANIES 401(k) PLAN****NOTES TO THE FINANCIAL STATEMENTS****NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Mumford Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General and Eligibility.** The Plan is a multiple-employer defined contribution plan sponsored by Advance Die Cast, LLC, Aluminum Foundry of Wisconsin, LLC, Colonial Brick Company, Inc., Contractors Access Equipment, Inc., Contractors Access Equipment – Dallas, Inc., Contractors Access Equipment – Jackson, Inc. (d/b/a Direct Scaffold Services), Contractors Access Equipment – Tampa, Inc., Michigan Die Casting, LLC, New Expert Foundry Services (d/b/a Expert Cores of Wisconsin), and RePave, LLC (collectively the “Employer”), affiliates through common ownership, for their employees. In 2025, Aluminum Foundry of Wisconsin, LLC was sold and employees at the entity are no longer eligible to participate in the Plan after the sale.

Employees are eligible to participate upon completing 90 days of service and reaching 18 years of age. Employees may enter the Plan on the first day of the Plan year or the first day of the fourth, seventh, or tenth month of the Plan year subsequent to meeting the eligibility requirements above. Union employees, leased employees, and nonresident aliens are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**Contributions.** Participants may contribute up to 100% of eligible compensation on a pre-tax and/or Roth basis within certain specified limitations imposed by the Internal Revenue Code (the “Code”). Contributions are limited in accordance with Internal Revenue Service (“IRS”) regulations. Participants may also contribute rollover amounts representing distributions from other qualified defined-benefit or defined-contributions plans.

The Plan permits Employer discretionary matching contributions. The amount of the Employer matching contribution, if any, will be determined by the Employer’ Board of Directors.

During the year ended December 31, 2024, participants who were employed by Advance Die Cast, LLC, Aluminum Foundry of Wisconsin, LLC, Colonial Brick Company, Inc., Contractors Access Equipment, Inc., Contractors Access Equipment – Dallas, Inc., Contractors Access Equipment – Tampa, Inc., and Contractors Access Equipment – Jackson, Inc. (d/b/a Direct Scaffold Services), Michigan Die Casting, LLC, and New Expert Foundry Services received an Employer matching contribution equal to 50% of the participant’s contributions, up to 6% of the participant’s eligible compensation. Participants who were employed by RePave did not receive an Employer matching contribution for the year ended December 31, 2024.

In addition, the Employer may make an annual discretionary profit-sharing contribution in an amount to be determined by the Employer’ Board of Directors. A participant must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible for Employer profit-sharing contributions. There were no Employer discretionary profit sharing contributions elected for the year ended December 31, 2024.

In no event shall the contributions credited to a participant’s account for any Plan year, either separately or when combined with Employer contributions, exceed the allowable deductions for federal income tax purposes.

**Participant Accounts.** Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Employer discretionary contributions, an allocation of investment earnings, and is charged with an allocation of Plan expenses. The benefit to which a participant is entitled is the vested benefit in the participant’s account.

## NOTE 1 – DESCRIPTION OF PLAN (Concluded)

**Vesting.** Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the Employer contributions is based on years of continuous service. Participants, except as noted below, vest in their Employer contributions and earnings thereon in accordance with the following table:

**Investment Options.** Participants direct the investment of their contributions into various investment options offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan provisions.

**Forfeited Accounts.** Forfeited balances of terminated participants are used to offset the amount of future Employer contributions as well as pay Plan expenses. Forfeited non-vested accounts totaled approximately \$134,745 and \$91,997 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to pay Plan expenses.

**Payment of Benefits.** The Plan provides for normal retirement at age 59.5 and does not provide for early retirement. On termination of service due to death, disability and/or retirement, a participant may receive a lump-sum payment. Upon separation from service, participants or their beneficiaries may elect to have their normal retirement benefits paid as a single lump sum payment. Accrued vested benefits less than \$5,000 may be distributed at any time after such termination.

Under certain circumstances such as for purchase of a principal residence, post-secondary education expenses, and with the consent of the Plan's administrator ("Plan Administrator"), a distribution of vested benefits may be made in the event of hardship.

**Concentration of Credit Risk.** Substantially all the Plan's assets are held by Fidelity Management Trust Company ("Fidelity"). Fidelity is referred to herein as the "Trustee" and is a qualified institution pursuant to ERISA.

**Party-In-Interest Transactions.** Custodian and recordkeeping fees were paid by the Plan. Additionally, various administrative, legal, and accounting services are performed by the Employer's personnel on behalf of the Plan for which no charges are made to the Plan. Investment expenses, however, are charged against the Plan's investment income. These transactions qualify as party-in-interest transactions.

**Recent Legislation.** In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The IRS has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

**MUMFORD COMPANIES 401(k) PLAN****NOTES TO THE FINANCIAL STATEMENTS****NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The accompanying financial statements have been prepared on the accrual method of accounting.

**Estimates and Assumptions.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

**Investment Valuation and Income Recognition.** Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefits are recorded when paid.

**Administrative Costs.** All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Employer. The Plan’s participants are liable for all administrative expenses that are not paid by the Employer.

**Expense Offset Arrangements.** Certain fees incurred by the Plan for investment management services and recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN ASSETS**

## NOTE 4 – FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Pooled Separate Accounts.** Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Common Collective Trust Funds.** Valued at the NAV of the units held by the Plan. The funds invest in fully benefit-responsive investment contracts that are held at contract value. NAV is determined to be contract value, the value at which participants ordinarily transact. The NAV is used as a practical expedient as described under pooled separate accounts. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Investments Measured Using the Net Asset Value per Share Practical Expedient.** The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively.

## NOTE 5 – PLAN TERMINATION

Although the Employer has not expressed any intent to discontinue contributions or terminate the Plan, it is free to do so at any time, subject to the provisions of ERISA and the Plan document. In the event of Plan termination, participants will become fully vested in all of their accounts and the Plan will distribute participant assets.

**MUMFORD COMPANIES 401(k) PLAN****NOTES TO THE FINANCIAL STATEMENTS****NOTE 6 – RELATED-PARTY TRANSACTIONS**

Certain Plan investments are units of pooled separate accounts and an insurance company general account managed by an affiliated company of the Trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee amounted to \$5,508 for the year ended December 31, 2024.

**NOTE 7 – TAX STATUS**

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Code. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for investing in numerous funds, which invest in various types of investment securities and in various companies within various markets. Investment securities, generally, are exposed to several risks, such as interest rate, market, and credit risks. Due to the level risk associated with the funds, it is reasonably possible that changes in the values of the funds will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

**NOTE 9 – DELINQUENT REMITTANCES**

During the years ended December 31, 2024, 2023, and 2022, the Employer failed to deposit participant contributions totaling \$70,697, \$299,628 and \$153,190, respectively, to the Plan timely. Management has not made the required corrections as of the date the accompanying financial statements were available to be issued.

**NOTE 10 – SUBSEQUENT EVENTS**

Management has evaluated all known subsequent events from December 31, 2024 through October 14, 2025, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
