## INDEPENDENT AUDITOR'S REPORT

To the Plan Committee

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Macias Gini & O'Connell LLP 401(k) Profit Sharing Plan (the "Plan") an employee benefit plan, subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

The supplemental schedules of delinquent participant contributions and assets held at end of year as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or are derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Macias Gini & O'Connell LLP 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established January 1, 1995, to provide benefits for employees of Macias Gini & O'Connell LLP (the "Plan Sponsor") and the employees' beneficiaries. The Plan is a defined contribution plan covering all eligible employees who have attained the age of twenty-one (21) years and have completed thirty (30) days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Fidelity Management Trust Company serves as the Plan's trustee.

**Plan Year**

The Plan year begins January 1<sup>st</sup> and ends December 31<sup>st</sup>.

**Contributions**

The Plan allows for the following types of contributions:

- *Employee Salary Deferral 401(k) Contributions*  
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Upon eligibility, employees are automatically enrolled into the Plan. The automatic enrollment contribution is 5%; however, participants may contribute from 1% to 100% of their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code or they may choose to opt out of the automatic enrollment. The Plan allows for both pre-tax and after-tax Roth contributions.
- *Discretionary Employer Matching Contributions*  
The Plan Sponsor may make a matching contribution equal to a discretionary amount. Participants must be employed on the last day of the Plan year with 1,000 hours of service to be eligible for the contribution. The Plan Sponsor elected to make a matching contribution equal to 50% of participant deferrals up to 4% of eligible compensation for the year ended December 31, 2024, and up to 2.5% of eligible compensation for the year ended December 31, 2023.
- *Discretionary Non-Elective Employer Contributions*  
The Plan Sponsor may make a non-elective contribution equal to a discretionary amount. Participants must be employed on the last day of the plan year with 1,000 hours of service to be eligible for the contribution. The Plan Sponsor made no non-elective contributions during 2024 and 2023.
- *Employee Rollover Contributions*  
Participants may make rollover contributions from other qualified plans.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

**Participant Accounts and Allocations**

Each participant's account is credited with the participant's contributions, employer contributions, rollover contributions, an allocation of Plan earnings (losses), and an allocation of certain Plan expenses, as defined by the Plan document. The Plan allows participants to self-direct their account balances and contributions among various investment options. The yield (interest, dividends, and net realized and unrealized gains and losses) on participant elected investments is allocated to each participant's account based on each participant's pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are always 100% vested in their elective deferral, rollover, non-elective employer contributions, and investment gains and losses credited thereon. Employer matching contributions and gains/losses credited thereon vest as follows:

Less than 2 years service	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

For vesting purposes, a year of service is determined using the elapsed-time method.

Additionally, a participant's interest in their respective account becomes 100% vested when the employee (a) attains age 65 while employed by the Plan Sponsor, (b) becomes disabled while employed by the Plan Sponsor, or (c) dies while employed by the Plan Sponsor.

**Forfeitures**

Forfeitures from non-vested portions of employer contributions may be used to pay for plan expenses or reduce employer contributions. Forfeiture amounts totaling \$191,620 and \$95,128 were available for the reduction of employer contributions at December 31, 2024, and 2023, respectively. Forfeiture amounts totaling \$191,620 and \$95,128 were used to reduce 2024 and 2023 employer contributions, respectively.

**Retirement**

Normal retirement age under the Plan is sixty-five (65) years of age.

**Payment of Benefits**

Participants may begin receiving benefits in the year following the attainment of age 59½. On termination of service due to death, disability or normal retirement, a participant may elect to receive a lump-sum amount or partial withdrawals or installments over a period of time not to exceed the participant's or beneficiary's assumed life expectancies. Participants qualifying under "hardship" rules may elect to receive all or a portion of their vested account balance prior to termination or retirement. Participants' vested accounts that do not exceed \$5,000 are distributed upon severance of employment. Effective January 1, 2024, participants' vested accounts that do not exceed \$7,000 are distributed upon severance of employment. Refunds of excess contributions generally represent the distribution of certain assets to employees in order for the Plan to comply with nondiscrimination rules in the Code.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

**Notes Receivable from Participants**

The Plan allows for participants to borrow from their accounts. Loans may not exceed \$50,000 or 50% of the vested account balance. There is no minimum borrowing amount for any loan. The term of the loan shall be limited to 5 years except for loans specified for the purchase of a principal residence. Principal and interest are repaid ratably through payroll deductions and are secured by the balance in the participant's account.

**Administrative Expenses**

Administrative expenses of the Plan are paid for by the Plan and/or Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

**Basis of Accounting**

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

Investments in mutual funds are stated at fair value based on quoted market prices. The net asset value is used as a practical expedient to estimate fair value of common collective trusts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Changes in the unit values of investments are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan has adopted a prototype plan which has obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)**

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 3: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

**NOTE 4: INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The following amounts are included in these financial statements and were taken directly from statements provided and certified as complete and accurate by the Plan's trustee, Fidelity Management Trust Company, as of and for the years ended December 31, 2024, and 2023:

**NOTE 6: FAIR VALUE MEASUREMENTS**

FASB ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 6: FAIR VALUE MEASUREMENTS (Continued)**

*Common collective trusts:* Stable value funds that are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts in the statement of net assets available for Plan benefits.

**NOTE 8: PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Plan assets as of December 31, 2024, and 2023 include notes receivable from participants and mutual funds issued by the trustee. Fees paid by the Plan for investment management services are recorded in net appreciation in fair value of investments. Fees for certain expenses related to the administration of the Plan were paid by the Plan and the Plan Sponsor. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 9: PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Plan Sponsor failed to remit certain participant contributions to the Plan in a timely manner, as defined by ERISA, in the amount of \$49.

**NOTE 10: SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued, and management has determined that no subsequent events have occurred that should be disclosed.
