We have performed audits of the financial statements of The LETCO Group, LLC 401(k) Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

**Note 1. Description of the Plan**

The following description of The LETCO Group, LLC 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by The LETCO Group, LLC (Company) for the benefit of substantially all its employees who do not meet the criteria of an excluded employee. Participants are eligible to participate in the Plan once they are age 18 and complete three months of service. Entry date is the first day of the month coinciding with or next following the date requirements are met. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective April 20, 2023, the Plan's trustee and record-keeper is John Hancock Trust Company, LLC (John Hancock). Prior to April 20, 2023, the Plan's trustee was Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal).

**Contributions**

The Plan permits eligible employees through a pre-tax or Roth deferral election to have the plan sponsor make annual contributions of up to 100% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The plan sponsor may elect to make a discretionary matching contribution to the Plan. For 2024 and 2023, the discretionary matching contribution is equal to 50% of employees' salary deferral amounts, including catch-up contributions up to 5%. Contributions are subject to certain limitations.

**Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan at 6% of eligible compensation, unless they affirmatively elect not to participate in the Plan. The plan document also includes an automatic increase feature whereby the deferral rate is increased each plan year by 1% up to a maximum of 10% of eligible compensation, unless the participant elects otherwise.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the plan sponsor's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the plan sponsor's contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after three years of service.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their vested interest in their account in the form of a lump-sum distribution or installments. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,951 and \$15,656, respectively. There were no forfeitures used to reduce Company contributions or pay administrative expenses for the years ended December 31, 2024 and 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust fund is valued based on information reported by the investment advisor using the audited financial statements of the collective trust fund at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the plan sponsor or the Plan at the plan sponsor's discretion.

**Note 3. Certification of Plan Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal and John Hancock, the trustees of the Plan, have certified the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by Principal and John Hancock, which are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The plan sponsor pays directly any fees related to the Plan's operations.

The Plan paid \$27,347 and \$23,919 of record-keeping fees to the trustees during December 31, 2024 and 2023, respectively. The plan sponsor provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities held by the Plan include a collective trust fund. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 securities held by the Plan during 2024 or 2023.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved retirement plan and trust/custodial document sponsored by John Hancock Retirement Plan Services LLC and Principal Life Insurance Company. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Black Out Period**

Effective April 20, 2023, the Plan was amended and restated (Plan Amendment) and John Hancock became the new trustee and administrator over the Plan. Plan assets transferred to John Hancock were transferred into funds comparable to those offered by the previous trustee, Principal. The conversion initiated a “Black Out” period beginning April 24, 2023 and continued through June 11, 2023. During this period, funds could not be applied to the employee-selected funds with John Hancock or withdrawn from the Plan until John Hancock had time to accurately complete the conversion.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 10. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the plan sponsor's general assets, but no later than the 15<sup>th</sup> business day of the month following the month in which the employee contributions are withheld by the plan sponsor. The plan sponsor has deemed \$16,783 as delinquent employee contributions as of December 31, 2023. The plan sponsor has remitted all funds to John Hancock and is in the process of calculating and remitting lost earnings.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
