Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Source4 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. December 31, 2024

Note 1 – Plan Description

The following description of the Source4 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Dominion Solutions, Inc., its parent company Dominion Holdings, Inc., and subsidiaries (the “Company”) who have three months of service and who are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In October 2024, the Company acquired Piedmont Direct Mail, Inc. The Plan was amended to allow employees previously employed by Piedmont Direct Mail, Inc. to participate in the Plan.

Contributions

Each year, participants may contribute from 1% to 100% of their compensation as defined in the Plan, up to the maximum dollar amount allowed by the Internal Revenue Service (IRS). The Plan permits catch-up contributions to be made by participants who have attained age 50 before the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. The Company’s match is discretionary. The Company elected to match 50% of deferrals up to 3% of plan compensation starting in July 2023 until June 2024. Starting in July 2024, the Company elected to match 50% of deferrals up to 4% of Plan compensation. Additional profit-sharing amounts may also be contributed at the option of the Company’s board of directors. Participants direct the investment of their contributions, matching Company contributions, and any additional profit-sharing amounts into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their employee and employer accounts. See “Forfeitures” for further discussion.

Notes from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms range from one to five years unless the note is for the purchase of a primary residence, in which case the term may exceed five years. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 2%. At December 31, 2024, interest rates ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reason, a participant may elect to receive retirement benefits as partial payments, installment payments, or a lump-sum distribution which may be either rolled over to an IRA or another qualified plan or paid directly to them. Distributions are paid as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company on a discretionary basis. Substantially all such expenses were paid by the Company.

Forfeitures

Forfeitures are no longer applicable to the Plan as a result of immediate vesting. Forfeited balances of previously terminated participants' non-vested matching accounts are available for reallocation to participant accounts after paying Plan expenses. Forfeitures of \$62 and \$1,509 were used to pay plan expenses in 2024 and 2023, respectively. Forfeited balances of previously terminated participants' non-vested profit-sharing accounts are available to reduce future employer contributions to the Plan. The balance in the forfeiture account at December 31, 2024 and 2023 was \$108 and \$1,634, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Benefit Payments

Benefit payments are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Note 4 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Certain Plan investments were shares of mutual funds managed by Merrill Lynch (former investment advisor), an affiliated company of Ascensus Trust Company, and its affiliate, BlackRock. Ascensus Trust Company is the Trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Pinnacle Bank, the current investment advisor, is also a party-in-interest. Fees paid by the Plan for administrative services amounted to \$44,781 for the year ended December 31, 2024.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 6 – Tax Status

The Plan was adopted under a prototype plan sponsored by Ascensus, LLC. The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes the Plan and its underlying trust are currently designed and are being operated in compliance with the applicable provisions of the *IRC*.
