Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of Plan

The following description of P & L Global Holding Corp 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 1996, and amended and restated on April 15, 2021, is a 401(k) profit sharing plan with a safe harbor matching contribution formula covering eligible employees of P & L Global Holding Corp., PLD Acquisitions LLC, P & L Development LLC, and PLDM Operating Co., LLC (collectively, the “Company”). Each employee who has attained the age of 21 with six months of service, and is not leased, is not covered by a collective bargaining agreement, is eligible to participate in the Plan. An employee’s entry date into the Plan is the first day of the first, fourth, seventh, and tenth month of the Plan year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

Participant Salary Deferral

Participants in the Plan may contribute a discretionary amount of their annual eligible compensation (not including bonus, commission, and post-severance compensation) provided that the participant’s contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each calendar year, which is \$23,000 for the year ended December 31, 2024. Employees over the age of 50 can elect to contribute an additional \$7,500 for year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer Safe Harbor Contributions

The Company has elected to make safe harbor employer contributions to the Plan. The amount of the safe harbor matching contribution will vary depending upon the percentage of the employee’s compensation that they contribute to the Plan as a deferral. The matching contributions are in an amount equal to the elective deferrals that do not exceed 3% of the participants’ compensation for the Plan year, plus 50% of the participants’ elective deferrals that do exceed 3% of compensation for the Plan year and cannot exceed 5% of compensation.

Employer Discretionary Profit-Sharing Contributions

The Company may make discretionary profit-sharing contributions to participants. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their voluntary and safe harbor contributions plus actual earnings thereon. Participants vest in the Company’s profit-sharing contributions plus actual earnings thereon based on the following schedule:

Participant Accounts

Individual participant accounts are credited with applicable participant contributions, an allocation of the Company's contributions, and investment earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of his account. Forfeitures attributable to employer profit sharing contributions are used to reduce employer contributions. There were no forfeitures used for the year ended December 31, 2024. The unallocated forfeiture balance at December 31, 2024 and 2023, amounted to \$583 and \$491.

Investment Options

Participants may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis.

Distributions

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59½, (ii) termination of employment, (iii) death or permanent disability, and (iv) a proven hardship. Distributions from a participant's account are made in the form of a lump-sum payment or partial payments. If a terminated participant's account balance does not exceed \$5,000, the balance may be distributed to a terminated participant without consent.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balances. In general, the Plan administrator may permit participants to borrow from their fund accounts a minimum of \$1,000. A participant may have only one loan outstanding at any time.

Loans are secured by the balance in the participant's account and bear interest at an interest rate determined by the Plan administrator based on the prime rate (rates ranged from 3.25% to 8.50% per annum). Loans shall be repaid over a period of up to five years unless the loan is for the purchase of a primary residence for which the Plan administrator will offer extended repayment options. Loans are repaid through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments, which consists of realized gains or losses and unrealized appreciation on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of the Plan's income and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document.

Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company ("Ascensus"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with an appropriate agency and has obtained a favorable opinion letter dated June 30, 2020 from the IRS stating that the plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has been amended since issuance of the opinion letter.

However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely- than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more of such an employer or employee association or relatives of such persons.

The Company administers the Plan from its office. Certain Plan investments are managed by Ascensus. Ascensus is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$108,775 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event that the Plan and the related trust terminate, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts, and the account balances will be distributed in full to participants.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1: Quoted prices in active markets for identical assets or liabilities.

Level 2: Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments at December 31, 2024 and 2023.
