Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Kewa Pueblo Health Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's responsibilities for the Audit of the Financial Statements section:

NOTE 1. Description of Plan

The following description of Kewa Pueblo Health Corporation 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established June 1, 2013. The Plan covers all employees of Kewa Pueblo Health Corporation (the Employer) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan management is responsible for oversight of the Plan. The Employer determines the appropriateness of the Plan's investment offerings, monitors investment performance, and serves as the Plan administrator. As of December 31, 2023, there were 222 participants in the Plan, 189 of whom have account balances.

Contributions

Each year, participants may contribute up to 100% of annual pre-tax basis compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

For 2024, the Employer made a nondiscretionary contribution of 100% of the first 5% of the participant's compensation. Additional profit sharing amounts may be contributed at the option of the Board and management. For the year ended December 31, 2024, the Employer did not approve a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Employer contributions and an allocation of the Plan's earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 not to exceed 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% percent above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 25% vested after 1 year of credited service and 100% vested after 2 years of credited service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$220 and \$0, respectively. These accounts will be used to reduce future Employer contributions or to pay Plan administrative expenses.

During 2024, \$33,338 was allocated to participant accounts from forfeited nonvested accounts to reduce employer contributions and \$16,038 was used to reduce administrative expenses, in accordance with Plan provisions.

Payment of Benefits

Benefits are payable in the event of hardship as defined, retirement, death, disability, attainment of age 59½, or termination of employment, and are paid in a lump sum.

Mandatory Cash-Out Provision

If the amount of the participant's vested account balance to be distributed exceeds \$1,000 but is less than or equal to \$5,000 and the participant fails to elect a lump sum payment or direct rollover, the Plan administrator will roll the entire vested balance to an IRA. Account balances of less than \$1,000 will be distributed as a lump-sum amount without the consent of the participant.

NOTE 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are on the accrual basis of accounting based on the accounting standards as promulgated by the Governmental Accounting Standards Board.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the respective year.

Risk and Uncertainties

The Plan invests in a variety of investment funds as directed by participants. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses is needed as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the Employer may elect for the Plan to pay administration costs. The Employer paid a portion of Plan administrative expenses for the year ended December 31, 2024, which are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 14, 2025, the date which the financial statements were available to be issued.

NOTE 3. Investments and Fair Value Measurements

Governmental Accounting Standards Board (GASB) issued Statement No. 72, Fair Value Measurements and Applications, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1— Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2— Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds are required to publish their daily net asset value (NAV) and to transact at that price.
- *Pooled Separate Accounts (PSA)* – Valued based on unit values reported by the Plan trustee, which is principally the market value of the underlying investments, but the PSA net asset value (NAV) per unit is not a publicly quoted price. Assets measured using net asset value as a practical expedient are not assigned a level in the fair value hierarchy.
- *Collective Investment Trust* – The collective investment trust (CIT) invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective investment trust and the separate accounts are not publicly quoted pricing inputs. The fair value of all these investments are used in determining the net asset value (NAV) of the CIT, which is not publicly quoted. Assets measured using net asset value as a practical expedient are not assigned a level in the fair value hierarchy.

NOTE 4. Information Prepared and Certified by Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants reflected on the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets held at end of year as of December 31, 2024.

NOTE 5. Plan Termination

Although it has not expressed any intention to do so, the Employer may terminate the Plan for any reason, subject to the provisions of ERISA. Unless the Employer was to transfer the trust fund to another trust or fund, account balances would be distributed to participants in cash or in purchased annuities. In the event of Plan termination, participants will become 100% vested in all their accounts.

NOTE 6. Tax Status

The Plan adopted a volume Submitter Profit Sharing Plan with CODA. The volume submitter plan received an IRS opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management does not believe that the Plan has taken any uncertain tax positions as of December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 7. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by Principal Life Insurance Company, the Trustee of the Plan's Investments. These transactions qualify as exempt party-in-interest transactions. The Employer provides certain accounting and administrative services to the Plan for which no fees are charged. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

For the year ended December 31, 2024, fees paid by the Plan for administrative expenses, such as third-party administrative fees, totaled \$57,538.
