**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan of Taconic Innovations, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan was effective on June 1, 2006, and subsequently amended (the latest amendment was December 31, 2010).

**A. General**

The Plan is a defined contribution plan covering substantially all employees of Taconic Innovations, Inc. (the "Organization" or "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**B. Eligibility and Service Rules for Participation**

All employees are eligible to participate in the Plan and make salary reduction contributions upon hire. However, employees must be at least 21 years of age and complete two years of service to receive employer-based contributions under the Plan.

**C. Contributions**

Each year, participants may contribute up to the maximum allowed by law of annual pretax compensation, as defined in the Plan. Participants who attained age 50 before the plan yearend are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently provides multiple mutual funds and an insurance investment contract as investment options for participants. The Plan accepts rollover contributions. Contributions to the Plan are subject to certain limitations.

Each Participant who has satisfied the age and service requirements shall be entitled to receive an allocation equal to his pro-rata share of any employer-based contribution made for the plan year, whether or not he has made a salary reduction contribution. Each Participant's pro-rata share for a plan year shall be determined by multiplying any employer-based contribution made for the year by a fraction (the number of which is the Participant's compensation received during the plan year and the denominator of which is the total compensation of eligible participants). The employer-based contribution is discretionary. Therefore, the employer shall have the sole discretionary right to determine the amount of any employer-based contribution made for a plan year.

For the year ended December 31, 2024, participant contributions totaled \$293,392 and employer-based contributions totaled \$48,699.

**D. Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**E. Vesting**

A participant is 100% vested in their contributions plus actual earnings thereon. The amounts in a Participant's Employer contribution account shall be 100% vested immediately.

**F. Forfeitures**

Forfeitures are created when participants terminate employment before being entitled to their full benefits under the Plan. Forfeitures are used to reduce future employer contributions. For the year ended December 31, 2024, there were no forfeitures.

**G. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments over ten years. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Benefits are recorded when paid.

**H. Participant Loans**

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Defaults in loans are treated as a distribution at the time of default against the Participant's account.

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of their vested balance or \$50,000 (whichever is less). Loans to the Participant are made directly from Mutual of America Life Insurance Company. The Participant's account is not reduced by the loan amount but serves as security for the loan. The loan amount is moved into a fixed income collateral account within the borrower's account. Within five years, the loan must be repaid directly to Mutual of America Life Insurance Company in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due per the schedule outlined in the promissory note or other writing permitted by applicable law representing the loan, the loan will be deemed in default.

On December 31, 2024, and 2023, total principal balances due amounted to \$143,748 and \$147,642, respectively, representing collateralization of participant accounts. As of December 31, 2024 and 2023, there were no defaulted loans. The interest rates on these loans ranged from 4.60% to 5.85%, with maturities through 2031.

**I. Expenses**

Certain expenses of maintaining the Plan are paid by the Organization and are excluded from these financial statements. Expenses paid by the Plan's participants consist of investment advisory services and transactional processing fees. Investment-related costs are included in net appreciation in the value of investments.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting and Use of Estimates**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**B. Investment Valuation and Income Recognition**

All of the Plan's investments are stated at fair value, except for the mutual interest accumulation account, which is stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. The mutual funds are open-ended and registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The funds valued at contract value represent contributions made under the contract, plus interest credited, less withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes Plan's gains and losses on investments bought and sold as well as held during the year.

**C. Payment of Benefits**

Payment of benefits is recorded when paid.

**D. Subsequent Events Evaluation by Management**

Management has evaluated subsequent events for disclosure and recognition in the financial statement through October 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 – INVESTMENTS INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE**

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information contained in the supplemental schedule was certified as complete and accurate by Mutual of America ("Mutual"), as Plan's custodian and was not subject to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

Mutual has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan follows U.S. GAAP guidance on Fair Value Measurements, which defines fair value and establishes a fair value hierarchy organized into three levels based on the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets, which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are observable and are used to the extent that observable inputs do not exist.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual of America Interest Accumulation Account**

The Mutual of America Interest Accumulation Account is credited with interest at a rate determined by Mutual of America. Mutual of America reserves the right to change the interest rate applicable to amounts held in the interest accumulation account at its discretion. If funds are transferred to another funding vehicle or investment, they may be subject to market value adjustments. The interest Accumulation account is carried at contract value.

**Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. We evaluated the significance of transfers between levels based on the nature of the financial instrument and the size of the transfer relative to total net assets available for benefits. There were no transfers for the years ended December 31, 2024 and 2023.

Mutual funds carried at fair value as December 31, 2024 and 2023 were classified as Level 1 and amounted to \$2,780,901 and 2,063,651, respectively.

**NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are managed by Mutual of America. Mutual of America is the Custodian defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. The sponsor paid certain fees relating to administrative expenses outside of the Plan.

Participants who are active employees may borrow from their accounts, and such loans qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Employer who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

Fees incurred by the Plan for investment management services are reflected as administrative fees in the accompanying financial statements and amounted to approximately \$527 for the year ended December 31, 2024.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their employer contributions.

**NOTE 7 - TAX STATUS**

The Plan has adopted an approved prototype plan document which received Internal Revenue Service ("IRS") approval. The Employer believes that the Plan is designed and operating according to applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to multiple risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statement of net assets available for benefits.
