Notes to Financial Statements

(1) Description of Plan

The following description of KOREAN AIR LINES COMPANY, LTD. EMPLOYEE WELFARE PLAN (the “Plan”) provides only general information about the Plan’s provisions. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions, copies of which may be obtained from the Plan sponsor.

(a) General

The Plan provides health and other benefits to full-time employees of KOREAN AIR LINES COMPANY, LTD (the “Company”) and any part-time employees who work at least 20 hours per week and covered dependents. Certain Plan assets are held in a Voluntary Employees’ Beneficiary Association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

(b) Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of vision insurance, supplemental and dependent life insurance, and short-term or long-term disability insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, accidental death and dismemberment insurance, and stop loss insurance.

The Company makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s benefit obligations over net assets available for benefit is funded by the Company on a pay-as-you-go basis.

(c) Benefits

The Plan provides health benefits (medical, dental, vision and prescription drugs), life insurance, short-term and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

(d) Self-insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (“ASO”) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan’s VEBA trust or the general assets of the Company. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (“PBM”) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

(e) Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

(f) Insured Benefits

The Plan offers various fully insured programs that participants can choose. The Plan fully insures the vision benefits, life insurance benefits (basic and dependent), accidental death and dismemberment benefits (basic and dependent), and short-term and long-term disability benefits. Premiums for vision benefits, supplemental life insurance benefits, and short-term and long-term disability benefits are paid by participants. Premiums for all other insured are paid from the general assets of the Company.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying statements of benefit obligations and net assets available for benefits and changes in benefit obligations and net assets available for benefits have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities at the financial statement date. Accordingly, actual results may differ from those estimates.

(c) Cash

Cash consists of bank deposits. Financial instruments that potentially subject the Plan to credit risk consist primarily of cash. The Plan maintains its cash accounts with a high quality financial institution, which, at times, may exceed federally insured coverage. At December 31, 2023, the Plan has approximately \$6,000 in excess of the Federal Deposit Insurance Corporation ("FDIC") insured limits, whereas no balances exceeded the FDIC limits at December 31, 2024.

(d) Pharmacy Rebate

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a pharmacy rebate receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$312,436 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024.

(e) Payment of Benefits

Premiums paid by either participants and the Company are recorded as premium paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as benefits payable in the accompanying statements of benefit obligations and net assets available for benefits. Claims paid for medical, dental and prescription drugs are paid by the VEBA trust. These payments are recorded as claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

(f) Stop Loss

Premiums for stop loss insurance are included in premium paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

(3) Claims Incurred but not Reported

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan management based on claims data provided by the Plan's third-party claims processors. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(4) Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims processors. These expenses are reported on the statement of changes in benefit obligations and net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

(5) Tax Status

Plan assets are held in a separate non-interest bearing bank account, which under the Department of Labor rules is treated as a trust. Any income generated would be includible in the Company's taxable income. The trust obtained a favorable tax determination letter from the Internal Revenue Service ("IRS") and the plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The IRS is one of the primary tax oversight bodies of the Plan and generally has the ability to examine the Plan's tax returns for the years 2021 through 2024; however, there are currently no audits for any tax periods in progress.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

(7) Related Party Transactions

As described in Note 1 to the financial statements, the Plan has several arrangements with service providers. These transactions are party-in-interest transaction under ERISA.
