Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### (1) DESCRIPTION OF PLAN

The following description of the HOPE International 401(k) Plan (“*Plan*”) provides only general information. Participants should refer to the Plan agreement and Official Summary Plan Description for a more complete description of the Plan’s provisions.

##### A. General

The Plan is a defined contribution plan covering all employees of HOPE International (*the “Organization”*). The Plan was adopted June 1, 2016. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*). All employees of the Organization are eligible to participate in the Plan.

##### B. Contributions

Employees of the Organization may elect to contribute up to the maximum allowable elective deferral. The employee has the option to take their deferral pre-tax or as a Roth deferral. For the plan year ended December 31, 2024, the maximum allowable elective deferral was \$23,000. Participants who have attained age 50 before the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization matches each employee’s contribution up to 5% of eligible earnings to a maximum of \$5,000.

##### C. Participants Accounts

Each participant’s account is credited with the participant’s contribution, organization’s contribution, if applicable, an allocation of the Plan’s earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### D. Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. For employer matching contributions, participants are fully vested on a pro-rata basis after three years.

##### E. Investment Options

Upon enrollment in the Plan, and at any time during the plan year, a participant may direct all future contributions into any of the investment options available under the Plan.

##### F. Payment of Benefits

A participant’s vested benefits will normally be distributed to the participant or the participant’s beneficiary upon termination of service, retirement, disability or death by transfer to another qualified plan or individual retirement account, through a lump sum distribution or in installment payments.

In-service withdrawals of all or a portion of a participant’s vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant’s vested benefits are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant’s rollover account balance may be withdrawn at any time.

### **G. Participant Loans**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, excluding Roth deferrals. The loans are secured by the balance in the participant's account and bear interest at prime plus 1 %. Interest rates ranged from 8.75% to 9.50% for the year ended December 31, 2024. As of December 31, 2024, there were outstanding loan balances of \$4,215. There were no outstanding loan balances as of December 31, 2023.

### **H. Forfeited Accounts**

Forfeited non-vested accounts are used to reduce employer contributions and Plan expenses. At December 31, 2024, forfeited non-vested accounts totaled \$2,244. There were no forfeited non-vested balances as of December 31, 2023. During the year ended December 31, 2024, \$2,206 of forfeited amounts were used to reduce Plan expenses.

### **I. Administration**

The Organization is the administrator of the Plan. Ascensus, Inc., parent of Ascensus Trust Company, is the trustee of the Plan. In addition, the Chief Operating Officer, is also a trustee whose responsibility is limited to ensuring the timely deposit of contributions. Ascensus is the recordkeeper for the Plan and maintains individual participant account records and advises the Plan on other matters related to the operation of the Plan. All Plan investments are held in Vanguard investment accounts.

## **(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***USE OF ESTIMATES***

The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### ***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See **Note 4** for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### ***PAYMENT OF BENEFITS***

Benefits are recorded when it has been determined that a distribution will be made.

#### **OPERATING EXPENSES**

All expenses of the Plan may be paid from assets of the Plan, however, the Organization, in its discretion, may pay any or all of these expenses. For the year ended December 31, 2024, the Organization paid all significant costs associated with maintaining and administering the Plan.

#### **(3) INVESTMENTS**

The Plan's investments are held in a directed trust. There are several investment options available to the participants at the time of this report. Participant accounts are allocated based on the decisions of the individual participants. The following tables present the market value of these investments at December 31, which have been certified by the Plan's trustee:

#### **(4) FAIR VALUE OF FINANCIAL INSTRUMENTS**

The Plan utilized various methods to measure the fair value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.

Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan's own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

**(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(6) TAX STATUS**

The trust, established under a prototype plan to hold the Plan’s assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust’s net investment income is exempt from income taxes. Although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

The Plan has reviewed the tax positions for each of the open fiscal tax years (2021 – 2023) or expected to be taken in the Plan’s fiscal 2024 tax return and has concluded that there are not significant uncertain tax positions that would require recognition in the financial statements.

**(7) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**(8) PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative costs of the Plan are paid by the employer / sponsor.
