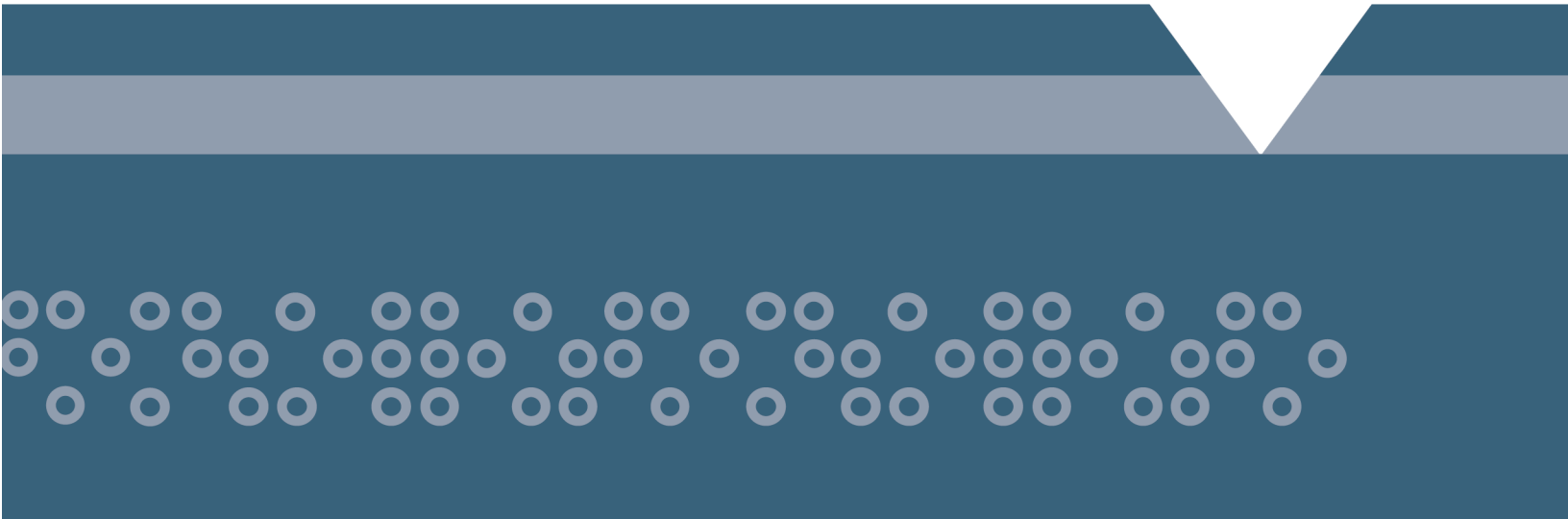

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Green Clinic Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank, or similar institution, or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter – Pending Plan Termination

As discussed in Note 8 to the financial statements, the Plan Sponsor was sold in November 2024, and the Plan is in the process of being terminated. The accompanying financial statements have been prepared on the going concern basis of accounting, as the Plan's liquidation was not considered imminent as of December 31, 2024. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Green Clinic Savings and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Green Clinic Savings and Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan covering all full-time employees of Green Clinic Management Company, L.L.C. and its entities (collectively hereinafter referred to as “the Company” or “the Plan Sponsor”) who have provided one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan allows eligible employees to accumulate funds for payment upon retirement, disability, death, or termination of employment.

(b) Eligibility

Employees of the Plan Sponsor and adopting employers are eligible to participate in the Plan on the next entry date after completing one year of service and attainment of age eighteen. Entry dates are the first day of the month coinciding with or following the date that an employee satisfies eligibility requirements. Participants are eligible for employer contributions on the first day of the month following the completion of one year of service with the Plan Sponsor.

(d) Contributions

Each year, eligible participants may contribute a portion of their compensation subject to certain maximum limitations imposed by the Internal Revenue Code of 1986, as amended (IRC). Participants who have attained the age of fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans.

The Company’s Board of Directors can also elect to make profit sharing and matching contributions to the Plan on behalf of participants. The Plan also provides for a qualified nonelective contribution by the Plan Sponsor that satisfies the provisions of safe harbor testing. This safe harbor contribution is equal to at least 3% of the compensation of participants who are not considered highly compensated employees.

(e) Participant Accounts

Each participant’s account is credited with the participant’s contributions, the employer’s safe harbor, matching, and profit-sharing contributions (if applicable), an allocation of Plan earnings, and an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(f) Vesting

Participants are immediately vested in their voluntary contributions and the Company’s safe harbor contributions, plus earnings thereon. Vesting in Company profit sharing and matching contributions plus earnings thereon is based on years of service. Participants are 100% vested after six years of service.

(g) Payment of Benefits

On termination of service due to death, disability, retirement, or upon reaching normal retirement age, a participant may elect to receive either a lump-sum amount equal to the value of the

participant's vested interest in his or her account, or annual installments over a period of not more than his or her life expectancy or the life expectancy of the last survivor in a joint and survivor election.

(h) Forfeited Accounts

Forfeitures resulting from termination distributions may be used to pay a portion of the Plan expenses or to offset future Company contributions. During the years ended December 31, 2024 and 2023, the forfeiture account balance was \$7,222 and \$20,931, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$12,908 and \$10,903 to pay for Plan expenses.

(i) Notes Receivable from Participants

Participants may borrow amounts from the Plan subject to the provisions of the Plan. Notes may be made from a minimum of \$1,000 up to a maximum of \$50,000. In addition, loans are limited to the greater of 50% of the participant's vested account balance, or \$50,000. The notes are secured by the vested balances in the participants' accounts and are repayable through payroll deductions over a period not to exceed five years (except for the purchase of a primary residence). The notes bear interest at prevailing market rates on the date the note is made (as determined by the Plan Administrator); the interest rate is fixed over the life of the note.

(j) Insurance Contracts

Participants may elect to purchase life insurance within separately maintained participant accounts. These contracts are referred to as allocated contracts and any cash or surrender value is excluded from plan assets.

2. Summary of Significant Accounting Policies

(a) Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting, except for the cash basis recording of benefits paid.

(b) Use of Estimates. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(c) Investments. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants. Notes receivable are measured as the unpaid principal balance plus accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Agreement.

(e) Payment of Benefits. Benefits are recorded when paid.

(f) Administrative Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financials. Fees related to the administration of notes

receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Information Certified by the Plan's Custodians

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the custodians of the Plan.

4. Fair Value Measurements

FASB ASC #820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC #820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: The self-directed brokerage accounts are comprised of interest-bearing cash, non-interest-bearing cash, common stock, preferred stock, mutual funds, corporate bonds, limited partnerships, and exchange trade funds at year end. The prices for the underlying assets were valued at NAV at year end, obtained from open markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Plan's Tax Status

The Plan received a favorable determination letter from the Internal Revenue Service (IRS) on February 16, 2012, which stated that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Tax periods for all fiscal years after 2020 remain open to examination by the federal taxing jurisdictions to which the Plan is subject.

7. Related Party and Party-in-Interest Transactions

The Plan Sponsor is party to an agreement with Regions Morgan Keegan Trust, Empower Trust Company, LLC, Empower Annuity Insurance Company of America, and Charles Schwab Trust Company. Under the agreement, these parties provide investment management services to the Plan. These transactions qualify as party-in-interest transactions.

8. Plan Termination

Effective November 18, 2024, the Plan Sponsor was sold, and as a result, the Plan Sponsor ceased to exist as a separate legal entity. Consequently, the Green Clinic Savings and Profit Sharing Plan is in the process of being terminated.

As of December 31, 2024, and the date these financial statements were available to be issued, the Plan termination paperwork had not yet been finalized or submitted to the Internal Revenue Service (IRS); however, it is management's intent to formally terminate the Plan once all required regulatory filings and approvals are completed.

DECEMBER 31, 2024 AND 2023

The accompanying financial statements have been prepared on the going concern basis of accounting, as the Plan's liquidation was not considered imminent as of December 31, 2024. Upon formal termination, all Plan assets will be distributed to participants or rolled over to other qualified retirement plans or individual retirement accounts, as applicable.

Subsequent to year end, the Plan's administrator began coordinating with the recordkeeper and third-party administrator to complete the termination process, including preparation of participant distribution paperwork and regulatory filings.

9. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued. As of this date, the Plan's attorney has not filed the required forms to officially terminate the Plan; however, the process of preparing for plan termination is ongoing. No other events have occurred that would require adjustment to or disclosure in the accompanying financial statements.
