Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lac Vieux Desert Band of Lake Superior Chippewa Indians 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS) and Government Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and Government Auditing Standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter—Required Supplementary Information

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America requires to be presented to supplement the basic financial statements. Such missing information, although not part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of the financial reporting for placing the basic financial statements in an appropriate operational, economic or historical context. Our opinion on the basic financial statements is not affected by the missing information.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Part IV, Line 4i – schedule of assets held at end of year as of December 31, 2024, and the supplemental schedule of Schedule H, Part IV, Line 4a – schedule of delinquent participant contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1) Summary of Significant Plan Provisions

The following description of Lac Vieux Desert Band of Lake Superior Chippewa Indians 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 1995, and restated on January 1, 2022. The Plan covers all employees, other than certain excluded classes, of Lac Vieux Desert Band of Lake Superior Chippewa Indians Tribe and the tribal enterprises of Ascension Technologies and Big Picture Loans, LLC (the “Tribe” or “Employer”) who have three months of service. Participants may begin participating on the date that the eligibility requirements are met. Excluded classes include; union employees under a collective bargaining agreement unless otherwise required to be included in the collective bargaining agreement, certain non-resident aliens, and part time, seasonal, or temporary employees with less than one year of service as defined in the plan document.

The Plan operates under the authority of Tribal Council. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer serves as the Plan administrator.

The Plan is subject to the provisions of Section 906 of the Pension Protection Act of 2006 (PPA). Although the Tribe maintains that the Plan is entitled to governmental status following the passage of the PPA, the Employer is operating this as a nongovernmental plan pending further guidance from the U.S. Departments of Treasury and Labor. The Employer is operating the Plan in accordance with its reasonable and good faith interpretation of the PPA, as required by IRS Notice 2006-89 and IRS Notice 2007-67. As of December 31, 2024 and 2023, there were 481 and 540 participants in the Plan, respectively, 480 and 540, respectively of whom have account balances.

Contributions

Each year, participants may contribute annual pretax compensation, as defined by the Plan, limited to the annual statutory maximum as determined by the Internal Revenue Service, as either pre-tax or after-tax Roth contributions. All participants who are eligible to make contributions and are at least age 50 by the end of the Plan year are eligible to make additional catch up contributions subject to annual limits as established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Each year, the Employer may, at its discretion, make a profit sharing contribution and a discretionary matching contribution to the Plan and in such amount, if any, as it may determine. Employees are eligible for the Employer profit sharing and discretionary matching contributions based upon the eligibility requirements to participate in the plan. For the years ended December 31, 2024 and 2023, no Employer profit sharing contributions or discretionary contributions were made to the Plan.

The Employer has elected to contribute an Employer safe harbor contribution of 3% for the years ended December 31, 2024 and 2023, for all eligible employees that are eligible to contribute to the Plan. The Employer retains the right to suspend the safe harbor nonelective contribution. The Employer currently has no intention to suspend or reduce the safe harbor nonelective contribution.

Participants direct the investment of all contributions in a variety of investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and allocations of Plan earnings (losses). Participant accounts may also be charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Accounts

Participants are immediately vested in their contributions and related earnings thereon. Vesting in the Employer's safe harbor contribution is immediately vested at 100%. Vesting in the Employer's profit sharing contributions and matching contributions portion of their accounts plus earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loan interest rates are determined by the Plan administrator by reviewing interest rates charged for similar types of loans by other lenders, which was prime rate plus 1% at the date of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows or in-service distributions upon attaining age 59½.

Mandatory Cash-Out

If the amount of benefit is \$7,000 or less at the time of separation, the Plan will distribute the benefits in a single lump-sum payment or as a direct rollover into an individual retirement account. Effective January 1, 2024, the plan was amended to increase the mandatory cash out amount from \$5,000 to \$7,000.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,900 and \$1,717, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the Plan document. No forfeited nonvested accounts were used to offset employer safe harbor contributions or to pay administrative expenses for the years ended December 31, 2024 or 2023.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting based on the accounting standards as promulgated by the Governmental Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Tribe. Expenses that are paid by the Tribe are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through October 6, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Governmental Accounting Standards Board (GASB) issued Statement No. 72, *Fair Value Measurements and Applications*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The net asset value (NAV) of pooled separate accounts (PSA) is based on unit values reported by the Plan custodian as determined by the investment manager based on the fair value of the underlying assets net of liabilities divided by the number of outstanding units of the trust on its valuation date. Management has determined that the investments using NAV as a practical expedient do not have published prices and; therefore, the investments are not assigned a level in the fair value hierarchy. There are no unfunded commitments for the PSA. There is no redemption notice period and an immediate redemption frequency for any purchases and sales that occur.

For the years ended December 31, 2024 and 2023, the Plan had no investments valued at fair value based on the fair value hierarchy. The investments measured at NAV as of December 31, 2024 and 2023, were \$8,734,801 and \$6,592,700, respectively.

4) Information Prepared and Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by John Hancock Life Insurance Company (U.S.A), a qualified institution, and certified as complete and accurate:

- Investments, at fair value, and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and participant notes receivable reflected on the supplemental schedule of assets held at end of year.

5) Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and may terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all their accounts.

6) Tax Status

The Plan is operating as a tax exempt plan under a volume submitter nonstandard prototype defined contribution plan document. The Internal Revenue Service (IRS) has determined and informed the volume submitter plan sponsor by a letter dated June 30, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7) Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A), the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Employer provides certain accounting, administrative, and management services to the Plan for which no fees are charged. Fees paid by the Plan for services rendered by the trustees, were \$67,395 and \$36,817 for the years ended December 31, 2024 and 2023, respectively.

8) Delinquent Participant Contributions

As disclosed in the supplemental schedule of delinquent participant contributions, during 2024 and 2023, the Tribe inadvertently failed to deposit \$408 and \$9,887, respectively, of participant contributions within the required time frame as stated by the United States Department of Labor Regulation 20 CFR 2510.3-102, thus constituting nonexempt transactions between the Employer and the Plan. The Employer expects to have all delinquent participant contributions corrected and remitted by December 31, 2025.
