## Independent Auditor's Report

### Plan Administrator AHF Savings and Investment Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AHF Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1      DESCRIPTION OF PLAN**

The following description of the AHF Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of AIDS Healthcare Foundation (the “Foundation”) and other employers, as permitted by the Plan, who are 21 years or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the employer and all contributions are held in accounts maintained by the Plan custodian, Minnesota Life Insurance Company (“MLIC”). The President and the legal counsel of the Foundation are the Plan’s trustees.

On December 1, 2022, Standard Insurance Company (“the Standard”) acquired Securian Financial Group, Inc. (“Securian”), recordkeeper of the Plan. The acquisition combined the recordkeeping business of Securian and The Standard. The business operates under The Standard brand and includes Securian’s retirement solution, employees, management, client relationships and distribution networks.

In 2024, MLIC and the Standard entered into a Reinsurance Agreement and other related agreements that transferred administrative, payment, and investment responsibilities with respect to certain insurance contracts from MLIC to the Standard, on a coinsurance basis in the case of general account liabilities, and on a modified coinsurance basis in the case of separate account liabilities. Pursuant to the agreements, the Standard is responsible for all administrative services, including the preparation and certification of the Plan’s annual reporting on behalf of MLIC. Because MLIC remains the issuer and retains liability for the insurance contracts that are reinsured and administered by the Standard, both MLIC and the Standard will be identified in the Plan’s annual reporting.

**Contributions**

Each year, participants may contribute up to the maximum amount allowable under the Internal Revenue Code (“IRC”). Participants may also elect to contribute a percentage of eligible compensation into the Plan on an after-tax basis and may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Foundation may make a discretionary matching contribution equal to a percentage of the participant’s salary deferrals. This discretionary matching contribution is subject to a maximum limit based on the participant’s years of service. The Foundation’s contributions are invested in the same manner as the participants’ contributions.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)**

**Participants' Accounts**

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Foundation's contribution plus actual earnings thereon is also immediate.

**Investment Options**

Participants direct the investment of their contributions as well as discretionary employer matching contributions into various investment options offered under the Plan. As of December 31, 2024 and 2023, the Plan offered a wide spectrum of investment options under MLIC described as follows:

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

Upon enrollment in the Plan, participants may direct both the employee and the Foundation's contributions to any of the investment options described above. Participants may change their investment options at any time, however, only one change can be made each day.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance in the previous 12 months or (b) 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. Only loans for the purchase of a principal residence may exceed five years. Loans are secured by the vested balance in the participant's account and bear interest at 2% over the prime rate published in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other allowable reasons, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or over a period of time determined by the participant. In accordance with the IRC, hardship withdrawals are allowed to satisfy an immediate and heavy financial need.

**Forfeited Accounts**

Forfeited amounts, if any, may be used to reduce Plan expenses and then, to the extent available, added to the employer's contribution under the Plan. The changes in the Plan's forfeiture account balance for the years ended December 31, 2024 and 2023 are as follows:

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

**Contributions**

Contributions from Plan participants and discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Excess Contributions**

Excess contributions refundable are accrued in the year in which contributions were made.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Foundation. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account. For the years ended December 31, 2024 and 2023, there were no administrative expenses funded through forfeitures

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses had been recorded as of June 30, 2024 and 2023. If a participant separates from service or ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the remaining loan balance will be treated as a taxable distribution after a cure period as defined by the Plan's loan policy. Plan loans in default are offset against vested balances upon separation from service that triggers a distribution. There were \$4,022,977 and \$2,796,358 in outstanding loans to Plan participants as of December 31, 2024 and 2023, respectively.

**NOTE 3      FAIR VALUE MEASUREMENT**

The Plan accounts for its investments in accordance with Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*. ASC Topic 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1:* Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.
- Level 2:* Observable inputs other than Level 1 measurements such as quoted prices for similar assets or liabilities; quoted market prices in markets that are active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.
- Level 3:* Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

**NOTE 3 FAIR VALUE MEASUREMENT (CONTINUED)**

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed retirement account - The underlying investments of these accounts consist of actively traded investments and are valued based on quoted market prices in active markets. These investments are classified within Level 2 of the valuation hierarchy.

Pooled separate accounts - The underlying investments of these accounts are mostly over-the-counter open-end mutual funds, investments in U.S. equity securities, money market securities, and fixed income securities. These investments are valued at the daily closing price as reported by the securities. Portfolio valuation procedures for these accounts are determined by the investment company. The asset class provided in the correspondence released by the Standard on behalf of MLIC (see Note 1) may be that of the primary asset class of the securities. These investments are classified within Level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 FINANCIAL DATA CERTIFIED BY PLAN CUSTODIAN**

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA supplemental schedule, were obtained by management and agreed to or derived from information certified by the Standard on behalf of MLIC, the custodian of the Plan (see Note 1). The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the Plan's assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

- Investments at fair value and notes receivable from participants as of December 31, 2024 and 2023, as reflected in the Statements of Net Assets Available for Benefits;
- Investment activities, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Note 3 to the Plan's financial statements; and
- Investments at fair value and notes receivable from participants, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in mutual funds that invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Because of the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

The Plan invests in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

**NOTE 6      PLAN TERMINATION**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts, and the net assets of the Plan will be allocated among the participants and their beneficiaries after payment of any expenses properly chargeable to the Plan, in accordance with the provisions of ERISA.

**NOTE 7      INCOME TAX STATUS**

The Foundation adopted a Prototype Non-Standardized Profit Sharing Plan (“pre-approved plan document”), which has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document is designed in accordance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Foundation believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8      EXCESS CONTRIBUTIONS PAYABLE**

During the plan years ended December 31, 2024 and 2023, the participants made contributions that exceeded the allowable limits under the plan document and applicable IRS regulations. These excess contributions were identified during the plan’s annual compliance testing and are required to be refunded to the participants.

As of December 31, 2024 and 2023, the Plan recorded excess contributions payable of \$140,989 and \$179,594, respectively, representing the total amount of excess contributions and associated earnings to be returned.

**NOTE 9      RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST**

Certain plan investments are managed by the Standard, on behalf of MLIC (see Note 1). MLIC is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees paid by the Plan to The Standard for the year ended December 31, 2024 amounted to \$188,563, and to MLIC for the year ended December 31, 2023 amounted to \$67,798, respectively.

**NOTE 11 NEW LAWS AND REGULATIONS**

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plan years beginning after December 31, 2024.

**NOTE 11      NEW LAWS AND REGULATIONS (CONTINUED)**

The IRS issued proposed regulations in February 2023 addressing the use and timing of forfeitures in qualified retirement plans. These regulations apply to plan years beginning on or after January 1, 2024. The regulation states that forfeitures must be used no later than 12 months after the end of the plan year in which the forfeitures were incurred. However, the transition rule also provides that any forfeitures that were incurred in any plan year beginning before 2024 are treated as having been incurred in the first plan year that begins on or after January 1, 2024, and, thus, must be used no later than December 31, 2025, for a calendar year plan.

For plan years beginning in 2026, catch-up contributions for participants age 50 or older earning more than \$145,000 annually will be required to be made on a Roth (after-tax) basis. Management is monitoring regulatory guidance and evaluating administrative updates required to comply with this provision.

The Plan will implement the above legislative changes and intends to formally execute the required plan amendments reflecting their implementation by the deadline of December 31, 2026.

**NOTE 12      SUBSEQUENT EVENTS**

The Foundation has evaluated events or transactions that occurred subsequent to December 31, 2024 through October 14, 2025, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements and determined that no subsequent events require disclosure or adjustment to the accompanying financial statements.
