Ochsner Clinic Foundation 401(k) Plan Notes to the Financial Statements

Note 1: DESCRIPTION OF PLAN

The following description of Ochsner Clinic Foundation 401(k) Plan (the Plan) provides only general information. Refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Ochsner Clinic Foundation (OCF, the Company, or the Employer). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rule and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Benefit Committee is responsible for the Plan. The Plan's Defined Contribution Investment Committee (DCIC) determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Retirement Benefit Committee.

Some administrative functions are performed by employees of OCF. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Vanguard Fiduciary Trust Company (Vanguard), the trustee and the qualified institution for the plan, which invests contributions and Plan earnings, makes investment transactions as directed by the DCIC, and provides certain recordkeeping services. Vanguard acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

Employees may become a participant in the Plan immediately upon hire, unless they fall within an excluded employee classification group.

Contributions

Each year, non-highly compensated participants may elect to contribute up to seventy-five percent (75%) of compensation, as defined in the Plan, in a combination of deferral and/or Roth contributions. Highly compensated participants may elect to contribute up to 7% of compensation. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts (i.e. rollover contributions). Participants direct the investment of their entire account balance into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designed fund until changed by the participant. Additionally, under the automatic increase provisions of the Plan, if a participant elects pre-tax and post-tax contributions totaling less than 10% of his or her compensation (or 9% for highly compensated participants), his or her deferral percentage will be increased by 1% each April 1, until his or her deferral percentage

Contributions (Continued)

equals 10% (or 9% for highly compensated participants), unless he or she elects out of the automatic increase provisions.

The Employer makes employer matching contributions of 50% of the employee's contributions, not to exceed 2% of their eligible employer contribution compensation for the Plan year. To be eligible for employer matching contributions, the employee must be employed as of the end of the Plan year and have completed a vesting year of service (1,000 hours) during that Plan year, except in the case of disability, death, or if the employee attains age 65 during the plan year.

In any plan year, the Employer may make retirement contributions, which are discretionary profit sharing contributions made for participants meeting certain requirements. Retirement contributions are calculated by applying the retirement contribution rate times employer contribution compensation. The contribution rate was 2% for the year ended December 31, 2024.

For the year ended December 31, 2024, the Employer made matching and retirement contributions of \$69,127,929. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of the Company's profit sharing contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching portion of their accounts plus actual earnings thereon is based upon years of continuous service. A participant is one hundred percent (100%) vested after six (6) years of credited service. The vesting schedule is included below:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, as determined by the plan administrator, based on the money rate section of the Wall Street Journal. Principal and interest is paid ratably through monthly payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, retirement, or the attainment of age 59 ½, a participant whose vested account balance is at least \$1,000 may elect to receive a distribution of his or her account balance in the form of a lump sum payment, periodic installments, a single-sum payment of any portion of the balance with the remainder being paid in periodic installments, or payment in periodic installments with the option to receive, at any time prior to payment of the final installment, a single-sum payment of the balance. A partial single-sum distribution can be elected only once per year. Vested account balances of \$5,000 or less are subject to the mandatory cash out provisions of the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$167,320 and \$1,345,744, respectively. These accounts will be used to reduce future employer contributions and/or to pay administrative expenses of the Plan. In 2024, employer contributions were reduced by \$2,765,083 from forfeited, nonvested accounts.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV. The DCIC determines the Plan's valuation policies utilizing information provided by the investment advisors, plan trustee, and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions are recorded when earned and measurable. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 8, 2025. No subsequent events were identified that required adjustment to or disclosure in the financial statements. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, the qualified institution:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statement of net assets available at December 31, 2024 and 2023.
- c) Investment income, net appreciation in value of investments, and interest income on notes receivable information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*
- e) All amounts included in Note 5, *Investments Reported at Contract Value*
- f) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Note 4: FAIR VALUE MEASUREMENTS (Continued)

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage fund: Accounts primarily consist of mutual funds, exchange-traded funds, and common stocks that are valued on the basis of readily determinable market prices.

Common collective trusts ("CCTs"): The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: INVESTMENTS REPORTED AT CONTRACT VALUE

In 2022, the Plan entered into an unallocated investment contract with Empower Annuity Insurance Company of America (Empower) and a traditional fully-benefit responsive guaranteed investment contract with Variable Annuity Life Insurance Company (VALIC) totaling \$1,657,947 for 2024 and \$3,005,500 for 2023. The unallocated investment contract was liquidated in 2023. Empower and VALIC maintains the contributions in a general account.

Unallocated contracts are contracts with an insurance company under which related payments to the insurance company are accumulated in an unallocated fund to be used to meet benefit payments when employees retire, either directly or through the purchase of annuities. Funds in an unallocated contract may also be withdrawn and otherwise invested.

The VALIC account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The VALIC contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5: INVESTMENTS REPORTED AT CONTRACT VALUE (Continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6: TAX STATUS

The IRS has determined and informed the Company by letter dated December 5, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Vanguard. Vanguard is the custodian and record-keeper for the Plan and, therefore, these transactions qualify as party-in interest transactions.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

Vanguard provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Vanguard. Vanguard receives revenue from mutual fund service providers for services Vanguard provides to the funds. This revenue is used to offset certain amounts owed to Vanguard for its administrative services to the Plan.

If the revenue received by Vanguard from such mutual fund service providers exceeds the amount owed under the MSA, Vanguard remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Vanguard for administrative expenses not covered by revenue sharing.

Note 8: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.
