Opinion on the 2024 Financial Statements

We have audited the financial statements of Dignari, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits for the year then ended (liquidation basis), and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, in all material respects, the net assets available for benefits of Dignari, LLC 401(k) Plan of December 31, 2024, and the changes in net assets available for benefits for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). As further discussed in Notes 1 and 5 to the financial statements, those charged with governance made a decision to terminate Dignari, LLC 401(k) Plan, upon the acquisition of Dignari, LLC by Ernst & Young LLP. As a result, in accordance with accounting principles generally accepted in the United States of America, the Dignari, LLC 401(k) Plan has changed its basis of accounting from the ongoing plan basis to the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Dignari, LLC 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Note 1 - Description of Plan

The following description of the Dignari, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

Plan Termination

Per the terms of the Plan sponsor's acquisition agreement, the Dignari, LLC 401(k) Plan adopted a resolution effective October 24, 2024, to terminate the Plan. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan. The Plan's assets will be distributed as soon as administratively practicable after receipt of an IRS determination letter on the Plan's termination. Existing Dignari, LLC employees who became Ernst & Young employees were eligible to participate in the Ernst & Young 401(k) in the first full pay period beginning on or after the first of the month following completion of two full months of employment and age 21.

General

The Plan was a defined contribution plan covering substantially all employees of Dignari, LLC (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee was responsible for oversight of the Plan.

Eligibility

Participation in the Plan was available to all eligible employees of the Company. Nonresident aliens with no U.S. source income, employees under collective bargaining agreements, and leased employees were specifically excluded from eligibility, unless otherwise noted in the Plan documents. Participants were automatically eligible in the plan upon hire date.

Contributions

Participant Salary Deferral Contributions - Each year, participants could contribute pretax annual compensation, as defined by the Plan, up to maximum amounts established by the Internal Revenue Service (IRS). Participants were eligible to make catch-up contributions, up to maximum amounts established by the IRS. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Roth Deferral Contributions Participants could designate some or all of the salary deferral as a Roth Deferral at the time the participant made his or her deferral election. Once made, this election was irrevocable (that is, a Roth Deferral cannot be later re-characterized as a pretax salary reduction). The amount of the Roth Deferral was included in the participants' income for tax purposes, and the income tax withholding amounts were deducted from the remainder of compensation, not from the Roth Deferral amount.

Employer Safe Harbor Contributions - Each year the Company could make a safe harbor contribution in the amount of 4% of each eligible participant's compensation. The Company made safe harbor contribution of \$1,172,765 for the Plan for the year ended December 31, 2024.

Employer Discretionary Non-Elective Contributions - At the end of the plan year, the Company, at the discretion of the Company's Board of Directors, could make discretionary non-elective contributions, as defined in the Plan document. Discretionary non-elective contributions, if any, are allocated to eligible employees. For the year ended December 31, 2024, the Company did not make a discretionary non-elective contribution.

Qualified Matching Contributions (QMAC) - The employer could always make QMACs on behalf of Participants in order to correct any testing or operational failures. The Company made no QMACs to the Plan for the year ended December 31, 2024.

Qualified Non-Elective Contributions (QNEC) - The employer could always make QNECs on behalf of Participants in order to correct any testing or operational failures. The Company made no QNECs to the Plan for the year ended December 31, 2024.

Investment Options

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offered a money market fund and registered investment companies which invested in various combinations of stocks, bonds, and other investment securities. The fair value is based on the underlying investments, which include registered investment companies, and a money market fund.

Vesting

Participants were vested immediately in their participant salary deferrals and employer safe harbor non-elective contributions plus actual earnings thereon. Participants vested in the Company's discretionary matching contributions plus actual earnings thereon over a graded four-year period as described in the Plan document. Upon the plan termination, all participants became fully vested.

Participant Accounts

Each participant's account was credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings based on the participant's specific investments and account balances. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Benefits commenced upon one of several dates: retirement, disability, death, or termination of employment. Benefits could also be requested in the event of a hardship as defined by IRS regulations. Benefits were distributed by means of either direct rollover or lump sum distribution.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,552 and \$1,516, respectively. Forfeitures were retained in the Plan and will be used to reduce future employer contributions and plan expenses. Forfeitures of \$4,001 were used to pay plan expenses for the year ended December 31, 2024.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"). On October 25, 2024, the Plan Sponsor's Board of Directors approved a liquidation of the Plan, and management determined that liquidation of the Plan's assets was imminent. As a result, the Plan's 2024 financial statements have been prepared using the liquidation basis of accounting, in accordance with U.S. GAAP, and the Plan has changed its basis of accounting from the ongoing basis use in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. This basis is appropriate when, among other things, liquidation of a Plan is probable and net realized value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amount.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants were recorded when paid.

Contributions

Contributions from Plan participants and employer matching contributions were recorded in the year in which the participant contributions are withheld from compensation.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Certain expenses related to the administration of the Plan were allocated to the participant's account, in accordance with the Plan document, and were included in administrative expenses. Fees related to the administration of notes receivable from participants and payment of benefits to participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in administrative expenses.

Recent Accounting Pronouncements

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, Revenue from Contracts with Customers. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis and the plan should consider whether the presentation of revenue sharing amounts is a significant accounting policy that should be disclosed in the notes to the financial statements. If significant, the notes to the financial statements include a description of revenue sharing arrangements including how such arrangements are presented in the financial statements. The adoption did not have a material impact to the Plan's financial statements.

Recent Legislative Developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

The Plan Sponsor amended the Plan for these changes in 2024.

Note 3 - Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Money Market Fund: Valued at the daily closing prices as reported by the funds.

Note 4 - Related-Party and Party in Interest Transactions

Certain Plan investments are shares of a money market fund and registered investment companies managed by Charles Schwab & Co., Inc., the broker, and Wellington Retirement Solutions, the third-party administrator. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to parties-in-interest of \$122,142 which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 5 - Plan Termination

On October 24, 2025, the Plan's sponsor, Dignari, LLC, formally resolved to terminate the Dignari, LLC 401(k) Plan (the Plan) effective October 24, 2025. The reason for the termination was the acquisition of the Plan sponsor. In accordance with Internal Revenue Code regulations, all participants became 100% vested in their accrued benefits as of the termination date, including discretionary non-elective contributions. The Plan is no longer accepting new contributions. The Plan's assets will be distributed to participants as soon as administratively feasible.

Note 6 - Tax Status

The underlying Wellington Retirement Solutions non-standardized pre-approved profit sharing/money purchase/coda plan has received an opinion letter from the IRS dated March 29, 2022, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receipt of the opinion letter, the Plan Administrator is taking steps to bring the Plan in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan holds a variety of investments. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation available for benefits.

Note 8 - Subsequent Event

As of June 30, 2025, the Plan processed the distribution of all investments and assets to participants in accordance with the plan termination effective October 24, 2025. As of December 31, 2024, the Plan was in the process of finalizing the termination, and all participant accounts were fully vested.

Date of Management's Review

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.
