Summary of the Principal Provisions of the Plan as of January 1, 2024

Effective Date: January 1, 2014.

Most Recent Amendment Date: January 1, 2020.

Eligibility for Participation: Each Employee in the service of the Employer will be eligible to participate in the Plan as of the January 1st or July 1st coincident with or next following the completion of one Year of Service and attainment of age 21. Employees of any other entities under common control with the Employer shall not be eligible to participate in this Plan unless such common control entity makes an affirmative election to sponsor the Plan or those employees are required to be covered to satisfy the requirements of IRC section 410(b).

Normal Retirement Date: The Normal Retirement Date is the first day of the month coincident with or immediately following the later of the Participant's 65th birthday or 5th anniversary of Plan participation.

Early Retirement Date: Not Applicable

Normal Retirement Benefit: A Participant who retires on his Normal Retirement Date will be entitled to a monthly retirement income commencing on his Normal Retirement Date and payable for his lifetime. The amount of such retirement income will be equal to 10.00% for Group 1 and 0.50% for Group 2 of the Participant's "Average Monthly Compensation" multiplied by the participant's total Years of Benefit Service not to exceed 25 Years. The minimum top-heavy benefit will be equal to 2.00% of the Participant's average compensation over the highest five years while a participant multiplied by Years of Plan Participation up to a maximum of 10 years unless a 5% contribution is made to a defined contribution plan on behalf of the participant.

"Average Monthly Compensation" is defined as the average monthly compensation received during the highest three consecutive Plan Years prior to termination of service including compensation prior to the effective date of the Plan.

A Participant shall be credited with a Year of Benefit Service for each calendar year of employment in which the employee was credited with at least 1,000 hours of service.

Early Retirement Benefit: Not Applicable.

APPENDIX A

Summary of the Principal Provisions of the Plan as of January 1, 2024

(Page two)

Death Benefit: In the event of a Participant's death, his beneficiary will be entitled to receive the greater of the actuarial equivalent of the Participant's Accrued Benefit at date of death or the qualified pre-retirement survivor's annuity benefit.

Disability Benefit: In the event of a Participant's disablement prior to his eligibility for Normal Retirement Benefits, he will be entitled to the actuarial equivalent of his Accrued Benefit at date of disability.

Termination Benefit: A Participant who terminates his service with the Employer will have a vested interest equal to a percentage of the actuarial equivalent of his Accrued Benefit earned at date of termination of service in accordance with the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 2 years	0%
2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 or more years	100%

A Participant shall be credited with a Year of Vesting Service for each Plan Year in which the employee was credited with at least 1,000 hours of service.

Accrued Benefit: A Participant's Accrued Benefit is the retirement benefit calculated using current "Average Monthly Compensation" and current Years of Benefit Service limited to 25 Years. Benefit accruals ceased as of January 1, 2020.

Actuarial Equivalence: Actuarial Equivalence is defined as an interest rate of 5.50% pre-retirement, and the current applicable mortality table under IRC §417(e) with an interest rate of 5.50% post-retirement. For lump sum distributions, the actuarially equivalent benefit will be determined in accordance with the requirements of IRC §417(e). For compliance with IRC §417(e), the stability period is the Plan Year and the interest rate month is the first month preceding the first day of the stability period.
