## Independent Auditor's Report

To the Plan Administrator  
RetirementPLUS Retirement Plan for Employees of Mount Auburn Hospital  
Cambridge, Massachusetts

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We were engaged to perform audits of the financial statements of RetirementPLUS Retirement Plan for Employees of Mount Auburn Hospital (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and September 30, 2024, and the related statements of changes in net assets available for benefits for the period from October 1, 2024 to December 31, 2024 and for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of and for the period from October 1, 2024 to December 31, 2024 and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Disclaimer of Opinion*

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### *Basis for Disclaimer of Opinion*

Prior to January 1, 2009, records were maintained at a contract, not plan, level; therefore, the management has not maintained, and the Teachers Insurance and Annuity Association of America-College Retirement Equities Fund ("TIAA CREF") did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the



completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with generally accepted accounting principle in the United States (“GAAP”) and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

***Auditor’s Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan’s financial statements in accordance with auditing standards generally accepted in the United States of America (“GAAS”), and to issue an auditor’s report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## Notes to the Financial Statements

---

### 1. Description of Plan

The following description of the RetirementPLUS Retirement Plan for Employees of Mount Auburn Hospital (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

#### *General*

The Plan, adopted January 1, 1990, is a defined contribution plan established under Section 403(b) of the Internal Revenue Code (the “Code”). All employees employed by participating employers are eligible to participate in the Plan as soon as administratively practical. The Plan was amended and restated on January 1, 2023, to incorporate all changes required by law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrator is Mount Auburn Hospital (the “Hospital” or “Plan Administrator”).

Effective December 31, 2024, the Plan was restated and merged into the Beth Israel Lahey Health 403(b) Retirement Savings Plan, and the sponsorship of the Plan was transferred to BILH. Concurrent with the merger, the assets of the Plan were transferred to the Beth Israel Lahey Health 403(b) Retirement Savings Plan as noted in the accompanying statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### *Contributions*

Participants may contribute up to 100% of their wages, not to exceed the maximum annual contribution allowed by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). The Hospital will contribute amounts on behalf of each employee on the first day of the month coinciding with the later of (i) attainment of age 21, (ii) completion of two years of service, or (iii) the effective date of any required enrollment forms or investment direction forms, and who is regularly scheduled to work at least 20 hours per week (other than persons whose employment is incidental to an education program or who are classified as per diem or temporary) according to the following schedule of service: after two years, 3% of such employee’s salary; after five years, 5%; after 10 years, 7%; and after 20 years, 8%.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of the Hospital’s contributions, investment earnings, and an allocation of administrative expenses (if applicable). Allocations are based upon participant earnings or account balances, as defined by the Plan. Investment income is allocated to participant accounts on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various options offered by the Plan.

#### *Vesting*

Each participant will at all times have a fully-vested and nonforfeitable interest in all accumulations under his or her annuity contract and/or custodial accounts.

### ***Notes Receivable From Participants***

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their total account balances within the Plan. The loans are secured by the balance in the participants' accounts and bear interest at a rate (ranging from 4.25% to 9.50%) commensurate with local market rates for similar loans. Principal and interest are paid through periodic direct debit deductions. The term of the loan cannot exceed five years unless the loan is for the purchase of a primary residence.

### ***Plan Loans***

Participants could previously request loans directly from the Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA CREF") using a portion of their plan account as security for the loan. Such loans are subject to certain limitations. Applicants receiving such loans are required to pledge as collateral the annuity account value of 110% of the loan amount for the period of time the loan is outstanding. Loan balances outstanding from TIAA CREF to the Plan's participants were \$-0- and \$372,729, as of December 31, 2024 and September 30, 2024, respectively. As such, approximately \$410,000 of annuity account values (110% of outstanding loans from TIAA CREF) as of September 30, 2024, serve as collateral for the related loans. The collateral is included in investments in the accompanying statements of net assets available for benefits. These loans are not recorded as receivables of the Plan as the loans are not made from plan assets. As of January 1, 2022, participants were no longer able to take plan loans from TIAA CREF.

### ***Payment of Benefits***

On termination of service, participants may elect to receive their distributions equal to the value of their account either in a lump-sum amount or in a period of installments. In addition, participants may elect to roll their account into another qualified plan.

Non-hardship withdrawals are allowed for benefits attributable to participant contributions after the participant attains age 59½, and hospital contributions and earnings thereon may be withdrawn when the participant attains age 70½.

Hardship withdrawals are allowed for situations considered to be of immediate and heavy financial need as defined in the plan document.

### ***TIAA Traditional Annuity***

The TIAA Traditional Annuity Fully Benefit Responsive ("TIAA Traditional Annuity") is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity is offered through a variety of contract types, including Retirement Annuities ("RA"), Supplemental Retirement Annuities ("SRA"), and Group Supplemental Retirement Annuities ("GSRA"). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, are guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

For accumulating RA contracts, the crediting interest rate was 5.25% as of December 31, 2024 and September 30, 2024. See Note 4 for fair value measurements related to the RA contracts. For accumulating SRA and GSRA contracts, the crediting interest rate was 4.50% as of December 31, 2024 and September 30, 2024. The total contract value is \$-0- and \$21,765,975 as of December 31, 2024 and September 30, 2024, respectively.

The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in net assets available for benefits.

## 2. Summary of Accounting Policies

### *Basis of Accounting*

The accompanying financial statements are prepared using the accrual basis of accounting, in accordance with generally accepted accounting principle in the United States ("GAAP").

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value, other than investments that are considered fully benefit-responsive. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Certain TIAA Traditional Annuity contract types, including the SRA and the GSRA, are considered fully benefit-responsive, and are stated at contract

value for the period from October 1, 2024 to December 31, 2024 and the year ended September 30, 2024. See Note 1 for further discussion of the TIAA Traditional Annuity.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are carried at their outstanding balance plus unpaid accrued interest. Delinquent participant notes receivable are reclassified as distributions based on the terms of the plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Administrative expenses, as defined in the plan agreement, are paid by the Plan.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

## **3. Information Certified by the Plan's Custodians**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity") and TIAA CREF, the custodians and qualified institutions of the Plan, have certified as to the completeness and accuracy of all the investments on the statements of net assets available for benefits as of December 31, 2024 and September 30, 2024, the related investment activity and interest income reflected in the statements of changes in net assets available for benefits for the plan period from October 1, 2024 to December 31, 2024 and for the year ended September 30, 2024. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the custodians. The Plan Administrator has obtained certifications from these entities for the plan period from October 1, 2024 to December 31, 2024 and for the year ended September 30, 2024, that such information is complete and accurate.

## **4. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures* (Topic 820), establishes a framework for measuring fair value and a hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets

or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment options available to participants include the TIAA Traditional Annuity, TIAA Real Estate, CREF Annuities, and select Fidelity mutual funds.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodology used for December 31, 2024 and September 30, 2024.

Investments in certain TIAA Traditional Annuity Non-Benefit Responsive contracts (Retirement Annuity) are reported at fair value. These investments are contract-based, and observable prices for identical or similar investments do not exist; accordingly, these investments are valued using unobservable inputs (Level 3). The fair value considers the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

TIAA offers eight CREF variable annuities. Unlike the TIAA Traditional Annuity, the variable accounts do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each account. The accounts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. The values of the variable annuity contracts are determined at the close of each business day at the net asset value ("NAV") and based on the fair value of the underlying investments. The underlying investments in the variable annuity contracts are invested in registered investment companies, which are valued at quoted market prices in an exchange and active markets. There are no restrictions on the trading or withdrawals of these investments. There are no unfunded commitments, and the redemption frequency and redemption notice period are both daily.

The CREF Stock fund seeks to invest in a wide range of equities from all around the world. The CREF Growth Account seeks to invest in large, established companies, with innovative solutions that enhance earnings or cash flow prospects. The CREF Global Account seeks to invest globally in companies of all sizes. The CREF Equity Index Account seeks to invest in a diversified portfolio of

publicly traded U.S. stocks represented by a broad market index. The Social Choice Fund seeks to invest in a diversified portfolio of bonds and global stocks while giving special consideration to certain environmental, social and governance factors. The CREF Bond Market Fund seeks to invest in intermediate-term corporate and government fixed-income securities designed to balance and manage risk. The CREF Inflation-Linked Bond Fund seeks to invest in fixed-income securities that seek to protect U.S. dollar investors from a loss of "real buying power" due to inflation. The CREF Money Market Fund Seeks to invest in high-quality short-term securities that aim to preserve capital and provide income.

In addition, TIAA offers the Real Estate Account ("REA") which is a separate account of TIAA. This account is a variable account similar to the CREF variable accounts; as such, its returns are not guaranteed and its accumulations and returns fluctuate based on the performance of the underlying investments. The account generally invests in real estate properties and real estate-related investments. The REA investments are generally valued at the NAV of the underlying real estate holdings or other real estate-related investments. The NAV is used as a practical expedient to estimate fair value. There are no unfunded commitments, and the redemption frequency and redemption notice period are both daily.

Transfers out of the REA to a TIAA or CREF account or into another option can be executed at any time but are limited to once per calendar quarter. Transfers out of the TIAA Traditional Annuity contracts can only be affected over a period of time (up to 10 years) and may be subject to limitations. Transfers out of mutual funds into another investment option may be executed on a daily basis.

The Fidelity mutual funds invest principally in equity securities, fixed-income instruments, and short-term instruments in accordance with each fund's investment objectives. The funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as level 1 assets in the fair value hierarchy.

Fidelity self-directed brokerage accounts represent a brokerage account that allows participants to invest in mutual funds and cash reserves. The Plan's individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related-Party Transactions

Certain plan investments are managed by Fidelity and TIAA CREF. Fidelity and TIAA CREF are the custodians and recordkeepers for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Hospital and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan expenses or allocated to the accounts of the participants. During the period from October 1, 2024 to December 31, 2024 and for the year ended September 30, 2024, the excess amounts received by

the Plan were \$241,233 and \$498,301, respectively. This is included in interest, dividends, and other income. The balance of the revenue sharing account as of December 31, 2024 and September 30, 2024, was \$-0- and \$154,605, respectively. The Plan or the Hospital may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain fully vested in their accounts. See Note 1 for merger effective December 31, 2024

### **7. Income Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan Administrator believes that the Plan is designed and being operated in accordance with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
