### NOTE A – DESCRIPTION OF PLAN

The following description of Hawkins Parnell & Young, LLP (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed ninety days of service and are age twenty-one or older, except union employees, nonresident aliens, leased employees, law clerks, and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. **Contributions**

Each year, participants may contribute up to the maximum amount allowable not to exceed the limits provided for by the Internal Revenue Service (IRS) Code. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for the year ended December 31, 2024. Additionally, the Plan agreement allows the Company to make safe harbor matching contributions in an amount not less than 3 percent of participant's compensation. For the year ended December 31, 2024, the Company made safe harbor matching contributions equal to 3% of participants' compensation. The matching contribution, for the year ended December 31, 2024, was \$1,141,198. Participants may direct the investment of their contributions into various investment options offered by the Plan. Rollover contributions are accepted by the Plan.

Additional profit sharing contributions are discretionary and determined by the Company to the Plan participants that are actively employed on the last day of the Plan year and have completed one year of service. The profit sharing contribution amounts are based on a percentage of the employees' annual compensation. Discretionary profit sharing contribution, net of forfeitures, for the year ended December 31, 2024, was \$1,104,291.

3. **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching and profit sharing contributions, Plan earnings, and forfeitures and charged with any withdrawals or distributions, Plan losses, and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. **Vesting**

Participants are immediately vested in their contributions and the Company's matching contribution plus actual earnings thereon. Participants' profit sharing contributions are 100 percent vested after two years of credited service.

5. **Notes Receivable from Participants**

The Plan does not allow for loans to participants.

**6. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments over his or her life expectancy. If a participant's vested benefit in the Plan does not exceed \$5,000, then his or her benefit will be distributed in a lump-sum payment as soon as practical. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allows benefits to be paid in cash or in property. Hardship distributions are allowed, as defined by the Plan.

**7. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,144 and \$7,970, respectively. Forfeitures may be used to reduce any employer contributions or to pay administrative expenses of the Plan. For the year ended December 31, 2024, employer contributions were reduced by \$7,970, and administrative expenses were reduced by \$1,652 in forfeited nonvested accounts.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

A summary of the accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

**1. Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**2. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Administration of Plan Assets**

ERISA Services, Inc. (ERISA Services) is designated as the third-party administrator for the Plan.

**5. Payment of Benefits**

Benefits are recorded when paid.

**6. Administrative Expenses and Fees**

Certain administrative functions are performed by officers or employees within the Company. Administrative expenses are absorbed by the Plan sponsor, and fees are paid directly from the participants' accounts.

**7. Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE C – FAIR VALUE MEASUREMENTS, continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/Collective Trusts* – Valued by the fund’s trustee based on the fair value of underlying securities within the fund, which represent net asset value (NAV) of shares held by the Plan at year-end.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D – PARTY-IN-INTEREST TRANSACTIONS**

The Company signed an Agreement for Services with Transamerica Retirement Solutions, LLC (Transamerica) for providing certain administrative and recordkeeping services, for which fees are charged to the Plan. While the Company pays most of the fees, an insignificant portion is paid by the Plan.

Transamerica signed a Service Agent Agreement with Reliance Trust Company (RTC) for administration of all ministerial duties regarding fund and plan administration. Under this agreement, Transamerica acts and signs on behalf of RTC. While Transamerica has a signed agreement with the Company regarding the Plan, RTC acts as trustee and custodian of the Plan under its arrangement with Transamerica.

**NOTE E – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### NOTE G – TAX STATUS

The Plan has adopted the non-standardized pre-approved profit sharing plan with CODA from ERISA Services. The Internal Revenue Service has determined and informed ERISA Services, by a letter dated June 1, 2021, that the non-standardized pre-approved profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE H – INFORMATION CERTIFIED BY TRUSTEE

The following is a summary of the Plan's financial information, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that is included in the financial statements based on information certified by RTC as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).
