Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Hord Farms West LLP 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Hord Farms West LLP 401(k) Retirement Plan, formerly the New Horizon 401(k) Retirement Plan, see Note 1.a., (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – Hord Family Farms, LLC purchased New Horizon Farms LLP effective November 17, 2023, and now operates as Hord Farms West, LLP (the “Employer”). As a result of the purchase and effective November 17, 2023, the Plan’s name changed from the New Horizon 401(k) Retirement Plan to the Hord Farms West LLP 401(k) Retirement Plan. The Plan is a defined contribution plan for the benefit of employees of the Employer. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee who is not a nonresident alien or covered by a collective bargaining agreement that does not provide for participation in the Plan is eligible to participate in the Plan provided the employee has obtained the age of 18 and completed six months of service. Plan entry dates are the first day of the Plan year or the first day of the fourth, seventh or tenth month of the Plan year.
- c. **Contributions** – A participant may contribute through payroll deductions and rollover contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The automatic deferral percentage for new participants is 3% of compensation. A participant may elect not to participate or to defer a different percentage of their compensation. The Employer makes a safe harbor matching contribution in the amount of 100% of a participant’s contributions up to 3% of the participant’s eligible compensation, plus 50% of a participant’s contributions that exceed 3% but do not exceed 5% of eligible compensation. The Employer may also make a discretionary contribution. No discretionary contributions were made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are, at all times, fully vested with respect to their contributions and the Employer safe harbor matching contributions, plus earnings/losses thereon. All benefits attributable to a participant shall be fully vested if they reach normal retirement age, become totally disabled or upon death. If a participant terminates employment for any reason other than those mentioned above, they are entitled to the total value of their own contributions and Employer safe harbor matching contributions, plus earnings/losses thereon, plus a vested percentage of the Employer discretionary contributions, plus earnings/losses thereon.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions into the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 (as reduced in the Plan agreement) or 50% of their vested balance. Note terms range from one to five years or a reasonable amount of time if the purpose of the note is for the purchase of the principal residence of the participant. The notes are secured by the participant's account and bear interest at a rate commensurate with local prevailing borrowing rates. Principal and interest are paid through payroll deductions.
- h. **Payment of benefits** – Upon termination of employment, a participant may elect to have their account paid either in a lump sum or installments, or may elect to defer payment of their account balance if it exceeds \$5,000. If the participant's account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant's consent will be rolled over to an individual retirement account designated by the Plan administrator. Any distribution that is \$1,000 or less that is made to a participant without the participant's consent will be made as a lump sum distribution to the participant. In-service withdrawals are available to participants who attain age 59½, become disabled, or meet certain hardship requirements.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Certain administrative expenses of the Plan are netted monthly from the rate of investment return for all investment options, lowering the investment return. Fees related to loans and distributions are charged directly to the participants’ account.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by First Bank & Trust (“FBT”), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing such information with the related information included in the financial statements and supplemental schedule:

- a. Cash as shown of the accompanying statement of net assets available for benefits of \$118,890 and \$118,216 as of December 31, 2024 and 2023, respectively.
- b. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$6,674,462 and \$6,269,128 as of December 31, 2024 and 2023, respectively.
- c. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$167,731 (excluding \$12,990 of interest from notes receivable from participants) for the year ended December 31, 2024.

- d. Net change in the fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$622,230 for the year ended December 31, 2024.
- e. All investment transactions that occurred during the year ended December 31, 2024.
- f. All information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements

December 31, 2024 and 2023

4. Fair Value Measurements (cont.)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Common collective trust fund: This investment is stated at fair value based on the net asset value (“NAV”) of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is utilizing a prototype plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Parties-in-Interest Transactions

FBT is the trustee of the Plan. The Plan pays FBT for its services. Inasmuch as FBT serves as trustee of the Plan, it is by definition a party-in-interest. In addition, the Plan holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

7. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through October 10, 2025, which is the financial statement issuance date.
