### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Tufts Medical Center, Inc. Retirement Program - Participant Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ***Notes to Financial Statements***

***Note 1 - Description of the Plan***

The following description of the Tufts Medical Center, Inc. Retirement Program - Participant Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

Effective October 1, 1989, Tufts Medical Center, Inc. ("Tufts Medical Center") (formerly New England Medical Center Hospitals, Inc.) discontinued its Retirement Program - Contribution Plan and established a new money purchase pension plan entitled Tufts Medical Center, Inc. Retirement Program - Participant Contribution Plan. Under the Plan, after-tax participant contributions are based on participants' gross compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Assets of the Plan, along with a second qualified retirement benefit plan of the Plan Sponsor, the Consolidated Pension Plan of Tufts Medicine, Inc. (the "Defined Benefit Plan") through December 31, 2024, are generally combined in the Tufts Medicine, Inc. Master Trust (the "Master Trust") with The Bank of New York Mellon/BNY Mellon, N.A. as trustee. Investment managers are appointed by the Tufts Medicine, Inc. Investment Committee to invest Plan assets. The Plan administrator is Tufts Medical Center.

***Eligibility***

Effective August 1, 2005, the Plan was frozen to new participants. Also on that date, for new hires and rehired union contracted nurses, the Tufts Medical Center, Inc. Retirement Savings Plan - 403(b) (the "403(b) Plan") was established whereby eligible employees may contribute a percentage of their pre-tax salaries to the 403(b) Plan and receive an employer match after completing the service requirements.

Prior to the Plan freeze, the Plan is available to all eligible employees as defined in the Plan, and as of January 1, 1995, only employees under union contract were eligible. This is a voluntary defined contribution money purchase plan.

Effective February 28, 2018, the Plan was fully frozen and no additional participant contributions shall be made.

***Contributions***

Prior to February 28, 2018, participants who chose to participate in the Plan entered into an agreement to make after-tax contributions equal to a percentage of their salary. The contribution percentage was 1% of salary up to \$6,600, plus 2% of salary in excess of \$6,600. Contributions were subject to certain Internal Revenue Code ("IRC") limitations.

***Note 1 - Description of the Plan (Continued)***

***Participant Accounts***

Each participant's account is credited or charged with investment income/losses and Plan expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on the ratio of the participant's account balance to the total of all participants. The Plan Sponsor determines the investment allocation as investments are non-participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon.

***Payment of Benefits***

At the time of termination, participants may elect to receive a lump-sum distribution or to transfer their individual contribution account balance into the Defined Benefit Plan to receive monthly annuity payments. Participants whose balance exceeds \$7,000 at the time of termination may elect to remain in the Plan. As directed by the Plan administrator (at the participant's option), the trustee will provide an annuity benefit for a retiring employee, with monthly payments equal to an amount determined pursuant to the payment election. In the event of death, the participant's beneficiary shall be entitled to receive a death benefit equal to the total amount in the participant's account or monthly annuity. A participant who becomes totally and permanently disabled has the same options as a terminated employee.

***Administrative Expenses***

Substantial costs and expenses incurred in connection with the operation of the Plan are paid by the Plan or Tufts Medical Center, as provided in the Plan document.

***Note 2 - Summary of Significant Accounting Policies***

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, changes in net assets available for benefits during the reporting period and, when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Note 2 - Summary of Significant Accounting Policies (Continued)***

***Benefits Paid to Participants***

Benefits are recorded when paid.

***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 4 for discussion of fair value measurements.

Interest and dividend income are recorded as earned on the accrual basis. The net appreciation in the fair market value of the Plan's interest in the investments of the Master Trust, which consists of the realized gains or losses and the change in unrealized appreciation on those investments, is also included in investment income from the Master Trust.

***Subsequent Events***

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

***Note 3 - Information Certified by Trustee and Custodian***

Plan investments are managed by The Bank of New York Mellon/BNY Mellon, N.A. ("BNY Mellon"), the trustee and custodian. The fair value of all investments as of December 31, 2024 and 2023 and all related investment transactions for the year ended December 31, 2024, including interest, dividends and net appreciation in fair values, are reported to the Plan and certified as complete and accurate by BNY Mellon.

***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Exchange Traded Funds***

Valued at the closing price reported on the active market on which the individual securities are traded.

***Common/Collective Trusts***

Valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily with one day's notice. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

***Hedge Funds***

Hedge funds are valued by calculating the NAV of each investment by multiplying the investment's total capital from audited financial statements by the Plan's ownership percentage in that investment. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Redemption rights, including the ability to withdraw from an investment within 15-90 days and fees related to such withdrawal, vary based on each individual investment.

***Limited Partnerships***

Limited partnerships are valued by calculating the NAV of each investment by multiplying the investment's total capital from audited financial statements by the Plan's ownership percentage in that investment. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Redemptions may be processed monthly with 2-30 business days' notification.

***Note 6 - Interest in Master Trust***

Certain of the Plan's investment assets are held in a trust account with the trustee and consist of an undivided interest in an investment account of the Master Trust, a master trust established by Tufts Medical Center and administered by the trustee. The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income or loss less actual distributions and allocated administrative expenses. Use of the Master Trust permits the commingling of trust assets with the assets of the Defined Benefit Plan for investment and administrative purposes. Although assets of both plans are commingled in the Master Trust, the trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans. The net investment income or loss of the investment assets is allocated by the trustee to each participating plan based on the relationship of the investment assets of each plan to the total of the investment assets of the participating plans.

***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

***Note 8 - Tax Status***

The Internal Revenue Service ("IRS") has determined, and informed Tufts Medical Center by a letter dated November 12, 2013, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been recorded in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
