## Report of Independent Auditors

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Torrance Health Association, Inc. 401(a) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

### **Opinion**

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following brief description of the Torrance Health Association, Inc. 401(a) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document and summary plan description for more complete information, copies of which may be obtained from the Plan Sponsor.

#### **General**

The Plan is a defined contribution plan for which the employer, Torrance Health Association, Inc. (THA), is the sole contributor and the Plan Sponsor. The Plan was adopted by THA for the exclusive benefit of its eligible employees, effective January 1, 2010. The plan administrator is THA (the Plan Administrator) acting through its board of trustees. The Trustee and Record Keeper of the Plan is Lincoln Financial Group Trust Company, Inc. The Plan is in conformity with the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Eligibility**

All THA employees, except employees eligible to accrue benefits under the Torrance Health Association Employees Retirement Plan (Pension Plan) and collectively bargained employees, are eligible to participate in the Plan when they have attained age 21 and meet the Plan's one-year length-of-service requirement, defined as the completion of one year of service with a minimum of 1,000 hours of service in a 12-consecutive-month period. Participation enrollment occurs on the nearest January 1 or July 1 upon completing the eligibility requirements. The Plan was amended February 26, 2020 in conjunction with the freeze of the Pension Plan to provide participation in the Plan by former Pension Plan participants. The amendment was effective as of June 28, 2020 at which point former Pension Plan participants were eligible to participate in the Plan.

### Notes to Financial Statements (continued)

#### 1. Description of Plan (continued)

##### Contributions

The Plan Sponsor makes contributions to the Plan on behalf of each participant based on a percentage of each participant's annual compensation as follows:

At least 10 but less than 15	5
At least 15 but less than 20	6

Former Pension Plan participants are also eligible to receive additional contributions based on the participant's age. For participants who attained at least age forty-five (45) but had not attained age fifty (50) as of June 27, 2020, the additional contribution is 1.5%. For participants who attained at least age fifty (50) as of June 27, 2020, the additional contribution is 2.75%.

Participants direct the employer contributions into various investment options offered by the Plan.

##### Participant Accounts

Each participant's account is credited with the employer contributions, interest, dividends, and earnings, and is charged with investment fees. Interest, dividends, and earnings or losses are based on the participant's investment elections. Investment expenses are based on the participant's account balances and/or investment elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

Upon death or severance from employment with THA, a participant or their beneficiary may elect to receive a lump-sum payment.

**Forfeitures**

THA contributions forfeited by participants may be used by THA to reduce future THA contributions. During 2024 and 2023, \$46,552 and \$192,006, respectively, of forfeitures were used to reduce THA contributions. There were \$321,202 and \$194,776 of unallocated forfeitures at December 31, 2024 and 2023, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, THA has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participant accounts would become fully vested and be distributed as soon as practicable.

#### **2. Information Certified by Trustee**

All investment information disclosed in the accompanying financial statements, footnotes and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the employer and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc.

#### **3. Summary of Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States (U.S. GAAP).

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

The Plan holds traditional investment contracts which meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

#### **3. Summary of Accounting Policies (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held.

#### **Administrative Expenses**

All expenses, exclusive of investment expenses and related fees that are netted against net appreciation (depreciation) in fair value of mutual fund investments, incurred in the administration of the Plan, including legal, accounting, and trustee fees and expenses, are paid by THA.

#### **4. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

**4. Fair Value Measurements (continued)**

Financial assets and liabilities measured at fair value are based on one or more of the following three valuation techniques:

- a) Market approach – Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.
- b) Cost approach – Amount that would be required to replace the service capacity of an asset (replacement cost).
- c) Income approach – Techniques to convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing, and excess earnings models).

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* – Valued at the closing price reported on the active market for which the individual securities are traded.

#### **5. Investment Contract with Insurance Company**

The Plan invests in a fully benefit-responsive annuity contract. The issuer maintains the contributions in the Lincoln Stable Value Account. The account is credited with participant contributions plus earnings and charged for participant withdrawals. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and may be changed quarterly. Such rates are set annually, and the interest rates are reviewed quarterly and may be reset if a higher rate is justified. The credited interest rate is impacted by net deposits, withdrawals, expense charge deductions, and the net effective yield on underlying investments during each calculation period.

Subject to ERISA regulations, participant-directed redemptions have no restrictions. Although the contract values under the investment contract are guaranteed, certain events limit the timing of withdrawals or transfers under the investment contract. Such events include (1) spin-offs, sales, or divestitures; (2) mergers or consolidations; (3) corporate relocation or facility closings; (4) layoffs or retirement incentive programs; (5) establishment of a competing investment option; (6) partial or total plan termination; (7) liberalization of plan withdrawal or transfer rules; or (8) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

#### **6. Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **7. Party-In-Interest Transactions**

The Plan holds annuity investments managed by an affiliate of the Record Keeper. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

#### **8. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated February 13, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, the date at which the financial statements were available to be issued.
