## INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
Wellthy, Inc. 401(k) Retirement Plan and Trust

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Wellthy, Inc. 401(k) Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Wellthy, Inc. 401(k) Retirement Plan and Trust (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Wellthy, Inc.'s (hereinafter, the "Employer" or the "Plan Sponsor") management, which is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America ("U.S. GAAP") and have been consistently applied in the preparation of the financial statements and supplemental schedules.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's net appreciation (including gains and losses on investments bought and sold, as well as held during the year) was \$947,295.

Participant Notes Receivable: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Expenses: Certain administrative, accounting and audit expenses for the Plan were paid directly by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Events Occurring After Report Date: The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2025 and October 13, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan, established January 1, 2020, is a participant-directed defined contribution plan covering all eligible employees of the Plan Sponsor who completed at least three months of service and are age twenty-one or older. Eligible employees become participants in the Plan as of the date they meet the eligibility requirements. The Plan is subject to the provisions of ERISA.

Reliance Trust Company ("RTC") was the custodian of the Plan assets through June 30, 2024. Effective July 1, 2024, Transamerica Trust Company ("TTC") and Transamerica Financial Life Insurance Company Inc. ("TFLIC") serves as the trustees and custodians of the Plan. Transamerica Retirement Solutions, LLC ("Transamerica") is the administrator and recordkeeper of the Plan.

Contributions: Participants may contribute to the Plan a percentage of eligible compensation, as defined in the Plan document, between 1% and 90%. Eligible compensation for the Plan is defined by the Plan document as compensation under Code Section 3401(a) per the United States Internal Revenue Code. This compensation includes all remuneration (other than fees paid to a public official) for services performed by an employee for his or her employer, including the cash value of all remuneration (including benefits) paid in any medium other than cash. Exceptions to this definition are outlined in the code section. These contributions are excluded from the participants' federal taxable income until received as withdrawals or distributions from the Plan. Contributions are subject to certain limitations. Employees may elect to defer a maximum amount not to exceed the annual thresholds established by the IRS. Participants who attained age 50 by the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified plans.

Effective January 1, 2021, the Plan was amended to include an automatic enrollment provision for new and current participants. Automatically enrolled participants have their deferral rates set initially at 3% of eligible compensation. Unless the participant elects to change the deferral rate, the rate is increased by 1% annually up to a maximum of 6%. Contributions are invested in a qualified default investment alternative until changed by the participant.

The Plan allows participants to designate a portion of their contributions to be treated as "Roth" contributions. A contribution treated as a Roth contribution is subject to current federal income tax at

the time it is contributed to the Plan. However, if certain requirements are satisfied prior to the distribution of such amounts from the Plan, distributions of amounts attributable to Roth contributions (including earnings thereon) will not be subject to federal income tax at the time of distribution.

The Plan provides for employer matching contributions to deferring participants. Such employees are eligible to receive a matching contribution equal to 100% of the first 4% of eligible compensation that a participant contributes. For the year ended December 31, 2024, the Plan Sponsor made matching contributions of \$626,217, net of \$42,419 of forfeitures. Contributions are subject to certain IRS limitations.

Participant Accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Participants direct the investment of their contributions and their share of employer contributions into various investment options as offered by the Plan. Each participant's account is credited with each participant's contribution and earnings, and an allocation of any employer contributions and administrative expenses. As a participant-directed plan, each participant's investment choices determine his or her share of earnings or losses.

Vesting: Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are 100% vested in employer matching contributions after two years of service.

Investment Options: Upon enrollment in the Plan, participants may direct the recordkeeper to invest contributions into various investment options managed by the custodians, its affiliates, and other large investment management companies. If a participant fails to designate an investment selection, funds are automatically invested into the qualified default investment alternative. Participants may change their investment options, transfer part or all past investments to other funds, and change their deferral percentages at any time.

Notes Receivable from Participants: The Plan provides for participant loans at a minimum of \$500 to a maximum of the lesser of \$50,000 or 50% of a participant's account balance. The maximum payment term allowed for any loan is five years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prevailing market rates at the time the loan is taken. Outstanding loans at December 31, 2024 bore interest at 8.25% to 10.50%. Principal and interest are repaid ratably through payroll deductions.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan that would result in taxable income to the participant upon the occurrence of a qualifying event as defined by IRS guidelines. As of December 31, 2024, there were no outstanding loans representing defaulted loans (deemed distributions) for which the participant was taxed through an IRS Form 1099-R.

In-Service Withdrawals: In-service or hardship withdrawals are permitted by the Plan.

Payment of Benefits: Unless the participant elects otherwise, a participant will begin to receive his/her benefits no later than the 60<sup>th</sup> day after the close of the Plan year in which the latest of the following occurs:

- a) the participant attains normal retirement age (65);
- b) occurs the 10<sup>th</sup> anniversary of the year in which the participant commenced participation in the Plan; or
- c) the participant terminates employment

Required minimum distributions as mandated by IRS regulations will commence when a participant attains age 70 ½. Participants who are not 5% owners and attain age 70 ½ may elect to defer distributions until April 1<sup>st</sup> following the calendar year in which they reach age 70 ½ or, if later, terminate employment. Due to changes made by the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"), effective January 1, 2020, if a participant's 70<sup>th</sup> birthday is July 1, 2019 or later, required minimum distributions may be deferred until the participant reaches age 72. Due to changes made by the SECURE 2.0 Act of 2022 ("SECURE 2.0 Act"), effective January 1, 2023, participants who turned 72 in 2023 or later may defer required minimum distributions until the participant reaches age 73.

On termination of service due to death, disability, or retirement, as defined in the Plan, participants are generally entitled to a payment of their full account balance in the form of a lump-sum. On termination of service due to other reasons, the balance of a participant's vested account becomes distributable to him or her upon election.

Forfeitures: When certain terminations of participation in the Plan occur, the non-vested portion of a participant's account represents a forfeiture. Forfeitures are applied against any employer contributions made during the Plan year or used to pay Plan expenses. During the year ended December 31, 2024, there was \$73,766 of forfeited amounts of which \$53,827 was used to offset employer matching contributions and to pay for Plan expenses. The balance in the forfeitures account at December 31, 2024 and 2023 amounted to \$95,719 and \$74,378, respectively.

Plan Amendments: The Plan Sponsor has the right under the Plan to amend the Plan at any time. The Plan was restated effective in June 2024 to change the Trustee from Reliance Trust Company to Transamerica Trust Company.

In January 2020, Congress passed the SECURE Act. In December 2022, Congress passed the SECURE 2.0 Act. Many of the provisions of the SECURE Act and SECURE 2.0 Act will require significant changes to plan administration and recordkeeping. The Plan Sponsor has until the 2026 Plan year to

amend the Plan to include adopted mandatory and voluntary SECURE Act and SECURE 2.0 Act provisions.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed pursuant to the Plan document.

**NOTE 3 - INFORMATION CERTIFIED BY CUSTODIANS**

All investment information and notes receivable from participants disclosed in the accompanying financial statements as of December 31, 2024 and 2023, and ERISA-required supplemental schedules, including net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by RTC, TTC and TFLIC.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Accounting standards establish a framework for measuring fair value, providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds (Registered Investment Companies): Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV is based upon quoted market prices.

Stable Value Funds: Stable value funds are valued at contract value (which approximates fair value), and are based on their beginning balance plus any deposited and credited interest, less any withdrawals, charges, or expenses, a measurement which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - TRANSACTIONS WITH PARTY-IN-INTEREST**

Certain Plan investments were managed by RTC, TTC and TFLIC and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments.

**NOTE 7 - TAX STATUS**

The Plan Sponsor adopted Transamerica's prototype, non-standardized; profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of the tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
